

It is June already. We have already had 2 riding courses this year and have one more scheduled. We had the Trike course on April 28 and did enjoy some "cooler" weather for the day. On May 7 we had the Bike Trailering Course. We had LeRoy Douglas join us from Arkansas to get certified as a Bike Trailering Instructor. We had 9 bike/trailer rigs take the course and it was a great day of training.

We still have the Trike Trailering Course scheduled for Friday evening and Saturday morning **June 17 and 18**. We will again be at the King Park Shelter building in Hesston for the classroom on Friday night. We will start registration at 6:45 that evening. The range will be Saturday morning at the Hesston High School parking lot just to the west of the stadium. We will start the range exercises at 8:00 a.m. **Please be there and ready to ride at 8:00 a.m.** so we can get done as early as possible to avoid the heat of the afternoon. We do still have openings and the cost is still \$25 per bike and as always there is no cost for the co-rider.**

Now get out and ride and enjoy the cooler temperatures while they are with us. Summer will be here sooner than you think.

Motorcycle Safety: Stay Shiny Side Up

Business Law

I don't know about you, but I'm itching for all this rain to stop so I can start riding regularly again. The wind in my face. The open road. The sense of freedom and release. For those of us who ride motorcycles, there is little else that compares to the experience. Unfortunately, there are also many risks associated with cruising the open roads on our favorite 2-wheeler, that don't exist within the confines of the standard automobile. If you have never suffered an injury while riding, here are some tips to keep you safe and shiny-side up. If you have recently been in a motorcycle accident, jump down and read about some specific information you need to be aware of when pursuing a recovery for your injuries and damages.

Tips to stay safe and shiny-side up

1. Always wear a helmet. The statistics overwhelmingly show that wearing a helmet not only can save your life, but can protect you from suffering other serious and crippling consequences like a traumatic brain injury. If you don't like the feeling of "missing out on the wind and elements," then buy a half-helmet or even a shorty. But whatever you choose, please just choose to protect your dome with a properly fitted and DOT-approved helmet.
1. Keep close tabs on your tires' air pressure. Motorcycles tires, unlike car tires, are specifically designed and engineered to flex and roll, especially on the edges and up into the side walls. This is what allows the bike to "lean" into turns while still maintaining the proper center of gravity to stay upright. While car tires can operate more or less OK when slightly over or under inflated because they maintain constant and full contact with the road surface, over or under inflated tires on your bike can cause the bike to either not flex enough to allow a bike to lean and turn sharply, or flex too much and thus lose all traction. So, check your air pressure at least weekly and keep it at the manufacturer recommended levels.
1. Keep your gas tank full and your chain or belt properly lubed and maintained. A broken chain or belt can lead to catastrophic consequences. As for an empty gas tank, well, let's just say we've all been the "I felt so cool riding and now feel like a loser walking" person at least once in our life. Let's try to never go there again.
1. Drive as though you're invisible to others because, to most cars and trucks on the road, you are. If you always assume the worst can happen, you'll be ready to have the best ride. Enough said.

Issues you'll face in an insurance claim or lawsuit for injuries from a motorcycle accident

If you've been involved in a motorcycle accident, you've likely already faced one of our greatest fears as riders: an unpleasant encounter with a car or truck. The National Highway Traffic Safety Administration reports that motorcyclists are far more likely to be killed or injured in a traffic accident than passenger car occupants. If you wonder why, see safety tip number 4 above.

Unfortunately, in a large majority of cases the injured rider will have insult added to their injuries when they are blamed, at least in part if not in full, for the accident and for causing their own injuries, even when they weren't at fault at all. As wrong as this may be, many people still cling to old stereotypes about motorcyclists living and riding recklessly. In addition, many defense attorneys representing the at-fault auto driver know about the bias against bikers, and will do all they can to exploit the stereotypes in front of jurors to try and sway the jurors to not be as sympathetic or generous to a motorcyclist as they would be to any other victim of an auto accident. Similarly, and equally deplorable, is the tendency of a jury to not value the loss of quality of life for a biker as high as they would for an auto driver.

These are just a few of many reasons why obtaining a fair settlement or jury verdict for motorcycle accident victims can be more difficult, and why it is all the more important to hire a high quality personal injury attorney that has experience with motorcycles, not only as a rider but in representing riders in personal injury insurance claims and lawsuits. An experienced motorcycle injury attorney knows how to fight fire with facts. It's imperative to gather as much documentation and information as possible, including photographs and diagrams of the accident scene, credible witness statements, thorough medical records, testimony from the victim's friends and family members, and evidence of fact-based claims for non-medical damages such as lost wages, out of pocket expenses, and other economic damages for care, support and maintenance. The defendant's attorney will challenge and try to downplay these facts, while subtly introducing lifestyle issues in order to minimize your compensation. But your attorney can overcome these draconian efforts if they are familiar with these tactics and understand how to effectively counter them throughout settlement discussions and even on to trial.

From there we went to the Newton High School parking lot. The lot was not in very good condition, but it simulated real riding conditions. From what I could see, all riders did a very good job. I have been working hard to regain my riding skills. My skills declined after my surgeries and recovery time. It sure felt good to be able to do well on this course. (This is just my opinion) I wish to thank the Riders Ed Team for putting on a good and much needed class.

Two of our Chapter A members have been laid up for a while. Larry Mazur had back surgery and Michelle Grooms had a health scare. Both are out of the hospital and recovering at home. Our wishes go out for a speedy recovery for both members.

The middle of the month brought the Arkansas Rally. Terri and I were not able to attend. However, we put on a Chapter ride on the 21st. We left the Walmart parking lot at 53rd Street N and N. Who would have ever thought that a fill up on our Wings would cost almost \$25.00! Our riding is now being limited to much shorter rides. In order to keep lower fuel usage, we must remember a few basics. We need to check our tire pressure. An under inflated tire causes more fuel usage. We need to always have a clean air filter. Now I know well how much of a job it is to change the filter on an 1800, but it is worth while to keep a clean filter, not only for economy, but for better performance.

Motorist Awareness info

The end of May brings the end of Motorcycle Awareness month. I feel this should be a concern of ours ALL year long. Now we constantly talk about car and truck drivers seeing us. But we need to do our part to be seen. Riding in the proper track of the lane is important to be seen. Remember NOT to hang out in a truckers blind spots (the no zone). Remember that when following a truck, if you cannot see the drivers head in his rearview mirror, he cannot see you. When passing, get around quickly and get far enough ahead of the truck to be seen. I know it is very cool to have our riding gear match our Wings. But this is not a good idea when riding. Good only for show. Matching colors of our bikes and riding gear makes us harder to seen. A bright or light colored helmet along with bright colored riding jackets make us easier to bee seen. Another tip is to make sure ALL of our lights work. This may seem very simple, but it really helps.



In 1888, an English doctor prescribed eating three hamburger meals a day as a cure for different ailments. A seasoned ground beef patty served with gravy reminds us of him. He was Dr. Salisbury.

Both the hamburger and ice cream cone made their debut at the 1904 World's Fair in St. Louis. They are still popular today as they meet the consumer's need for tasty, portable food.

Both 90% and 95% lean ground beef have less fat than ground turkey. A three-ounce serving of 95% lean ground beef contains five grams of fat. Three ounces of 90% lean ground beef have nine grams of fat. And, a three-ounce serving of ground turkey has eleven grams of fat because the fat and skin are ground up into the meat.






