

Time and Space

The following information is taken from the March 2013 Motorcycle Consumer News. "Time And Space" is the paragraph I'm quoting. The entire article is authored by Ken Condon, MSF RiderCoach, and chief instructor for Tony's Track Days and author of Riding In the Zone. NOTE: I will be quoting the article as written by Ken Condon.

"Still not convinced that your superior physical skills may not be enough to keep you safe? Then consider the timing and circumstances of a typical 30mph crash. At that speed you are traveling at 44' per second (1 mph=1.47 ft/sec). Getting the motorcycle stopped from 30 mph takes just over two seconds and requires about 35' of space. But braking distance include more than just the time and space to physically stop your motorcycle. It also includes "thinking time' and "reaction time." At 30 mph you can count on using about .7 seconds or 31' to realize that there is a problem. It then takes you another .3 seconds or 13' to react by rolling off the throttle and reaching for the brakes. That means you traveled 44' before even touching the brakes. Finally, it take you about 2.2 seconds or 35' (with a typical deceleration rate achieved by the average rider) to bring the motorcycle to a halt. Add this "braking time" to the "thinking time" and "reaction time" and you will need a total of 3.2 seconds and 79' in which to stop.

Let's say you are traveling at 30 mph and a car pulls out from a side street. It takes one second for you to perceive that action is required and for you to react. You execute a perfect, quick stop, but did you have enough time and space to avoid a collision? The car would have to be at least 80' away (about three and a half seconds) when you noticed it as a threat. Unfortunately, it is likely that you will have only two seconds from the time the driver begins to move until impact. This is an impossibly short amount of time to complete the thinking and braking sequence. Your braking skills would have slowed you significantly, but not enough to prevent a collision.

Swerving is an alternative to emergency braking when

there isn't enough time and space to stop. However, effective swerving requires excellent counter steering skills that are wellpracticed. To steer a motorcycle quickly requires a forceful push on the handlebars, which can be a real challenge for many motorcyclist. The rider who elects to swerve must also have the discipline to resist braking because there is not enough traction to swerve strongly and brake hard at the same time.

Effective emergency braking and swerving both require excellent skills that many rider lack. This is another reason why it is unwise to rely solely on your braking or swerving sill to keep you safe. Yes, these skills are critical, but when you consider that you might have only two seconds to react, I think you'll agree that it is best to do all you can to avoid being faced with the need to use superhero skills in the first place."

That's the end of the quoted article.

Ride Safe, Ride Alert, and Ride Smart. Please consider taking a refresher BRC2 or Trike course this year. Your Co-rider will be glad you did. :-)

I would like to give Jim and his "Klondike" truck a special "Thank You" for being there. We got to see him in action.







April found Chapter B ready to ride. The weather wasn't as cooperative as we would have liked, but that didn't stop some members who were tired of being cooped up in the house from venturing out.

April 5 found nine bikes and ten riders headed on a journey around the state of Kansas. Last year John English led a ride around Texas. This year it was time to explore our home state. Dave Aiken, Earl Baker, Barton Bloom, John English, Ed James, Greg Marquardt, Maurice Reiter, Mick Schurer, and Missy and Roger Shores set off on a four day adventure to travel around the four sides of Kansas. They started along the east side and headed south to Pittsburg where they stopped to see the Hotel Stilwell which was built in 1889 and the Besse Hotel constructed in 1927. From there they followed Route 66 to Rainbow Curved Bridge and the old Riverton Store where they enjoyed Route 66 root beer.

In Galena they saw Tow Mater. This vehicle was the inspiration for the tow truck Mater in the Disney movie, *Cars*.

Then it was on to Independence to see the Booth Hotel, another grand old hotel completed in 1912.



Saturday's journey took the group through the Gypsum Hills where they were able to see many land formations, including, flat mesas, deep canyons, sharp high hills, red soils and caprock formations, and on to the Cimarron National Grasslands, the largest area of public land in Kansas and the only parcel managed by the Forest Service.

This also led them to the second "corner" where a windmill marked the joining of Kansas, Colorado, and Oklahoma.



Also outside Galena was the first corner with a marker of rocks indicating the meeting of Kansas, Oklahoma and Missouri.





They continued north still in the grasslands and saw the Point of Rock.

It was a continued trip north on Sunday with stops at the giant reproduction of Van Gogh's "Three Sunflowers in a Vase" and the Cherry Creek Encampment, a memorial to the Cheyenne and other Indians who survived the November 29, 1864 massacre at Sand Creek, Colorado, and who fled to the Cherry Creek Valley. The group was unable to actually stand at the third state corner as it was out in a plowed field and though they traveled on some gravel and sand, they drew the line at plowed ground.

As they turned back to the east, they visited the cabin where the song, "Home on the Range" was written in 1872, the geographical center of the contiguous forty eight states, the Pawnee Indian Village Museum, and the Pony Express Monument before stopping for the night.



Monday found the group setting out toward the final corner with a stop in Hiawatha to see the Davis graves and elaborate stone work at the cemetery and a stop in White Cloud at the Wilbur Chapman Monument.



Wilbur, a local ten-year-old, owned a prized pig named Pete. He sold Pete in 1910 to raise money for a leper colony. The story caught the attention of the press and the people, in such a way that "piggy banks" were invented as a generic way to save money. Since no one was in the mood for swimming and the northeast corner of the state is underwater, the group didn't actually get to that corner either. The giant carved Indian totem pole in Troy was also on the agenda as the group headed to lunch in Leavenworth and the end of a wonderful 1500 mile journey with friends.

The following weekend found members once again setting out, this time for Moonshine, Illinois and the Moonshine Lunch Run. Seven bikes and nine riders left on a cold Friday morning.

Joe Magnant served as the ride leader and following along were Wendal and Judy Morris, Dave Patton, Allen Robertson, Roger and Missy Shores, Eric Wadman, and Wes Wadman. The group headed

toward Hannibal, Missouri and then on to Moberly for lunch. It was on into Illinois and some great two lane roads including several miles along the Illinois River. There wasn't a bridge to cross the river, but a ferry appeared to provide transportation.





More back roads took the group to Effingham, Illinois to spend the night.Saturday morning it was on to Casey, Illinois and a stop for cinnamon rolls. All the yummy rolls were homemade and provided at no charge to the riders. Donations were taken for local charities. The group purchased Moonshine tshirts and visited with other riders. A guided ride led the group

the fifteen miles to the Moonshine General Store. A sign proclaimed a population of two, but that wasn't the case that day. proper to call them up and rub in the fact that it was 76 degrees at 10 o'clock in the morning while it was struggling to get above freezing in Kansas at the time. He did have a complaint since they got stuck in construction traffic in Florida and it took them an hour to cross one bridge and they both were worn completely out after not getting very far, however he was lucky and got a room for $1 \frac{1}{2}$ days for the price of one day. When John & Teresa's plans got changed there was still a bit of a problem with not having enough miles on their trike. With their sense of humor they came up with the following trivia question.... How many miles does a Goldwing have to travel to get an oil change?

Answer: According to John and Teresa, 410 miles.

Since they needed to go 410 miles to get the oil changed they thought why go alone there has to be somebody that wants to take a ride. Our phone rang and it was Teresa asking if we wanted to ride to Russellville, AR with them. With Brenda and me if you mention a ride we're game and it pretty much doesn't matter where or when. The maintenance John needed was the 4,000 mile service. Basically an oil change, however Honda of Russellville checked several more things while they had it in the shop. It worked out that when we arrived in Russellville he had 4010 miles on the trike so the timing was perfect. Now the maintenance agreement John purchased with the new trike is set up so he can get the work done at any dealer with a phone call to take care of paperwork.

That being said what is the fun of going down the road 10 miles to a dealer?

We left mid-morning on Friday for Russellville and after getting the work done headed back to Kansas mid-morning Saturday. The ride was pretty much perfect with no wind, sunny skies and temperatures in the low 70's. Honda of Russellville has an excellent selection of Goldwings with Hannigan, California Sidecar, and Roadsmith trikes, which let me do some side by side comparisons as I'm researching trike kits now for future reference. Along with a good selection of trikes they have several GL1800's and a bunch of the F6B's. For those of you that haven't seen the F6B for some reason Honda widened the front of the seat which causes problems with reach to the ground if you have short legs like me. We had a very interesting trip back home in that we it seemed being "dive bombed" by birds having several come close to our bikes. It appeared John even hit a small one with his radio antenna. We had stopped in Fayetteville, AR for lunch and as we got to the top of the onramp and started to accelerate to merge with traffic all of a sudden a car right in front of John took off to the right and by the time it got straightened back up it had been all over the shoulder and back in front of us. I said it wrecked three times but that the car didn't realize it. It was extremely close to a multivehicle pile-up with the two of us sandwiched around a semi and several cars. Lucky for us John was very alert and we got slowed down before any contact was made with hard stuff. As we were getting close to Topeka we discussed it and decided breakfast at Big Mike's in Holton would be a good way to relax after the ride. It was agreed we would meet at 9:30 rain or shine number of wheels didn't matter. John & Teresa were on their trike Brenda and I were in the pickup (Brenda had an ankle giving her problems). While having a leisure breakfast, I think it lasted 3 hours. We discussed the finer points on

how to tune a CB radio. I managed to hit the channel change switch instead of the volume control and didn't realize it until Teresa left a message on Brenda's phone to check it. Anybody that has a NAVI bike is aware you don't see any of the icons on the left side if you have the screen set up to show distance to the next turn and that is the way I ride most of the time when using the GPS. That's my excuse and I'm sticking to it.

John and I also considered calling the Guinness book of world records for Teresa's accomplishments on the trip. As is well known in Chapter C Teresa tends to require the bike to be stopped frequently to determine the cleanliness of various facilities along whatever route we are riding. This can be a big plus for other riders that are a bit shy about speaking up over the radio. Much to Teresa's credit on the trip to Russellville and back she was able to ride tank to tank on two occasions non-stop. With her doing that John did make a comment that he needed to reacquaint some body parts to each other from spending that much time in the saddle. In addition to that the Butler cups had to be stretched for the entire tank of fuel. The next time anybody sees Teresa don't forget to congratulate her on her staying power. I'm not sure but John may be considering an auxiliary fuel tank to see if she can get a better record time.

We received both bad news and good news this month reference to one of our members. Terry Widner ended up in the hospital on IV antibiotics because of some post operation infection. After positive encouragement from Cathy Logan (most men would say threats) Terry went to the ER where thankfully his problems began where they were able to successfully treat him.

After several days in the hospital he was taken off the IV antibiotics and places on oral antibiotics and allowed to go home. He is able to get around now and is doing well. As many of you know Terry had to sell his Goldwing because of medical reasons, but is still an active member in Chapter C. We wish Terry a quick recovery and lasting good health. Terry did call Ken Felch while several of us were at Ken and Arlene's for our maintenance day and was in good spirits.

Our Maintenance day didn't consist of a lot of maintenance being done as most of the chapter members tend to ride when the roads are safe, so not that much maintenance is required early in the spring to get the Wings road ready. Al Davis did install a nice flashing LED brake light to his bike and also wired his trailer light connector. It apparently was a fairly complicated task since he had to have four supervisors during the install. With the "expert" advice by the chapter members Al was successful in completing the work and getting the rear fender back on the bike and no parts left over. The installation was interrupted by the need to eat pizza and also Ken providing his famous cookies for both appetizers and desert (can't get enough cookies). 
