- The ***Trustees are pleased to announce that the Trumbull Neighborhood Partnership (TNP) has secured an Ohio EPA grant to remediate and remove the abandoned gas station at 3625 Main Street (SR46) in Mineral Ridge***, the project is already out to bid. WHEREAS, Ohio Revised Code §3709.03 authorizes the Board of Trustees to designate an alternate from among themselves to serve at the meetings of the Advisory Council and to exercise voting authority on behalf of the Township if the Chair of the Board of Trustees is unable to attend the meeting of the Advisory Council; and

WHEREAS, the Chair of the Board of Trustees is unable to attend the 2026 annual meeting of the Advisory Council; and

WHEREAS, it is in the best interest of Weathersfield Township to designate an alternate from among themselves to ensure continuous representation and the ability to vote at the 2026 annual meeting of the Advisory Council;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Weathersfield Township, Trumbull County, Ohio, that:

1. Trustee Edward Whittaker is hereby designated as the alternate to the Chair of the Board of Trustees for purposes of attending the 2026 annual meeting of the Trumbull County Combined Health District Advisory Council, in accordance with the provisions of Ohio Revised Code §3709.03; and
2. Trustee Edward Whittaker is hereby delegated the authority to vote on behalf of the Chair at said meeting of the Advisory Council, in accordance with the provisions of Ohio Revised Code §3709.03; and
3. This Resolution shall take effect immediately upon its adoption.
