WHEREAS, Ohio Revised Code Section 2925.03(F)(1) "Trafficking, aggravated trafficking in drugs" authorizes creation of the Drug Law Enforcement Fund and requires adoption of a written internal control policy governing use of those funds and the Board of Trustees by this Resolution adopts such a policy and specifies approved uses for these funds, and

WHEREAS, Ohio Revised Code Section 2981.13(C)(1) "Sale of forfeited property – application of proceeds – forfeiture funds" authorizes creation of the Law Enforcement Trust Fund and requires adoption of a written internal control policy governing use of those funds and the Board of Trustees by this Resolution adopts such a policy and specifies approved uses for these funds, and,

WHEREAS, Ohio Revised Code Section 4511.19(G)(5) "Operating vehicle under the influence of alcohol or drugs - OVI Trafficking, aggravated trafficking in drugs" authorizes

creation of the Enforcement and Education Fund and the Board of Trustees by this Resolution specifies approved uses for these funds; and

WHEREAS, the Board of Trustees hereby specifies approved uses by the Weathersfield Township Police Department of the Opioid Settlement Funds received from the settlement of lawsuits against the distributors of opioids.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF WEATHERSFIELD TOWNSHIP, TRUMBULL COUNTY, STATE OF OHIO, that:

<u>Section I.</u> There is hereby adopted an Internal Control Policy for the Weathersfield Township Police Department's receipt and use of funds in the Drug Law Enforcement Fund and the Law Enforcement Trust Fund. The Internal Control Policy is attached.

<u>Section II.</u> The Board of Trustees determines the Drug Law Enforcement Fund may be used for any expense of the Weathersfield Township Police Department that pertains to the enforcement of the laws related to drug offenses, including but not limited to: Police department employee salaries, retirement contributions, worker's compensation charges, supplies such as gasoline, oil, tires, guns, etc., and capital costs, including buildings, vehicles, equipment and tools of the Police Department, used in law enforcement efforts pertaining to drug offenses.

<u>Section III.</u> The Board of Trustees determines the The Law Enforcement Trust Fund may be used:

(i) To pay the costs of protracted or complex investigations or prosecutions;

(ii) To provide reasonable technical training or expertise;

(iii) To provide matching funds to obtain federal grants to aid law enforcement, in the support of DARE programs or other programs designed to educate adults or children with respect to the dangers associated with the use of drugs of abuse;

(iv) To pay the costs of emergency action taken under section 3745.13 of the Revised Code relative to the operation of an illegal methamphetamine laboratory if the forfeited property or money involved was that of a person responsible for the operation of the laboratory;

(v) For other law enforcement purposes, and the Board of Trustees determines the following uses to be appropriate: any expense of the Weathersfield Township Police Department, including employee salaries, retirement contributions, benefits, worker's compensation charges, unemployment compensation costs, tools, equipment, supplies, and buildings used by the Police Department.

Ten percent of the first one hundred thousand dollars of amounts deposited during each calendar year in Law Enforcement Trust Fund shall be used in connection with community preventive education programs, including but not limited to the DARE program.

<u>Section IV.</u> The Board of Trustees determines the Enforcement and Education Fund may be used for any expense of the Weathersfield Township Police Department that pertains to the enforcement of the laws related to operating a vehicle under the influence of alcohol or drugs, including but not limited to: Police department employee salaries, retirement contributions, worker's compensation charges, supplies such as gasoline, oil, tires, guns, etc., and capital costs, including buildings, vehicles, equipment and tools of the Police Department that are used in enforcing R.C. §4511.19 and to educate the public about driving under the influence.

<u>Section V</u>. The Board of Trustees determines that Opioid Settlement Funds may be used consistent with the OneOhio Memorandum of Understanding which defines "Approved Purposes" as: "evidence-based forward-looking strategies, programming and services used to (i) expand the availability of treatment for individuals affected by substance use disorders, (ii) develop, promote and provide evidence-based substance

use prevention strategies, (iii) provide substance use avoidance and awareness education, (iv) decrease the oversupply of licit and illicit opioids, and (v) support recovery from addiction services performed by qualified and appropriately licensed providers. The Board of Trustees determines that it is appropriate to use the Opioid Settlement Funds to decrease the oversupply of licit and illicit opioids by applying the funds to pay a portion of the salaries and benefits of Police Department employees working to decrease the supply of illicit opioids; as well as for drug take-back disposal or destruction programs; to discourage or prevent misuse of opioids through drug prevention efforts including drug prevention programs in schools; for training and education regarding naloxone and other drug overdose treatments; for education of officers related to opioids, and for the provision of wellness and support services for officers related to responding to opioidrelated events.

<u>Section VI.</u> The Board finds that the passage of this resolution and all deliberations relating to the passage of this resolution were held in open meetings in accordance with the provisions of Ohio Revised Code Section 121.22.

<u>Section VII.</u> This Resolution shall take effect, and shall be in full legal force and effect, from and after the earliest period allowable by law.

#### 24-164 Motion to adopt a **RESOLUTION TO REQUIRE OWNER TO DEMOLISH STRUCTURE** WHICH IS UNFIT FOR HUMAN HABITATION PURSUANT TO OHIO REVISED CODE §505.86.

WHEREAS, Ohio Revised Code §505.86 authorizes a Board of Trustees to declare structures within the Township to be a nuisance by reason of being insecure, unsafe, structurally defective, or unfit for human habitation, and to provide for the abatement of said nuisance by repair or demolition and removal of said structures; and

WHEREAS, the Trumbull County Board of Health, at their meeting on August 14, 2024, declared the structure located at 1375 Emerson Avenue, Niles, Ohio 44446 ("the Property") to be Unfit for Human Habitation.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Weathersfield Township, Trumbull County, Ohio as follows:

**Section 1**: The Structure on the Property is hereby determined to be a nuisance and a threat to the public health and safety as unfit for human habitation and must be demolished and removed, pursuant to O.R.C. §505.86.

**Section 2:** Notice shall be given to the owner(s) of the Property and any lienholders by certified mail or as otherwise provided in O.R.C. §505.86, of the Township's declaration of nuisance and demand to abate said nuisance by demolition, and the right to request a hearing in writing within twenty days after the notice is mailed, pursuant to O.R.C. §505.86 (B) and (C).

**Section 3:** If the Property Owner or lienholders fails to request a hearing before the Board within twenty days or provide for the repair or demolition and removal within thirty days of issuing notice, the Board authorizes the Township Administrator to enter into contracts with private contractors or the Trumbull County Land Bank for the demolition of the structures on the Property.

**Section 4.** The total costs incurred by the Township for the demolition and removal of the structure and abatement of the nuisance, including all associated site restoration work, and the costs incurred in providing notice shall be paid from the Township general fund, and the Township Fiscal Officer shall certify the total costs incurred to the county Auditor who shall place the costs upon the tax duplicate to be a lien upon such lands from and after the date of entry. The costs shall be collected as other taxes and returned to the Township general fund.

This Resolution shall take effect immediately upon adoption.

structurally defective, or unfit for human habitation, and to provide for the abatement of said nuisance by repair or demolition and removal of said structures; and

WHEREAS, Ohio Revised Code §505.871 authorizes a Township Board of Trustees to require removal of junk motor vehicle(s) in the Township; and

WHEREAS, the Trumbull County Board of Health, at their meeting on September 25, 2024, declared the structure located at 1345 Depot Street, Mineral Ridge, Ohio 44440 ("the Property") to be Unfit for Human Habitation; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Weathersfield Township, Trumbull County, Ohio as follows:

**Section 1**: The Structure on the Property is hereby determined to be a nuisance and a threat to the public health and safety as unfit for human habitation and must be demolished and removed, pursuant to O.R.C. §505.86.

**Section 2:** The Board of Trustees determines the following motor vehicles on the Property are "junk motor vehicles" as defined in O.R.C. §505.173 as a vehicle meeting all of the following criteria: being (1) three model years old or older, (2) apparently inoperable, and (3) extensively damaged, including but not limited to, any of the following: missing wheels, tires, engine, or transmission. There are multiple vehicles stored on the grass in the back yard, and four motor vehicles parked on the driveway, including a tractor.

**Section 3:** Notice shall be given to the owner(s) of the Property and any lienholders by certified mail or as otherwise provided in O.R.C. §505.86, of the Township's declaration of nuisance and demand to abate said nuisance by demolition, and their right to request a hearing in writing within twenty days after the notice is mailed, pursuant to O.R.C. §505.86 (B) and (C) and O.R.C. §505.871.

**Section 4:** If the Property Owner, lienholders, or other Party in Interest fails to request a hearing before the Board within twenty days or provide for the repair or demolition and removal, and removal of said junk vehicles, within thirty days of issuing notice, the Board authorizes the Township Administrator to enter into contracts with private contractors or the Trumbull County Land Bank for the demolition of the structures and removal of junk vehicles on the Property.

**Section 5.** The total costs incurred by the Township for the demolition and removal of the structure and junk vehicles and abatement of the nuisance, including all associated site restoration work, and the costs to remove or cause the removal of the junk motor vehicles, including the costs incurred in providing notice, shall be paid from the Township general fund, and the Township Fiscal Officer shall certify the total costs incurred to the county Auditor who shall place the costs upon the tax duplicate to be a lien upon such lands from and after the date of entry. The costs shall be collected as other taxes and returned to the Township general fund.

This Resolution shall take effect immediately upon adoption.
