25-153 MOTION TO ADOPT A RESOLUTION APPROVING ANNEXATION AGREEMENT AMONG GEARMAR PROPERTIES, INC., THE CITY OF NILES, AND WEATHERSFIELD TOWNSHIP.

WHEREAS, Gearmar Properties, Inc. owns approximately 122.632± acres of land located in Weathersfield Township, Trumbull County, Ohio, Permanent Parcel Nos. 24-310900; 24-311300, and 24-311400, (collectively, the "Property"); and

WHEREAS, Gearmar Properties, Inc. desires to annex the Property into the City of Niles; and

WHEREAS, the City of Niles, Weathersfield Township, and Gearmar Properties, Inc. have negotiated an Annexation Agreement to foster economic development that will benefit the residents of both the City and the Township, as the property will be annexed into the City but also remain in the Township.

NOW, THERFORE, be it resolved by the board of Trustees of Weathersfield Township:

<u>Section 1:</u> That the Annexation Agreement among the City of Niles, Weathersfield Township, and Gearmar Properties, Inc. attached hereto be approved, and that the Chairman of the Board of Trustees is authorized to execute the Agreement.

<u>Section 2:</u> That the Township agrees not to object to the annexation petition filed by Gearmar Properties, Inc. with the Trumbull County Board of Commissioners on July 17, 2025, and affirmatively consents to the Annexation of the Property on the terms as set forth in the Annexation Agreement.

<u>Section 3.</u> That a fully executed copy of this Resolution and the Annexation Agreement shall be filed with the Trumbull County Board of Commissioners.

<u>Section 4.</u> That the Board finds and determines that all formal actions of this Board concerning and relating to the passage of this resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any committee that resulted in those formal actions were in meetings open to the public in compliance with law.
