25-054 Motion to ***adopt a Resolution to accept the proposal of Miller Yount Paving Inc to construct New Pickleball Courts*** and authorize Township Administrator to enter into a design-build contract for the construction.

WHEREAS, Weathersfield Township has secured a grant of \$150,000.00 from the Trumbull County Commissioners from American Rescue Plan Funds for the construction of pickleball courts at the Township Park located at 1388 Stewart Street, Mineral Ridge, Ohio 44440; and

WHEREAS, Weathersfield requested proposals from contractors for construction of the pickleball courts with lighting and fencing in accordance with law.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Weathersfield Township, Trumbull County, Ohio as follows:

Section 1: The Proposal of Miller Yount Paving Inc to construct four pickleball courts with fencing and lighting for the sum of One hundred forty-eight Thousand, Seven Hundred Dollars (\$148,700.00) is hereby accepted.

Section 2. The Township Administrator, David Rouan, is hereby authorized to enter into a contract with Miller Yount Paving Inc, 2295 Hoagland Blackstub Road, Cortland, OH 44410, to construct four pickleball courts with fencing and lighting at the Township Community Park for the sum of One hundred forty-eight Thousand, Seven Hundred Dollars (\$148,700.00).
