- The Trustees would like to announce their 2019 Residential Tree Limb Chipping Program. The 2019 Residential Tree Limb Chipping Program begins on Friday May 3rd, 2019 and will continue each Friday through Friday October 25th, 2019. For tree limb pick-up, you must call the Township by Thursday of each week to be placed on the list for a Friday pick-up. Please keep the following rules and procedures in mind:
 - This program is intended for residential tree limbs up to 3 inches in diameter.
 - The tree limbs must be placed at the curbside with all the cut ends aligned with each other toward the street.
 - No shrubs, stumps, roots, lumber, or rail road ties will be accepted. All tree limbs must be free from vines.
 - We are not a tree removal service; if you are having a tree professionally removed let them do the entire job, you must have them take the tree limbs as well.
- The *Trustees would like to remind everyone of the dates for the 2019 Spring Clean-Up Program.* The program will begin on Monday, May 13th, 2019 and continue through Friday, May 17th, 2019. Residents should put their items out on their regular night.
- The *Trustees would like to remind everyone of the dates for the 2019 Scrap Tire Grant.* Curbside collection will begin on Monday, May 13th, 2019 and continue through Friday, May 17th, 2019. There is a limit of four car tires (off rims) per household, large truck tires will NOT be accepted. You can also drop-off your tires between 8:00 AM and 3:00 PM during the collection week at the Township Administration Building at 1451 Prospect Street, Mineral Ridge, Ohio 44440.
- The Trustees would like to remind our residents that the Warren-Trumbull County Public Library Bookmobile will be at our Community Park twice a month and this will continue through Monday, May 13th, 2019. Please see our social media and website for specific dates and times.
