The lead government agency for the joint LGIF grant application will be the Trumbull County Engineer's Office. The participating local government entities include the Trumbull County Engineer's Office, the Trumbull County Commissioners, Howland Township Trustees, the village of Newton Falls, and the Weathersfield Township Trustees. The 10% local match that will be required if the LGIF grant is awarded will be paid by the Trumbull County Engineer's Office and the Trumbull County Commissioners, there will be no local match revenues required from Weathersfield Township.
