United States Army, serving in the 1st Amphibious Brigade, D Company as the company bazooka man. Thomas' commitment to duty and resilience were evident as he played a crucial role in the invasion of Normandy, France, on June 6, 1944, with his fellow brothers.

Marching alongside 133,000 soldiers, Corporal Bettura valiantly stormed Utah Beach and fearlessly advanced on the battlegrounds. His short stature did not deter him as he waded through chin-deep water, carrying his bazooka and rockets on his shoulders, ensuring their preservation and effectiveness.

Throughout WWII, Corporal Thomas A. Bettura participated in five campaigns across Northern France and Central Europe, including the liberation of Buchenwald Concentration Camp in Weimar Germany on April 11, 1945. His actions and those of his fellow brothers led to the freedom of over 21,000 people, a testament to their heroism and unwavering commitment to justice.

Upon his honorable discharge from the Army in 1945, Corporal Bettura was recognized for his exceptional service, earning the Gold Star for completion of five campaigns and the Arrowhead for the initial assault on Normandy. His sacrifices and valor are etched in history, serving as a shining example for future generations.

Beyond his military service, Corporal Thomas A. Bettura continued to make a profound impact on his community. He married his beloved wife Stephanie Gawdyda, and together they raised a loving family. Corporal Bettura's commitment to his faith was evident through his fifty-year tenure as an usher at St. Rose Church in Girard.

As Corporal Thomas A. Bettura approaches his 100th birthday in July, we stand in awe of his extraordinary life, marked by selflessness, bravery, and dedication. In an era where the term "hero" is often misused, we acknowledge Corporal Bettura's true heroism and commend him for his unwavering devotion to his family, community, and our great nation.

WHEREAS, O.R.C. §505.87 authorizes a Board of Trustees to provide for the abatement, control, or removal of vegetation, garbage, refuse, and other debris from land in the township, if the board determines that the owner's maintenance of that vegetation, garbage, refuse, or other debris constitutes a nuisance; and

WHEREAS, the Property located at **3624 South Main Street, Mineral Ridge, OH 44440** Weathersfield Township, Trumbull County, Ohio, Parcel No. 21-155750 (hereinafter "the Property"), has been inspected by the Township Zoning Inspector, who has taken photos of the property showing that the grass is unmowed and there are overgrown bushes and weeds.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Weathersfield Township, Trumbull County, Ohio as follows:

- **Section 1**: The Board of Trustees determines that the accumulation of vegetation, including unmowed grass, overgrown bushes and weeds, upon the Property constitutes a nuisance, which is dangerous, unhealthy, and unsightly to the neighborhood and community and which negatively impacts property values and the general welfare of the community, and must be abated pursuant to O.R.C. §505.87.
- **Section 2:** The Owners of the property are ordered to immediately abate, control or remove the overgrown vegetation and mow and maintain the grass on the Property.
- **Section 3:** The Township Fiscal Officer shall give notice of this Resolution to the owners of the Property by publication in a newspaper of general circulation in the Township and by posting a notice on the principal structure on the land. The Property Owner to be notified is: SABIR Properties, Inc.
- **Section 4:** If within **seven days** the Property owner fails to abate, control, or remove the overgrown vegetation and mow and maintain the grass on the Property, the Board shall provide for the removal of the vegetation, and mowing of the grass, and may employ a contractor to perform such work.

**Section 5.** The total costs incurred by the Township for the abatement, control, or removal of the vegetation, and mowing, including the costs incurred in providing notice, the cost of a lien search and the amount paid for labor, materials and equipment shall be paid out of the Township general fund. The Township Fiscal Officer shall certify the total costs incurred to the county Auditor who shall place the costs upon the tax duplicate to be a lien upon such lands from and after the date of entry. The costs shall be collected as other taxes and returned to the Township general fund.

**Section 6.** All formal actions relative to the passage of this Resolution were taken in an open meeting of the Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including §121.22 of the O.R.C.
