WHEREAS, Ohio Revised Code §505.86 authorizes a Board of Trustees to declare structures within the Township to be a nuisance by reason of being insecure, unsafe, structurally defective, or unfit for human habitation, and to provide for the abatement of said nuisance by securing or demolition and removal of said structures after thirty days' notice ; and;

WHEREAS, Ohio Revised Code §505.87 authorizes a Board of Trustees to declare real Property in the Township which is not maintained and contains accumulations of vegetation, garbage, refuse or other debris a nuisance and provide for the abatement of such nuisance after seven days' notice; and

WHEREAS, Ohio Revised Code §505.871 authorizes a Board of Trustees to provide for the removal of any vehicle in the Township determined to be a junk motor vehicle after fourteen days' notice; and

WHEREAS, Ohio Revised Code §3929.86 authorizes a Board of Trustees to use funds deposited by an insurance company to repair, remove or secure structures within the Township damaged by fire if the property owner fails to do so; and

WHEREAS, the following property located in Weathersfield Township (hereinafter "the Property") was severely damaged by fire in August 2020:

**1465 Lincoln Avenue, Mineral Ridge OH 44440, Weathersfield Township**

WHEREAS, the Weathersfield Township Fire Chief has inspected the Property and has declared the structures on the Property to be insecure, unsafe and unfit for human habitation due to structural damage caused by fire, and the Property to have accumulations of debris and vehicles that are abandoned, apparently inoperable and extensively damaged and;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Weathersfield Township, Trumbull County, Ohio as follows:

**Section 1:** The Board of Trustees determines that the structures on the Property are abandoned, insecure, unsafe, dilapidated, dangerous and/or structurally deficient and must be demolished and removed pursuant to O.R.C. §505.86.

**Section 2:** The Board of Trustees determines that the accumulation of vegetation, garbage, refuse and other debris upon the Property constitutes a nuisance which must be abated pursuant to O.R.C. §505.87.

**Section 3:** The Board of Trustees determines that the motor vehicles on the Property are "junk motor vehicles" as defined in O.R.C. §505.173 as they are (1) three model years old or older, (2) apparently inoperable, and (3) extensively damaged, and the vehicles constitute a nuisance which must be removed pursuant to O.R.C. §505.871.

**Section 4:** The Board of Trustees has received a deposit pursuant to R.C. 3929.86 as security for against the total cost of removing, repairing, or securing the fire damaged structures incurred by the township pursuant to R.C. 505.86.

**Section 5:** Notice has or shall be given to the owners of the Property and any lienholders by certified mail or publication in a newspaper of general circulation in the township and by posting a notice on the principal structure on the land, of the Township’s declaration of nuisance and demand to abate said nuisance by demolition, and the right to request a hearing in writing within twenty days after the notice is mailed, pursuant to RC 505.86(B) and(C).

**Section 6:** If the Property Owner or lienholders fail to request a hearing before the Board within twenty days or provide for the demolition and removal of said nuisance structures within thirty days of giving notice, the Board authorizes the Township Administrator to enter into contracts for the demolition of the structures on the Property and the removal of the vegetation, garbage, refuse, debris, and junk vehicles from the Property.

**Section 7.** The total costs incurred by the Township for the abatement, control, or removal of the structures damaged by fire, and abatement of the nuisance, including all associated site restoration work, and the costs incurred in providing notice shall be paid out of the funds on deposit with the township pursuant to R.C. 3929.86. If there are any funds remaining, they will be returned to the property owner.

**Section 8:** If the funds on deposit are insufficient to pay the costs of demolition and abatement of the nuisance, such costs will be paid from the Township general fund, and the Township Fiscal Officer shall certify the total unrecovered costs incurred to the county Auditor who shall place the costs upon the tax duplicate to be a lien upon such lands from and after the date of entry. The costs shall be collected as other taxes and returned to the Township general fund.
