All applicable local, state, and federal procurement requirements will be followed when expending federal funds. Should the state of Ohio have more stringent requirements, the most restrictive requirement shall apply so long as it is consistent with state and federal law.

WHEREAS, The Youngstown Air Reserve Station ("YARS") is home of the 910th Airlift Wing of the United States Air Force and is a critical part of the nation's air defense, charged with two major missions, providing fixed wing aerial spraying capability and combat tactical airlift operations; and

WHEREAS, YARS is Trumbull County's largest employer, and has been selected as the preferred location for eight new, high-tech C130J Super Hercules aircraft to replace the current C-130H's; and

WHEREAS, a Joint Land Use Study (JLUS) for YARS and the surrounding community was completed in 2019, identifying ways land use may impact YARS, and the Military Installation Sustainability Grant Project is seeking to implement the recommendations for compatible land use and coordination between local governments and YARS; and

WHEREAS, Weathersfield Township is committed to supporting YARS. NOW, THEREFORE, BE IT RESOLVED by the Weathersfield Township Board of Trustees, State of Ohio:

SECTION 1. Weathersfield Township recognizes the importance of YARS to the Weathersfield community and seeks to support YARS and maintain community airspace compatibility with YARS military operations and increase communication and coordination with YARS.

SECTION 2. Weathersfield Township will seek to communicate and coordinate with YARS when development is proposed which could potentially be incompatible with the YARS mission, particularly to mitigate Bird/Wildlife Aircraft Strike Hazards
