26-124 MOTION TO ***ADOPT A RESOLUTION EXTENDING FOR AN ADDITIONAL SIX (6) MONTHS THE TEMPORARY MORATORIUM ON DATA CENTERS WITHIN THE UNINCORPORATED TERRITORY OF WEATHERSFIELD TOWNSHIP ESTABLISHED BY RESOLUTION NUMBER 26-070***

WHEREAS, pursuant to Ohio Revised Code Chapter 519, including Sections 519.02 and 519.12, the Weathersfield Township Board of Trustees is authorized to regulate the use of land and structures within the unincorporated territory of Weathersfield Township in furtherance of the public health, safety, convenience, comfort, prosperity, and general welfare and to adopt and amend the Township Zoning Resolution; and

WHEREAS, on Thursday, April 30, 2026, at its Regular Meeting held at 3:30 P.M., the Weathersfield Township Board of Trustees adopted Resolution No. 26-070, establishing a temporary six (6) month moratorium on data centers within the unincorporated territory of Weathersfield Township; and

WHEREAS, Resolution No. 26-070 was adopted because the Board of Trustees determined that data centers present substantial and complex land-use considerations and potential impacts involving, among other matters, electrical generation and transmission capacity, electric utility costs, water consumption and water resources, sanitary sewer capacity and wastewater discharge, stormwater management, environmental impacts, audible and low-frequency noise, infrasound, traffic and roadway infrastructure, emergency services, neighboring properties, land-use compatibility, community character, and the overall public health, safety, and welfare of Township residents; and

WHEREAS, the Board of Trustees further determined through Resolution No. 26-070 that data centers are not presently identified as either a permitted use or conditionally permitted use within the Township’s industrial zoning districts and that additional study and consideration were necessary to determine how such uses should be addressed within the Weathersfield Township Zoning Resolution; and

WHEREAS, the purpose of the temporary moratorium established by Resolution No. 26-070 was to provide the Township with sufficient time to carefully study the complex issues associated with data centers and to permit the Weathersfield Township Zoning Commission, Zoning Director, Law Director, and other Township officials and professional advisors, as appropriate, to review the existing Zoning Resolution and develop appropriate amendments to protect the Township and its residents; and

WHEREAS, since the adoption of Resolution No. 26-070, the Weathersfield Township Zoning Commission, Zoning Director, and Law Director have diligently and continuously worked to research, review, develop, and revise proposed amendments to the Township Zoning Resolution concerning data centers and related land uses; and

WHEREAS, this work has included consideration of the unique nature, scale, intensity, infrastructure requirements, environmental effects, utility demands, noise characteristics, and other potential impacts associated with modern data center development and the appropriate regulatory measures necessary to address those impacts; and

WHEREAS, the Board of Trustees recognizes that the regulation of data centers involves complex technical, legal, land-use, environmental, infrastructure, and public-policy considerations and finds that the development of appropriate zoning regulations should not be rushed merely to meet the expiration date of the original moratorium; and

WHEREAS, notwithstanding the substantial work already completed, the Zoning Commission, Zoning Director, and Law Director have determined that additional time is necessary to carefully, thoroughly, and thoughtfully research these issues and to appropriately craft and refine proposed amendments to the Weathersfield Township Zoning Resolution; and

WHEREAS, the Board of Trustees finds that allowing this work to proceed deliberately and comprehensively is in the best interests of the Township and its residents and will help ensure that any zoning regulations ultimately considered by the Township are reasonable, legally defensible, appropriately tailored, and sufficient to protect the public health, safety, and welfare; and

WHEREAS, Section 4. Effective Period of Resolution No. 26-070 expressly provides for the effective period of the moratorium, and the Board of Trustees has determined that it is necessary and appropriate to extend that effective period for an additional six (6) months so that the ongoing review and zoning amendment process may be properly completed; and

WHEREAS, the Board of Trustees finds that the requested extension is reasonable in duration, is directly related to the ongoing and active review of the Township’s zoning regulations, and is necessary to preserve the status quo while that work is completed; and

WHEREAS, the Board remains committed to protecting the character of Weathersfield Township and the health, safety, welfare, property, and quality of life of its residents while the Township completes this important regulatory review.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Weathersfield Township, Trumbull County, Ohio:

SECTION 1. INCORPORATION OF RESOLUTION NO. 26-070.

The Board hereby incorporates by reference the findings, determinations, purposes, definitions, restrictions, and provisions contained in Resolution No. 26-070, adopted April 30, 2026, except as expressly modified by this Resolution.

SECTION 2. EXTENSION OF MORATORIUM.

Pursuant to Section 4. Effective Period of Resolution No. 26-070, the temporary moratorium established by Resolution No. 26-070 concerning data centers within the unincorporated territory of Weathersfield Township is hereby extended for an additional period of six (6) months.

Except for the extension of its effective period provided by this Resolution, all terms, conditions, restrictions, findings, and provisions of Resolution No. 26-070 shall remain in full force and effect during the extended moratorium period.

SECTION 3. CONTINUED ZONING REVIEW.

During the extended moratorium period, the Weathersfield Township Zoning Commission, Zoning Director, Law Director, and other appropriate Township officials and professional advisors are authorized and encouraged to continue their comprehensive review and analysis of data centers and to continue preparing, refining, and processing appropriate amendments to the Weathersfield Township Zoning Resolution in accordance with Ohio law.

The Board expressly finds that the additional six-month period is necessary to provide sufficient time for this work to be completed carefully, thoroughly, and thoughtfully, including the research, drafting, review, public hearing, recommendation, and legislative processes required for amendments to the Township Zoning Resolution.

SECTION 4. PURPOSE AND FINDINGS.

The Board finds that this extension is a reasonable and temporary land-use measure necessary to maintain the status quo while the Township actively considers amendments to its Zoning Resolution and that the extension serves the legitimate governmental purpose of protecting the public health, safety, convenience, comfort, prosperity, and general welfare of the residents of Weathersfield Township.

The Board further finds that the extension is necessary because of the substantial and potentially long-term consequences that data center development may have upon the Township, its residents, neighboring properties, public infrastructure, natural resources, utility systems, and community character.

SECTION 5. CONTINUING EFFECT OF ORIGINAL MORATORIUM.

Nothing contained in this Resolution shall be interpreted as repealing, superseding, weakening, or otherwise modifying the substantive provisions of Resolution No. 26-070. Rather, this Resolution shall be construed as an extension and continuation of the moratorium established therein.

In the event of any conflict concerning the duration of the moratorium, the provisions of this Resolution shall control.

SECTION 6. SEVERABILITY.

If any section, subsection, sentence, clause, phrase, or other portion of this Resolution is for any reason held invalid, unconstitutional, or unenforceable by a court of competent jurisdiction, such determination shall not affect the validity of the remaining portions of this Resolution, which shall remain in full force and effect.

SECTION 7. EFFECTIVE DATE.

This Resolution shall take effect immediately upon its adoption and shall extend the moratorium established by Resolution No. 26-070 for an additional six (6) months beyond the expiration of the original moratorium period, unless earlier terminated, modified, or otherwise superseded by subsequent action of the Board of Trustees in accordance with law.

- 26-126 ***MOTION TO ADOPT A RESOLUTION TO ABATE NUISANCE BY REQUIRING REMOVAL OF JUNK VEHICLES, JUNK, GARBAGE AND DEBRIS FROM THE PROPERTY AT 2896 NILES CARVER ROAD, NILES, OHIO 44446 PURSUANT TO OHIO REVISED CODE (O.R.C.) §505.87 and §505.871 AND TO REQUIRE THE OWNER OF THE PROPERTY AT 2896 NILES CARVER ROAD, NILES, OHIO 44446 TO REMOVE THE JUNK VEHICLES, JUNK, GARBAGE, REFUSE AND DEBRIS FROM THE PROPERTY***

WHEREAS, Ohio Revised Code §505.87 authorizes a Board of Trustees to provide for the abatement, control, or removal of garbage, refuse, and other debris from land in the township, if the board determines that the owner's maintenance of that garbage, refuse, or other debris constitutes a nuisance; and

WHEREAS, Ohio Revised Code §505.871 authorizes a township Board of Trustees to require the property owner to remove junk motor vehicle(s) from property in the township; and

WHEREAS, the Property located at 2896 Niles Carver Road, Niles, OH 44446, Weathersfield Township ("the Property") has been inspected and photographs taken and there is junk, garbage and debris on the Property, and there are vehicles located on the Property, not within a building, that appear to be "junk motor vehicles".

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Weathersfield Township, Trumbull County, Ohio as follows:

Section 1: The Board of Trustees determines the motor vehicles on the Property that are not within a building are "junk motor vehicles" as defined in O.R.C. §505.173 as a vehicle meeting all of the following criteria: being (1) three model years old or older, (2) apparently inoperable, and (3) extensively damaged, including but not

limited to, any of the following: missing wheels, tires, engine, or transmission. There are multiple junk motor vehicles stored on the property.

Section 2: The house on the Property was destroyed by fire January 15, 2025, and the house demolished and debris removed in July, 2025. Since that time, the Property Owner has accumulated an extensive amount of junk, miscellaneous household items, loose garbage and debris on the exterior of the property. The Board of Trustees hereby determines that the junk, garbage and debris stored in the yard on the Property constitutes a nuisance.

Section 3: Notice shall be given to the owner(s) of the Property and any lienholders (Parties in Interest) by certified mail, posting on the property, or as otherwise provided in O.R.C. 505.87 and 505.871, of the Township’s declaration that the junk vehicles, junk, garbage and debris constitute a nuisance, and of their right to request a hearing to dispute this determination.

Section 4: If the Property Owner or other Party in Interest fails to request a hearing before the Board and fails to remove the junk vehicles, junk, garbage, and debris within fourteen (14) days of notice, the Board may contract for the removal and disposal of the junk vehicles, garbage, junk and debris from the Property.

Section 5. The total costs incurred by the Township for the removal and disposal of the junk vehicles, junk, garbage and debris, and the costs incurred in providing notice, shall be certified by the Township Fiscal Officer to the county Auditor who shall place the costs upon the tax duplicate to be a lien upon such lands from and after the date of entry. The costs shall be collected as other taxes and returned to the Township general fund.

- Michael Moore of 1457 Williamson Street in Mineral Ridge read the following statement: Good evening. My name is Mike Moore, and asked for clarification from the Board regarding two portions of the Township Zoning Regulations. I have provided a packet containing the applicable ordinance language, the relevant correspondence in chronological order, photographic exhibits showing the exterior lighting and the pool at issue, including a representative pool-model comparison, and a short summary of relevant Ohio legal context. I'm not asking the Board to mediate a disagreement between neighbors, and I'm not asking the Board to accept my interpretation of these regulations. I'm asking the Board to tell me the Township's interpretation so that the rule can be understood and applied consistently. Although these questions arose from a specific situation, I believe the answers are relevant to any Township resident who needs to understand what these regulations permit or require. Regarding Section 1606.1, I am asking what the Township means by a "portable above-ground pool with an excavation of two feet or less," what "excavation" measures, and which of the subsections that follow still apply when a pool is classified under that exclusion. Regarding exterior lighting, I am asking whether Sections 1701.1 and 1701.2 apply to residential properties and, if they do, what standard the Township uses to determine compliance with the requirements concerning light spill, trespass, and direct lighting onto neighboring property. If the current ordinance language does not clearly express the Township's intended rule, I respectfully ask that the Board and Law Director consider whether clarification or amendment is appropriate. I've tried to make the packet complete because I am much better at explaining this in writing than speaking in front of a group. I appreciate the Board taking the time to review it. Thank you.

Trustee Whittaker thanked Mr. Moore and stated that the law director and zoning inspector will get back to him regarding his questions.
