3. All rubbish must be removed from all stabling, yarding, camping and wash bay areas. Any person found to be littering will incur a cleaning fee. Please use the ample supply of clearly marked bins throughout the property to dispose of rubbish.

4. All manure is to be picked up from around camping/float areas and placed in the appropriate signed areas. Failure to do so if caught will incur a cleaning fee.

5. All wash bays are to be hosed off after use. Do not leave products, manure, hair etc in the wash bays. Persons found to not adhere to this will incur a cleaning fee.

6. All dogs must be restrained and kept within the camping area. If found roaming or harassing other competitors, wildlife of animals they risk being reported to Council for impounding.

7. All stable/ yard rakes and wheelbarrows must be returned after use. These are kindly provided by the BEC and they expect they are returned in good condition.

8. All powered camping site are required to provide their own extension cables/ power boards to use. Always use safety precautions and do not overload the BEC power boxes with excessive appliances in use at once as this poses a major fire hazard.

9. Electric fences are prohibited from the grounds. Workplace Health and Safety Officers are authorized to remove electric fences that they deem hazardous.

10. All damage caused by the hirer, their helper/s or their animals is the sole responsibility of the hirer and will incur <u>all</u> <u>costs</u> related to the full repairs of damages.
