

Information Updates

Laurie Tatlock reviewed with the Board a proposal from OnePro Services to provide Landscape maintenance, irrigation and other general landscape services for the period May 14, 2024 through November 30, 2024 for \$6,265 payable in 7 equal monthly payment amounts of \$895 per month, May – November. The fees are \$1,200 greater than budgeted. CoCal, the previous landscape contractor has not been providing adequate service. After discussion, a motion to approve the contract with OnePro Services was presented, it was seconded and, upon vote, was unanimously approved.

A motion to ratify the contract with Clanton & Associates to provide design and construction services for lighting along South Alton Court for a fee of \$16,717 was presented, it was seconded and, upon vote, was unanimously approved. Staff discussed the need for a Topographic Design Exhibit and Utility Locating Services for this project and upon motion duly made, seconded and upon vote, the Board authorized expenditure of up to \$15,000 for these services.



Budget Hearing

The Board convened a public hearing to consider and adopt the 2025 Budget, appropriate sums of money and authorized the certification of the tax levy. There were no members of the public present. The public hearing was closed. The Board reviewed the proposed 2025 Budget. Staff recommended continuing the temporary mill levy reduction. Noting the modifications discussed and that there will be minor modifications when final assessment numbers are certified by Arapahoe County, upon motion duly made, seconded and unanimously carried, the Board approved the 2025 Budget, appropriated sums of money and authorized the certification of the tax levy at .8 mills. The public hearing was closed.


