- I. Called Meeting to Order at 4:02 PM
- II. Minutes of the July 23, 2015 meeting were approved by the Board members.
- III. Home-Owner Concerns
  - A. 5149 Moret Court: Landscape concern regarding pathway and surrounding grassy area: Pathway is Villa's responsibility. Ron Jones has contacted Beauchamps to weed and provide upkeep to the area. Homeowner is responsible for water bill because he chose to water the area.
  - B. Club Service Quality: It appears there is growing dissatisfaction with club services. There was discussion on the Food and Staff Service and the Board will discuss further with the Country Club.
  - C. Park Benches: The Board discussed the suggestion to place one or more park benches by each pond. The Board will investigate prices and consider purchase for Spring.
  - D. Golf balls from the driving range: concern noted.
  - E. 4596 Villa France: removal of tree without authorization. Modification process and replies were discussed. Homeowner will submit forms for landscape modification, including an expanded driveway.
  - F. Complaint from homeowner regarding grass by Pond #3 not getting mowed. Ron Jones will contact Beauchamps to rectify the situation.

Path off Quebec Lane: The earlier decision by the Board to pour a concrete path is rescinded due to escalating cost. After discussion, Board decided to remove existing wood mulch (3 in.), install Diamond Edging, cover ground with landscape material and add wood chips. Labor and materials est. \$755.5
