- 1. Called to order 10:30am
- 2. Minutes of December meeting were approved. Minutes for November meeting will be summarized and sent to Kristen from Larry.

- 4. Open Issues: Management Report
 - A. Action Item 2: Walk through with Allied paving on March 19 will also include front entrance road which is worsening.

6. Committee Reports:

- A. Boat Committee: Issues on AP with Mac Marine because of their outdated format of billing invoices. This is been discussed with the owner and all billing will have to be walked through the KT system to receive payment. Owner seemed uninterested in reformatting his billing. The Four Winns will probably market better launched, which will take place in early May. Board will continue search for a replacement 18' outboard.
- B. Landscape committee: Needlecast spray will be completed in May and June for Range tree line. A program will be offered to individual homeowners as well. Jim Linneger called to ask if a large spruce in his yard could be removed because it looks dead. We will revisit this as the weather improves.
- C. Social Committee: Dec. 14th 2019 Christmas party date
- D. Safety Committee: nothing to report

7. New Business:

A. Filbert Emergency Entrance: Discussion over letter from Fire Chief and the requirements for this area will be submitted to legal counsel for review by Kristen. Cost estimates were reviewed by the Board and concerns were raised over the necessity for such a gated area

- and the impact on neighbors in close proximity. Board concern for providing the safest access in case of fire was noted. This will be treated as an urgent item.

- C. Jon will ask for volunteers for the Sunshine committee in his Board update that will go out this week. We need a packet with info and a nice welcoming gift.
