- Reserve Financials there is a group that will do a study on how much financial reserve the Villas would need in a five to ten time period. The charge for this group is substantial and we have had residents who were willing to volunteer to look into this issue
- Moret Ct. & Villa France intersection The speed which vehicles cut and turn the
  corner on Villa France could cause a collision for the vehicles at the stop sign or
  coming to a stop on Villa France. Everyone needs to be aware of this hazard and the
  speed at which they drive. The resulting action would be to put STOP signs on
  Moret Ct. and make the intersection a three-way stop.

#### V. New Business

• Water Tower Cell Phone Survey- There were 101 SASE envelopes along with the questionnaire sent out to the residents. 75 surveys were returned to K.T.C. which equaled a 75% return of these 49 equaled 65% of surveys indicated the interest to go

**forward** in the pursuit of the cell tower and 26 equaled 35% of the surveys indicated **not to go forward** with the pursuit of the cell tower.

- Color schemes- Letters will be sent out to the homeowners with Black doors to have them painted according to the color palette by May of 2011. If they have not been repainted by that time then violation letters will be sent.
- Pond Winterizations- The biggest issue is with pond #1 if the water is too low to cover the pump the pump would freeze and damage it. Further discussion continued about options of how to increase the water level or actions needed to protect the pump.
- Pond 1 algae problems- it is not algae the water is so low that the ground that is usually hidden by the water level is now exposed.
- Tree Stump removal for 5245 Moret and 5198 Versailles are under review.
