At the end of the 90-day consignment term, I choose to:

Donate my unsold items

Pick up my unsold items

Upon choosing to have your items returned at the end of the 90-day term, consignors will be responsible for making note of their pick up date and collecting any unsold items. Due to limited storage, your items will be held for a maximum of 10 days from the contract expiry date. After 10 days, items will be donated to a charity or non-profit organization of our choice.

It is the full responsibility of the consignors to manage, check in and settle their accounts. Accounts and any money earned **will expire after 1 year with no activity**. Your online inventory site, www.ssvintage.consignoraccess.com/login, is updated in live time and is available for you to check freely.

Consignors will receive **40%** of the final sale price.

Payments will be issued by E-transfer or cash (pending amount) at the end of the 90-day term. It will be the responsibility of the consignors to request payment at the end of their contract. You can use your earned credit at any point for in-store purchases, excluding the sale of a gift card.

SSV will price all items based on age, condition, brand, style & product demand. There is a maximum of **20** clothing items, maximum of **5** purses & shoes and up to **10** pieces of jewelry during the 90-day term. Side Street Vintage reserves the right to return any unsold items to the consignor at any given time or in the case of a season changeover. Any items brought in for consignment more than two times that have not sold, will not be renewed for a third time.

All clothing items **must** be freshly laundered, stain-free, odour-free, in excellent used condition and folded down nicely into a bag, box or tote. All purses & shoes must be wiped down and free from soil and scuffs. All jewelry must be organized, clean and free from tarnish. SSV has the right to refuse items brought in without meeting these criteria.

The following list of brand names will not be accepted for consignment: ACX Active, Alia (*unless vintage*), Ardene, ASOS, Athletic Works, Bench, Bloomchic, Blue Crush, Carisma, Cleo, Dalia, Denver Hayes, Divided, Fashion Nova, Forever 21 (*XXI*), George, H&M, Hyba, Joe Fresh, Kirkland, Lily Morgan, My Style, Missguided, Mossimo, Mondetta, NOBO, Old Navy, Primark, Reitmans, Rickis, Seductions, Stitches, Streetwear Society, Shein, Tan Jay (*unless vintage*), Top Shop, Terra & Sky, Time & True, Tuff Athletics, Urban Planet, Victoria Secret, Warehouse One, etc. **SSV will decide if any exceptions are to be made on “brands not accepted”, due to the style, fabric, and wear of the garment. List is subject to changes/edits**

Please note: It is illegal to sell counterfeit luxury goods. If authentication is in question by SSV, a receipt of the certificate will be required. SSV will not knowingly buy or sell counterfeit items and will immediately return or donate items deemed counterfeit.

Side Street Vintage will provide reasonable efforts to safeguard merchandise on our premises. We maintain no liability for loss, damage, or destruction of any consigned items by fire, theft, accident or other cause of any kind.

By signing this agreement, you affirm you have read and fully understand ALL the terms outlined in this document and that you are, indeed, the lawful owner of the merchandise you have brought to us.

The consignor can terminate this agreement at any time, with 1 week's notice provided.
