

## **EQUITY MEMBERSHIP OPPORTUNITIES**

Include 18 holes of Championship Golf, 10 Clay Tennis Courts, Fitness Center 7 days per week, Group Exercise and Aqua Aerobics, Kids and Family Events, Separate Family and Adult-Only Dining, Exciting Social Events, Wine Tastings and Happy Hour Specials, Childcare, Junior Camps and Swim Team, Heated Resort-Style Pool and so much more!

### FULL MEMBERSHIP

Enjoy preferred access to all Club facilities and dining rooms, including unlimited fitness and pool usage. Full members may play golf and tennis without golf greens fees or tennis court fees. Cart fees apply. Sign up 7 days in advance for golf and tennis times.

#### SPORTS MEMBERSHIP

Enjoy preferred access to tennis and golf along with all Club facilities and dining rooms, including unlimited fitness and pool usage. Sports members are not required to pay greens fees any time Tuesday through Friday (except holidays). The Sports Member has a three-day advance sign-up privilege to reserve golf starting times for those days. The Sports Member may reserve tee times for weekend and holiday play with two days advance notice, play is restricted to after noon only and member greens fees apply. Weekend and holiday mornings can only be played as a guest of a Full member and will require payment of the appropriate Guest Fee. Cart fees apply. A two-day advance sign-up privilege is given to reserve court times.

## TENNIS MEMBERSHIP

Enjoy preferred access to tennis along with all social privileges. Tennis members enjoy a 7-day advance sign-up for court times and may play golf up to 4 times per year by paying appropriate greens and cart fees. Tennis members enjoy a 2-day advance sign-up for golf times. Saturday and Sunday golf is restricted to tee times after noon.

## SOCIAL MEMBERSHIP

Enjoy access to all Club facilities and dining rooms, including unlimited fitness and pool usage. Social members may play golf up to four times per year and tennis up to four times per year by paying appropriate golf greens fees, cart fees and tennis court fees. Sign up 2 days in advance for golf and tennis times. Saturday and Sunday golf is restricted to tee times after noon.

- Membership dues may be billed monthly, semi-annually or annually
- Privileges will be extended to two adults (spouses, partners or significant others) living in the same household and any unmarried children under the age of 25 who are claimed as dependents by the member for income tax purposes
- Amounts include a full equity certificate as determined by the Board of Governors.
