Coastal Realty & Property Management, Inc is transitioning to a partnership with CINC Systems, LLC to provide your community's online payment processing and web services to replace the current software AppFolio. We think you will see a positive impact from this partnership, and we look forward to continuing to provide you with the highest level of service.

Our transition to CINC will take effect on January 1, 2025. The transition period will occur for 2 weeks prior to this date through the end of the month of "GO LIVE". Please note that during the transition period, you may experience a delay in some processes. Late fees will not be assessed for the month of January 2025.

For your convenience, Coastal Realty in conjunction with CINC Systems, LLC will provide the following methods of payment:

You have 5 options to pay your assessments:

- 1. Mailing your payment to our main office payable to Ocean Villas, 3942 A1A South, St. Augustine, FL 32080.
- 2. Online payments through the Owner's Portal you will be able to make online payments and set up automatic recurring payments using either e-check or credit cards through our new

homeowner portal. There will be a convenience fee for e-checks and credit card payments. Information on the site and how to set up your portal will be sent closer to our GO LIVE date.

- 3. ACH you will have the option to set up reoccurring ACH from your checking or savings account. There is no fee associated with this payment method. Please contact your manager for the required form to be completed for our office to set this up for you.
- 4. Auto-pay through your bank account also known as bill pay if you use this method of payment currently, you need to change your payment setup to include the new mailing address (above) for payments. Your property address will be the account number for reference. If you already have bill pay set up, you will just need to update the mailing address and possibly account number with your bank.
- 5. Deliver your payment to our main office at the above address. There is a black drop-box outside of the "HOA" door where you can leave payments outside of our regular office hours.

Our main office hours are Monday through Friday 9:00 a.m. - 5:00 p.m. and Saturday & Sunday 9:00 a.m. - 6:00 p.m. Saturday & Sunday hours are for emergencies only, otherwise you can leave a message or email Melissa for Monday morning. Please call (904) 471-6606 with questions or concerns. Melissa is at extension 140. We also have an after-hours answering service that you can reach at the same number.
