

Reservation and Payment Terms:

- A first initial deposit along with reservation information is required to secure your booking.
- 2. Reservations must be made in your FULL NAME as it appears on your government-issued identification. Kapture the Globe LLC will not be responsible for incorrect information provided. Any name change fees incurred due to incorrect information will be the sole responsibility of the individual.
- 3. After making your deposit, you are required to make monthly payments to maintain your booking. Failure to do so may result in cancellation of your reservation, with all previous payments forfeited. If you face financial difficulties, you must email us at info@kapturetheglobe.com to avoid cancellation.
- 4. Reservations with no payments made after the first 60 days of booking will be canceled. It is your responsibility to ensure that your roommate, if any, is also making their monthly payments.
- 5. All payments to Kapture the Globe LLC are non-refundable and non-transferable due to contractual obligations with resorts, airlines, and other vendors. Ensure your commitment to attend the event before making a payment. No exceptions to final payment dates. Failure to make the final payment by the due date will result in automatic cancellation and forfeiture of all monies paid.

Passport and Visa Requirements:
