

Media Consent Form

I hereby grant to Morgan State University and DoDSTEM irrevocable permission to the following:

- to use my name, voice, image and likeness, in the form of video, photographs, and/or images that I have provided to Morgan State University and/or DoDSTEM, quotations or texts provided by me, biographical material acquired through interviews, questionnaires, and third-person testimonials (collectively “Materials”), for publication in reports, promotional, advertising, trade and/or curricular materials created in any format (including but not limited to web-based, print, and video). Furthermore, I understand this permission signifies that, among other uses, photographic or video recordings of me may be electronically displayed via the internet or in the public informational/educational setting.
- to license the Materials, in whole or in part, to others as Morgan State University and/or DoDSTEM deem appropriate.

The photography, audio and video recording will become the property of Morgan State University and/or DoDSTEM, stored in a place chosen by Morgan State University and/or DoDSTEM and will not be returned to me. In addition, I waive the right to inspect or approve the finished product, including written or electronic copy, wherein my likeness appears. I waive any right to royalties or other compensation arising or related to the use of the photography, audio and video recording.

I hereby agree to release, defend, and hold harmless Morgan State University and/or DoDSTEM and anyone working for them or on their behalf, and any sub-licensees, from and against any claims, damages or liability arising from or related to the use of the photographs, including but not limited to any misuse, distortion, blurring, alteration, optical illusion or use in composite form, either intentionally or otherwise, that may occur or be produced in taking, processing reduction or production of the finished product its publication or distribution.

I understand that Morgan State University’s and/or DoDSTEM’s use of the Materials does not grant me ownership rights in the Materials, or any works containing or based on the Materials. All the permissions, assignment, and releases that I grant shall be effective forever throughout the world and apply to Morgan State University and/or DoD STEM and their employees, volunteers, sub-licensees, and agents.
