# **Report from the Board**

#### TBM/NRTC Agreement

Final agreement signed with TBM for our court usage (with annual renewal) subject to review. It addresses facility usage and maintenance, terms, fees, cancellation, insurance and indemnification

#### Agreement for hours at Boyer and Bayview

The Town has approved additional NRTC hours at two other courts:

Boyer (101 Crossan Court): Tuesday and Thursday mornings

Bayview (60 Bay St East): Monday, Wednesday and Friday mornings

Court times at those locations are from 8am to noon and are bookable on Skedda. The Nipissing Ridge courts will remain the hub for our organized activities.

There was discussion concerning whether the courts could be used prior to 8:00 am and Terry Green confirmed that the earliest start time is 8am.

## Remarks from TBM – Terry Green

Terry thanked the board for their work and commented that NRTC is a well organized club. Highlights from Terry's remarks:

- Signage will be posted at Boyer and Bayview indicating NRTC times
- Terry will discuss with the TBM communications team if the change to court availability at Boyer and Bayview could be added to the TBM newsletter (The Review)
- Terry will speak with Marguerite (TBM) to determine if the NRTC bookings can be blocked off on the municipal booking system he will advise of outcome
- 8:00 am is the time the courts become bookable for Boyer and Bayview
- 6 additional parking spots have been added at Boyer
- Street construction near Bayview courts (on Mill Street) is occurring this summer -parking will be a bit more challenging park on Cottage Ave on grass
- TBM hopes to resurface Nipissing Ridge in 2026
- Courts will be opened as soon as possible (date to be determined) and NRTC will be advised

#### **Other Business**

Laurey commented on the report submitted by Ryan Gibbons, Director of Community Services to TBM Council on April 7<sup>th</sup>. The report proposed that TBM work with the Georgian Bay Racquet Initiative (GBRI) to identify properties for a 4-6 court indoor tennis facility and complete an initial feasibility assessment of potential locations and operating models. The proposal was approved and the report is to be submitted to the May 26<sup>th</sup> Committee of the Whole and June 2<sup>nd</sup> Council meetings.

Laurey noted that the NRTC Board has had correspondence with GBRI and has stated that we agree with the need for indoor tennis facilities but that the choice of location rests entirely with TBM. NRTC has neither the governance structure nor the capacity to assess the appropriateness of Nipissing Ridge as a location. She also noted that the proposed operating model would leave NRTC to continue as a seasonal club.

Laurey stated that volunteers are always needed and welcome. Sandee asked for help with the May 24<sup>th</sup> Social as well as one more volunteer for OSP. Please advise if you are able to help out in any way. Laurey asked for an IT volunteer and Kev Rostami offered to assist.
