

LIMITED-TIME AUGUST 2026 PROMOTION

Get Up to 6 Months of FREE Storage

A new-client promotion from Geshers Fulfillment designed to make the move to outsourced fulfillment easier for qualifying brands.

Offer at a Glance

Qualifying new clients who sign a minimum one-year agreement with Geshers Fulfillment by August 31, 2026, may receive free storage for up to 15 pallets for up to six consecutive promotional months. The promotion begins when the client's qualifying inventory first arrives at Geshers Fulfillment, but no later than October 1, 2026.

To remain eligible, the client's inventory must be actively fulfilled by Geshers Fulfillment, and the account must meet a minimum of 300 fulfilled orders per month. Storage above 15 pallets is billed at \$45 per pallet per month.

How to Qualify

1	Sign by Aug. 31	Execute a minimum 12-month service agreement and receive promotion approval.
2	Move inventory in	Inventory may arrive during September. The clock starts on arrival or October 1, whichever comes first.
3	Fulfill with Geshers	Geshers Fulfillment must actively fulfill the qualifying inventory.
4	Maintain 300+ orders	Meet at least 300 fulfilled orders each promotional month to receive that month's storage benefit.

Important: This promotion applies to qualifying warehouse storage charges only. Receiving, fulfillment, shipping/postage, packaging/materials, returns, special projects, prep/kitting and other agreed services remain billable from day one.

Maximum base storage value calculation: 15 pallets x \$45 per pallet per month x 6 months = \$4,050. Actual promotional value depends on the number of qualifying pallets stored and the number of months in which all eligibility requirements are satisfied.

Promotion Terms & Conditions

Effective for the August 2026 promotional campaign

These Promotion Terms & Conditions (the "Promotion Terms") govern the limited-time free-storage promotion offered by Geshers Fulfillment ("Geshers"). Participation is also subject to the client's separate fulfillment/service agreement with Geshers. If these Promotion Terms conflict with the service agreement regarding the promotional storage benefit, these Promotion Terms control only as to the promotion; all other services remain governed by the service agreement.

1. Promotion Period and Sign-Up Deadline

- A qualifying new client must enter into a minimum one-year (12-month) service agreement with Geshers no later than August 31, 2026.
- Signing by the deadline does not by itself guarantee participation. The account and inventory must also satisfy all eligibility requirements and be approved by Geshers.
- Clients may use September 2026 to transition inventory into the facility. The six-month promotional period begins on the date qualifying inventory first arrives at Geshers, or on October 1, 2026, whichever occurs first.

2. New-Client Eligibility

- The promotion is available only to new Geshers Fulfillment clients. Former or returning clients do not qualify as new clients for this offer.
- The client must use Geshers to actively fulfill the inventory receiving the promotional storage benefit. The offer is not available for stand-alone warehousing or passive storage.
- The client must maintain at least 300 fulfilled orders per month during the promotional period.
- The account must remain in good standing and comply with the signed service agreement and these Promotion Terms.

3. Free Storage Benefit

- For each month in which the client satisfies all requirements, Geshers will waive qualifying storage charges for the client's first 15 pallets.
- The standard storage rate used for this promotion is \$45 per pallet per month. Any storage above 15 pallets is billed at \$45 per pallet per month unless a different written rate applies outside this promotion.
- At the stated rate, the maximum base storage value of the six-month new-client promotion is \$4,050 (15 pallets x \$45 x 6 months). This is a maximum illustrative value, not a cash payment or guaranteed credit.
- The benefit has no cash value, is non-transferable and may only be applied to eligible storage charges on the qualifying account.

4. Monthly 300-Order Requirement

- Eligibility is measured monthly. A client must have at least 300 orders fulfilled by Geshers during the applicable promotional month to receive the free-storage benefit for that month.
- If the client does not meet the 300-order minimum for a promotional month, the client will be charged the applicable storage fees for that month, including storage otherwise covered by the promotion.
- Failure to qualify for a particular month does not extend or pause the six-month promotional clock. The promotional period continues to run from its original start date.

5. Services Not Included

- The promotion covers qualifying pallet storage charges only.
- The following remain billable at the client's standard or agreed-upon rates from day one: receiving, fulfillment/pick and pack, shipping and postage, packaging and materials, returns, special projects, prep and kitting, and other agreed services or charges.
- Nothing in this promotion changes carrier charges, postage costs, labor charges, material costs or other fees set out in the client's service agreement or approved pricing.

6. Inventory and Product Restrictions

- Hazardous items do not qualify for this promotion.
- Large or oversized items do not qualify. Products or individual items exceeding 5 pounds are not eligible for promotional storage.
- General temperature-controlled inventory that can be appropriately maintained within Geshers' air-conditioned facility may be considered, subject to Geshers' approval and operational requirements.
- Geshers may reject inventory that is unsuitable for the facility, requires special handling, creates safety or compliance concerns, or cannot reasonably be accommodated within available capacity.

7. Existing Client Referral Reward

- An existing Geshers client may earn 3 months of free storage for up to 15 pallets by referring a new client who qualifies for the program.
- The referral reward begins when the referred qualifying client's inventory is moved into Geshers and the referred client begins working with Geshers.
- The referred client must satisfy the applicable new-client criteria, including the one-year agreement, qualifying inventory, active fulfillment relationship and 300-order monthly minimum.
- Storage above 15 pallets for the referring existing client remains billable at the applicable storage rate.

8. New Client Referral Reward

- A new client participating in this promotion may earn one additional month of free storage, up to 15 pallets, for each qualifying referral.
- There is no stated limit on the number of additional months that may be earned, provided each referred business independently satisfies the promotion criteria, is approved by Geshers, moves qualifying inventory into Geshers and begins working with Geshers.
- A referral is considered earned only after the referred client's qualifying inventory has moved into the facility and the referred client has begun its fulfillment relationship with Geshers.
- Referral rewards have no cash value and cannot be transferred to another person or account.

9. Account Standing, Cancellation and Loss of Benefits

- Geshers may suspend, cancel or deny promotional benefits if the client has overdue invoices, violates the service agreement, terminates service or removes inventory early, fails to meet the monthly order requirement, provides inaccurate information, or otherwise fails to remain eligible.
- Cancellation or loss of promotional eligibility does not cancel amounts otherwise owed for fulfillment, receiving, shipping, packaging, storage, labor or other services.
- If a promotional benefit is lost for a month because the client does not meet the 300-order requirement, applicable storage charges may be invoiced for that month.

10. Approval and Warehouse Capacity

- All participation is subject to Geshers' approval.
- Geshers may approve or reject an applicant based on inventory type, product dimensions or weight, available warehouse capacity, operational requirements, safety or compliance considerations, account standing, expected order volume, or other legitimate business considerations.
- Signing an agreement before August 31 does not require Geshers to accept inventory that falls outside the program's eligibility requirements.

11. No Stacking or Combination With Other Promotions

- This promotion may not be combined with other promotions, storage discounts, promotional credits or negotiated promotional offers unless Geshers expressly agrees otherwise in writing.
- If multiple discounts could apply, Geshers may require the client to select the applicable offer.

12. Pallet Measurement and Billing

- The free-storage allowance applies to a maximum of 15 qualifying pallet positions during an eligible month.
- Any pallet positions beyond the promotional allowance are billable at the applicable rate. Geshers' warehouse and inventory records will be used to determine pallet quantities and storage usage for billing purposes.
- The promotion does not guarantee that Geshers will reserve 15 pallet positions for a client if the client's actual inventory requires fewer positions, nor does it guarantee additional capacity beyond approved inventory.

13. Changes, Availability and Interpretation

- The offer is limited in duration and subject to warehouse availability.
- Geshers reserves the right to interpret and administer these Promotion Terms in good faith, including determining whether inventory, referrals and accounts satisfy the stated criteria.
- Any exception, modification or special arrangement must be confirmed by Geshers in writing to be effective.

14. Relationship to Service Agreement

- These Promotion Terms do not replace the client's fulfillment/service agreement. The service agreement continues to govern operational services, payment obligations, liability, termination, shipping, inventory handling and other aspects of the relationship.
- The promotional storage waiver is a conditional benefit only and does not alter charges for services not expressly included in this promotion.

Promotion Summary: Sign a minimum one-year agreement by August 31, 2026; move qualifying inventory in by October 1, 2026; use Geshers for fulfillment; maintain at least 300 fulfilled orders per month; and remain in good standing to receive up to six months of qualifying storage for up to 15 pallets.
