♦ Tennis Courts

- The Board entertained 2 bids received for resurfacing the tennis courts.
- Southeastern came in 3K higher than their last estimate at 18K.
- Signature Tennis courts bid a little over 11K, with a discount the total is around 10K.
- Motion made to select Signature Tennis Courts for the tennis court resurfacing project. It was seconded and approved by unanimous vote. Kevin will be notified.
- Replacement comes with a warranty to cover existing cracks for 5 years.
- The wires on each light at the tennis court has been cut. Mark sent an email to ask the electrician to take a look at them and provide his recommendation when he comes to install the electricity for the flock camera.

♦ Financial Audit

- Additional research needed before erecting new stop signs at the intersection of Cedar Pass and Glade Bend. Twanesia has reached out to Mr. Valenzuela in Public Works and Mr. Sebastian our District 4 rep but hasn't received a definitive answer yet. She will forward their response once received. LaFaye will also research adding new stop signs.

Pressure Washing

- Pressure washing the caps on top of the brick columns and the top of the monument has not been done. Twanesia sent an email requesting an update on these two items.
- ☐ The Board voted to approve the 1st installation of invoice submitted by Weaver for the cleanup.

Fences

- □ We need to purchase supplies to repaint the fences at the entrances, and gazebo. Estimated material includes 2 5 gal buckets of white exterior paint and paint supplies.
- ☐ The Board voted to purchase paint and supplies for \$300 to touch up

the fences. The motion was seconded and approved by unanimous vote

- Shay sent a request to Kevin to remove the 3 poles at the main entrance. She is waiting for his response.
- We need to setup a meeting with Doug to discuss his duties. LaFaye will contact him to determine when he will be available to meet with us.
- Kendall was nominated to Chair the events committee. The motion was seconded and approved by unanimous vote.
- We will discuss committees at the next meeting. Members should come to the meeting with an idea of which committee they want to chair.
