From **April 1 to December 31** there is a pro-rated option. An additional fee of \$6.25 per month for an adult membership or \$10.42 per month for a family membership **PLUS** the membership fee for the next year. A new member may choose to pay the full fee for the remainder of the current year if they do not want to take advantage of the discounted fees.

Pro-rated adjusted fee schedule is as follows: **If joining anytime in the month of:**

April - \$106.25 for adult membership *or* \$168.75 for family membership (21 month total).

May - \$100.00 for adult membership *or* \$158.33 for family membership (20 month total).

June - \$93.75 for adult membership *or* \$147.92 for family membership (19 month total).

July - \$87.50 for adult membership *or* \$137.50 for family membership (18 month total).

August - \$81.25 for adult membership *or* \$127.08 for family membership (17 month total).

September - \$75.00 for adult membership *or* \$116.67 for family membership (16 month total).

October - \$68.75 for adult membership *or* \$106.25 for family membership (15 month total).

November - \$62.50 for adult membership *or* \$95.83 for family membership (14 month total).

December - \$56.25 for adult membership *or* \$85.42 for family membership (13 month total).

No discounts will be given for Juniors or Seniors as they are already at discounted pricing.

The application must be signed before it is processed. By signing and submitting this application the applicant agrees to adhere to and obey all of the current **Rules and Regulations** as set forth by the **Board of Directors** of the Hollidaysburg Consolidated Sportsmen's Assn. (HCSA) to include the **wearing of ear and eye protection** while at any location on HCSA property where firearms of any kind are in use.
