

# AUXILIARY APPLICATION FOR MEMBERSHIP

Applicants for membership must be the **Spouse, Parent, Sibling or Child** (Twenty-one years of age or over) of a current South Norwalk Boat Club, Incorporated member in good standing at the time of application. Proof of relationship may be required.\*

Applications for membership must be written in ink, signed by applicant and sponsoring SNBC Member in good standing, and accompanied by the Initiation Fee of Thirty Dollars (\$30.00), plus one year's dues of Forty Dollars (\$40.00). Total of Seventy Dollars (\$70.00) shall be presented to the Recording Secretary. Any present or former member of the South Norwalk Boat Club, Incorporated will not be allowed to apply for membership in its Auxiliary, nor shall any applicant who applied for membership into the South Norwalk Boat Club, Inc. be allowed to apply for membership into its Auxiliary.

Applicant, if accepted, will be notified by the Corresponding Secretary, and must appear within two (2) meetings of the date of the letter to take their Oath, or notify the Secretary, otherwise application will be rejected and money forfeited.

\*The Auxiliary shall not discriminate in matters of Race, Color, Creed, Gender or National Origin in the election of a member. No person shall be elected as a member of this Auxiliary who has been convicted of a morals charge. No person shall be elected as a member of this Auxiliary who has been convicted of a felony unless the matters are first referred to the Board. The Board shall investigate the seriousness of the crime, the time since the conviction and other relevant circumstances. The Board may either reject the application or by a two thirds (2/3) majority recommend the candidate to the floor as suitable for membership. The floor shall then vote on the candidate's application in accordance with its normal procedure.
