US Senate: Representative Elisa Slotkin: What Policies, if any, will you advance regarding reproductive health?

First, we need to codify the Roe standard into federal law. The biggest mistake we can make is thinking that overturning Roe was the end. It was only the beginning. Republicans across the country – in courtrooms, State Legislatures, and Congress – are targeting contraceptives, travel, abortion medication and even IVF. In Congress, I have defended a woman's right to have a family when and how she chooses, including working to protect access to contraception and IVF and blocking Republican attempts to limit access to

reproductive care among our service members. It's why I am proud to have earned the endorsement of groups like Planned Parenthood.

US House District 9; Clint St. Mosley: What recommendations, if any, would you propose to change United States Immigration Policy?

We need comprehensive immigration reform; the last time we passed meaningful legislation was back in the 1980s. We need to expand legal immigration and increase the static caps so that more people have a legal way to immigrant especially including high skill talent (H-1B visas) and entrepreneurs (start-up visas). We also need to ensure a path to legal status for those workers who are already here and have been contributing to a healthy society and economy. Lastly and most importantly we need to create a path for those who came as children to legal status (DREAMers).

Michigan House District 67; Anissa Buffin: What should Michigan do to provide an equitable, quality public education while addressing the teacher shortage?

Michigan needs to take a hard look at the public education funding in the state. It has been vulnerable and problematic for many years. Everyone deserves a quality public education. And that starts with quality teachers. We need to start reforming public education by first giving respect to teachers for the incredible work they do. They need to be paid appropriately and competitively. We also need to give them the skills and tools needed to face the numerous challenges head on with confidence and competence. Supporting the teachers who are doing the hard work is long overdue. (Submitted by Alex D.)

Did You Know? Primary Election Results 2024

- Approximately 2 million voters cast a ballot statewide.
- 75,500 voters cast a ballot at an in-person early voting site.
- 970,041 Michigan voters completed their absentee ballot and submitted it to the clerk for tabulation.

Election results are made official after the canvassing procedure in all 83 counties and the Board of State Canvassers certified the election on 8/26/24. (Michigan Secretary of State)

In Case You Missed It. The First Presidential Debate Recap:

If you weren't among the over 50 democrats able to make it to the debate watch party, or watch from the comfort of home, you missed Vice President Kamala Harris put on an absolute debate clinic. Before the debate, numerous podcasters and pundits prognosticated that Kamala Harris had a nigh impossible task before her: look strong and decisive while still appearing likable, introduce herself and her policies while not letting her opponent off the hook, defend the record of the Biden administration while presenting herself as a candidate of change and the future. She exceeded even that lengthy list of expectations, delivering a decisive moment in this race, extending a small lead nationally and in the battleground states in the latest polls.

Talking to family, friends or when out canvassing, here are some big takeaways from the debate to bring up to persuadable voters:

- 1. Kamala Harris has grown into her role, and she proved she can control a negotiating table with foreign leaders and adversaries. Nothing the former president could do shook her; she out-prepared, outwitted, and outclassed him for 67 million people to see.
- 2. In contrast, the former president has clearly lost a step. I hate to bring up a sore subject, but just as President' Biden's poor debate performance demonstrated time is undefeated; Donald is clearly older and less capable than in the past. He couldn't string a sentence or a coherent policy together and clearly was unable to prepare for the moment. Even 9 years after first running for president, when asked for his healthcare policy his response was

to repeal Obamacare, and to replace it he has "the concept of a plan".

- 3. Donald proved without a shadow of a doubt anyone in the world can manipulate him with ease, and that should concern everyone if he were to become president again. The Harris campaign has said for weeks she would get under Trump's skin at the debate. They told him what she was going to do, and he couldn't help himself but take every bait she threw in the water. It is very clear to anyone who watched he is more passionate about defending his crowd sizes than addressing our cost of living or even immigration.
- 4. They're eating the cats! If you haven't seen the aftermath yet, the former president shared an unsubstantiated conspiracy theory about legal Haitian immigrants in Ohio eating they're neighbor's pets, causing real fear and divisiveness, even bomb threats, in that community "because he saw it on TV". Lapeer County Convention to be Held 11/9/24 at 10 am

What is the County Convention? – It is the time and place for Lapeer County Democrats to elect members of the County Committee and Party Executive Board. These people will set policy and create a direction for our party for the next two years.

To vote at the County Convention or to hold office, one must be a member of both the Michigan Democratic Party (30 days prior to Convention) and the LCDP. (There is an exception to the 30 day rule for candidates for office and Precinct Delegate's; they can join up to the date of the convention.)

- The County Convention date and rules will be announced at the Sept. general meeting.
- Nominating interested people (and only people who have shown interest) happens at the October general meeting.

Take Action!

Your call to action to support elections and voting in Michigan.

Know and share the difference between poll watchers and

election challengers.

ELECTION CHALLENGER: A credentialed individual who has the right to challenge a person's qualifications to vote if the challenger has "good reason to believe" that the person is not qualified to vote in the precinct. This cannot include assumptions based upon race, sex, national origin, or religion.

POLL WATCHER: A person who wishes to observe but is not a qualified election challenger.

Must carry credentials issued by appointing authority.	Yes	No

Has the right to challenge a person's eligibility to vote.	Yes	No


