The Rule of Law is Leftist Now, Apparently

It's no secret to anyone that the courts have become very, very busy in Trump 2.0. There are currently over 100 active litigations against the administration, and likely many more will follow. I'm sure many of you, like us, have not been able to keep up with where they all stand due to the sheer volume of lawlessness. While the administration is still obeying court orders, the judicial branch is our strongest institutional bastion left against this authoritarian agenda. We have included a few higher profile cases to highlight where they stand at the time of this writing.

Khalil vs Joyce

On March 8th ICE arrested and detained a Mahmoud Khalil, a US green card holder, based on his role in the Gaza campus protests at Columbia University. He was NOT accused or charged of any crimes when he was detained. He was immediately sent to an ICE holding facility across the country in Louisiana, without a court hearing. The case has recently been moved from Louisiana to the District Court in New Jersey, with a hearing scheduled for April 8th

Washington vs Trump – birthright citizenship

On January 20th, the Trump administration decided to pretend the 14th Amendment to our Constitution was just a suggestion, and not law of the land. By executive order, Trump attempted to create broad exceptions to citizenship for persons born in the United States. This order was immediately challenged by state attorneys general and multiple other litigants. A nationwide injunction was filed by multiple district court judges. Currently, the appeals courts have denied removal of those injunctions, and the appeal for that action is up at the Supreme Court.

JGG vs Trump- illegal deportation to El Salvador

On March 16th, the Trump Administration deported a number of Venezuelan migrants to a horrific prison in El Salvador. This was done without any due process. A judge also instructed the administration to turn the planes around when it was discovered, and this order was ignored. The administration defended their actions by invoking the Alien Enemies Act, which was last used to justify imprisoning Japanese Americans in internment camps during WWII. It can only be invoked in wartime, which we clearly are not. Currently, the judge is investigating the violation of his order.

The Fight for our Right to Read Continues, Patterns Emerge

Over the last month, some of the newest Lapeer District Library (LDL) Board members, self-identified conservatives, have been speakers at the Lapeer County Tea Party and held forth during Library Board meetings and County Commissions meetings.

At the March meeting of the LDL Board, the Conservative Majority (let's call them CM) quickly, over the objections of LDL Board members Bill Marquardt and Perry Vale, fired Anne Seurynck of Foster Swift, widely considered to be the top Library law attorney in the state. In Ms.Seurynck's place, they retained local firm Rickard, Denney, Leichleiter, Childers and Bosch. (The Denney Group) Although the website of the Denney Group touts their expertise in Religious Freedom, Municipal Law and dog bites (among other things) they mention no expertise in Library Law.

At the same meeting, the CM introduced an amendment to the LDL Board Bylaws to add Pledge of Allegiance and Prayer to the meeting order. This change to library bylaws will be voted on at the April 17 LDL Board meeting.

Several patterns are beginning to emerge in messaging from the CM Board members:

• The CM say they are not book banners or burners. They just want to protect children by limiting the materials they can access in the library without parental involvement. (Distinction without a difference.)

- The CM says they want to protect vulnerable children who don't have responsible adults in their life from what the CM judges to be pornography. (This is important because "vulnerable" is a term used in Library Law to describe groups that may need protection from sexually explicit materials in the library.)
- The CM says children have access in the library to images that would be pornography if they were photographs instead of drawings (Misleading/inaccurate statement.)
- The CM says children are being sexualized, which leads to trafficking and sexual abuse of children. To fight this, they say the community must ensure children can't view images that are pornography, no matter where those images are housed in the library. (Again, pornographic materials aren't available in public libraries. And a few books are causing the sexualization of children?)
- The CM asks who are these people who wouldn't want to protect children? (Those damn liberals they're pedophiles and groomers!)
- "If the community knew about these books" they would never pass another library millage, says the CM. (Repeat this often enough and the community will never pass another millage.)
- And finally, the CM and Prosecutor John Miller have emphasized that dissenters must be respectful in their comments and they will only reply to respectful questions and comments. (Remind you of the reprimand on Zelenskyy by Trump et al in the Oval Office?)

Despite their protestations that there are "no plans to target specific books and pull them off the shelf," the CM very clearly has plans to target specific books and flag them or limit access to them. We are waiting for a requested list of the titles that are of concern to the CM, although books mentioned in their comments to date seem to be primarily those with LGBTQ+ themes.

In a bright spot for the fight against censorship, at the March 27 Lapeer County Board of Commissioners meetings, the Commissioners voted 5-2 to appoint Ms. Bonnie Lawrence to fill the vacant seat on the Library Board. (Commissioners Scott McMahan and Kevin Knisely voted for another self-identified Christian conservative.) Ms. Lawrence's term will end December 31, 2028. Although the CM will undoubtedly still work to bring censorship to our district library, this signals that the majority of County Commissioners feel the board requires balance and is leaning away from single focus applicants.

Understanding the CMs messaging is key to building a meaningful resistance to censorship in our libraries. Your presence at upcoming LDL Board meetings supports the LDL Trustees who are fighting censorship and sends a powerful message to the Conservative Majority as they attack our right to read.

Meetings are on the third Thursday of each month at 5:30 pm. The May meeting is held at the DeAngeli Library, all others are held at the Lapeer Center Building.

Additionally, you may be interested in following a newly formed community group, **Fight 4 the First Lapeer**. This is an anti-censorship, 1st Amendment group working to protect freedom to access information in our district library, and which will be building an effort to support the future Lapeer District Library millage requests. The Economic Boycotts Are Working and New Boycotts are Set to Begin!

Money is power and companies are learning the hard way that turning their backs on DEI policies and cozying up to the horrific initiatives of the current administration will result in angry American consumers taking their valuable dollars elsewhere.

Economic boycotts against categories such as fast food and gas and against companies like Target, Amazon, Nestle and others who have rolled back the diversity, equity and inclusion initiatives have been ongoing since February 2025 organized by grassroots organizations like the People's Union USA and spread across social media channels.

The impact has been significant. Target has experienced an 11% decline in sales and 5 million fewer customers while Costco, which has fought to maintain its DEI initiatives, has seen an increase of 7.7 million customers.

Below are the upcoming economic boycotts this spring. Voters are encouraged to shop instead at locally owned stores or to recycle; reuse or trade with others and the NAACP is recommending that people shop with Black-owned businesses and other brands that still have DEI programs.

UPCOMING ECONOMIC BOYCOTTS

• Walmart boycott from April 7th - April 14th and May 20th - 26th

• A 1-day general economic blackout, asking shoppers to avoid spending any money, including fast food and gasoline on April 18th

- General Mills boycott through April 21st
- 40 day "Target Fast" through April 17th and June 3rd 9th (targetfast.org)
- Amazon boycott from May 6th 12th
- McDonald's boycott from June 24th 30th

Fight Back with Simple Actions to Push against Trump's Agenda



The 5 Calls app is a simple yet dynamic tool that helps us make a difference by connecting users with elected officials so we can share our thoughts about important issues. It's very easy to use and designed to help you stay informed and take action on things that matter to us, especially at this time when changes are happening so quickly.

I used to feel unsure and even a little intimidated when considering calling a congressional office. I wasn't sure what to say or if my comments were having an impact. Then someone suggested 5 Calls in a Facebook post.

I learned that phone calls are the most effective way to make our opinions count. Emails and letters take time to process but phone calls are immediately logged by congressional staff. Regular call tally reports are shared with congress people so they definitely know when their constituents feel strongly about an issue! And the app makes it so easy that I can make three calls on my coffee break at work - and still have time for coffee! (Read more at 5calls.org.)

How It Works



When you open the app, it will show a list of current issues that you can call about. Each issue has a brief description and contact information for the people you need to call—in

Lapeer, for example, it lists Senator Gary Peters, Senator Elissa Slotkin, and Representative Lisa McClain.

The app provides you with a script, so you don't have to worry about what to say. Just follow the script, make the call, and let your voice be heard!

Easy to use: The app guides you step by step and provides scripts, so you don't need to memorize anything.

It makes a real impact: Each call helps influence decisions that affect your community.

Stay informed: It keeps you updated on important issues and makes it simple to take action.

Convenient: You can make calls from anywhere, any time, making it easy to participate in democracy.

It's a simple, powerful way to have your voice heard! Just open the app and choose the topic that's most important to you, and then follow the prompts!

How to find and download the 5 Calls app

For Android Users (Samsung, LG, Google Pixel, etc.):

- 1. Open the Google Play Store:
 - a. Look for a small icon on your phone that says "Play Store" (it looks like a colorful triangle).
 - b. Tap on it to open the app store.
- 2. Search for the 5 Calls App:
 - a. At the top of the Play Store, there is a search bar.
 - b. Tap on the search bar and type "5 Calls" using the on-screen keyboard.
 - c. Press the magnifying glass or "search" button.
- 3. Find the App:
 - a. You should see the 5 Calls app appear in the list. It has a logo with a phone and the number 5 on it.
 - b. Tap on the app name to open its page.
- 4. Download the App:
 - a. On the app page, there will be a button that says "Install" (it's usually green). Tap on that button.
 - b. Wait a few moments as the app gets downloaded and installed onto your phone. You may see a progress bar while it's downloading.
- 5. Open the App:
 - a. Once the app is downloaded, you will see the word "Open" on the same screen. Tap on "Open" to start using the app.
 - b. You can also find the app by looking for the 5 Calls icon in your apps list (the page where all your apps are displayed).

For iPhone Users (Apple Phones):

- 1. Open the App Store:
 - a. Look for an icon that says "App Store" (it's a blue icon with a white "A" made out of sticks).
 - b. Tap on it to open the App Store.

- 2. Search for the 5 Calls App:
 - a. At the bottom of the screen, you will see a magnifying glass or "Search" option. Tap on it.
 - b. In the search bar that appears at the top of the screen, type "5 Calls" and press the "Return" key or "Search."
- 3. Find the App:
 - a. The 5 Calls app should be listed in the search results. It has a logo with a phone and the number 5 on it.
 - b. Tap on the app name to open its page.
- 4. Download the App:
 - a. On the app's page, you will see a cloud icon with an arrow or a button that says "Get" (it's usually blue).
 - b. Tap on "Get" and it will start downloading. You may need to confirm the download by entering your Apple ID password or using Face/Touch ID.
- 5. Open the App:
 - a. Once the app finishes downloading, you can tap on "Open" to start using it immediately.
 - b. Alternatively, you can find the app on your home screen and tap the icon to open it.

Backlash Starting – Let's Contribute!

Most Presidents – the normal ones in our past – enjoy a honeymoon after entering office that lasts a few months until actions from the White House start to irritate, annoy or disturb his supporters and those in the middle of the spectrum.

Less than 15 days from the Inauguration, 1,200 people gathered – mostly Republicans but many independents and some Dems – at the "Principles First" conference to start planning responses to the monstrous first proclamations from this President and co-President Musk.

Around the country, people began reacting to the inane, insane and completely bonkers nonsense this President is and has been spouting; Canada as a 51st state; Greenland invasion; Panama Canal takeover – and then the draconian slashing of jobs, imposing tariffs (on our friends!), and deportation of long resident persons that followed.

The backlash has been substantial and severe – particularly in the Republican heartland where the dependence on Medicaid, crop sales, education funding and belief in honest government runs the highest. Republican members of Congress are afraid to hold town hall meetings or meet those who voted for them. Farmers who voted for this President are preparing bankruptcy petitions while hiding from neighbors and friends the severity of the trouble.

A Missouri farmer, and Trump voter, has paid \$4,250 more in fertilizer and supply costs already this spring and will pay \$13,250 more in three annual cycles because of Canadian tariffs, a total hit of \$18,500 which eliminates his profit for the year on several products while prices for his corn, wheat and soybeans tank from demand diverted to other countries and tariffs completely eliminated his \$85,000 market for wood from his walnut trees.

Teachers across the South are in a panic because, of course, the largest percentage of Education Department funds are dispersed in the 5 southern states, the same states where recipients of Medicaid payments run as high as 1/3 of the populations.

In Kansas, 900 people attended a town hall meeting with their Republican Congressman and stared at an empty stage when he refused to face the people who elected him.

And there is so much more it's impossible to list all the people – many supporters of this President – who are going to suffer the most from his slash and crash policies of destruction.

So what's to be done? We are – temporarily – shut out of the House and Senate. Our ability to respond is limited except it's not.

First, we remember at all times – this past election was a 2% election. This President won by the slimmest of margins and the voters represented in that sliver are among those about to suffer the most.

Second, we craft an EFFECTIVE message of economic renewal. We work alongside our appointed and elected representatives, our local, county and state Democratic leadership to design a program that cares about the lower income, under-employed and those saving to buy a home and build a family. That's where the election was lost and where the next one must be won.

Finally, we use the power of our voice and our pen. Our voice includes social media – Facebook and all the other methods for sharing opinions are critical outlets that reach the younger voters to remind them that better choices exist and we can make them. Point out, gently perhaps, the promises made by this President are proving to be lies and the pain he dishes out so easily is not shared by his Republican buddies.

Letters to the Editors of all our papers are a crucial link to others of the like mind. The County Press, Flint Journal, Detroit Free Press and News are key outlets to remind the independent voters of the chaos being inflicted on our citizens. National papers, as well, are receptive to "voices from the hinterlands".

Where there are rallies, be in attendance. Where there are meetings, participate. Where there are people, talk and listen. We will not win by yelling – we will win by being good neighbors, good friends and sympathetic alternatives to the scorched earth policies being visited upon us.

Then, as they say, rinse and repeat. Do it over and over again. We have two years to drive home the message to our 2% neighbors that this Congress is not their friend. Let's do it.

As I was carrying an anti-Trump sign at an outdoor event, a person driving by screamed at us, "majority rule!" If they were trying to say most of the country doesn't agree with me, I think they are very wrong.
