Now is the Time to Apply for Home Heating Credit

The deadline for applying for the Home Heating Credit is September 30. This credit helps renters (with a contracted lease) and homeowners lower their heating costs before winter. You must meet the income requirements. Residents can connect with their local free tax preparation site by calling 211 or visiting MichiganFreeTaxHelp.org. To get free help you must have an income less than \$67,000, a disability or limited English-speaking ability.

WASHINGTON, D.C. – U.S. Senator Elissa Slotkin (D-MI) released the following statement after voting 'no' on President Donald Trump's "One Big Beautiful Bill," which passed by a vote of 51-50, with Vice President J.D. Vance breaking the tie.

"After more than 25 hours on the Senate floor, I voted no on the so-called 'One Big Beautiful Bill.' No matter which way you slice it – health care, energy, housing – the President just rammed through a bill that will make Michiganders pay in every part of their lives. All so the wealthiest among us can get a tax break.

"Today's massive bill will go through only with a tie breaker. Senate Democrats importantly delayed the process enough to allow the world to see this bill and to lay bare the fighting and divisions on the other side. "History will not be kind to this bill."

Lapeer County Commissioner Steps In It

They're Killing the Dogs...They're Killing the Cats...in Lapeer!?!

When Trump stood on the debate stage during the 2024 campaign to declare that Haitian immigrants were eating the pets of the people of Springfield, he was rightfully ridiculed. The claims were so easily debunked; they seemed potentially part of a pattern of mental decline. In reality, his cynical campaign had stumbled on a universal truth to exploit - nothing makes people angrier than the thought of someone harming an innocent animal.

From cartoon socialites stalking Dalmatians, to foolish gangsters provoking John Wick, Hollywood always makes it easy to spot the villain. In reality, even our biggest enemies are not usually so callously cruel. Democrats and Republicans can thankfully still agree that our animal companions should be treasured and protected. With this in mind, Lapeer County Commissioner Scott McMahan's recent idea that local Animal Shelter be converted to a 30-day kill facility, was a head-scratching suggestion.

Michigan is currently a "no kill" State, long a leader in the ethical treatment of animals. Euthanizing animals for budgetary reasons has largely been unnecessary and immensely unpopular. Converting to a kill shelter is completely out-of-step with the values of the community. And, in a scene straight out of a studio script, the community responded pushed back at the July 24 Board of Commissioners meeting. Public comment periods

featured overflow crowds, where citizen after citizen voiced opposition to the plan, many in utter disbelief at the very notion.

Though McMahan was quick to retreat from the urgency of his proposal, he did not rule out revisiting the concept down the road. The Commissioner's choice to stubbornly cling to his inhumane idea becomes easier to understand in the context of the broader campaign of cruelty the GOP has unleased. Those who see fit to lock immigrants in kennels and children in cages might more effortlessly see animals as expendable.

If connections to Commission-endorsed ICE activities seem a far-fetched, recall that United States Secretary of Homeland Security Kristi Noem proudly revealed that she shot her puppy, Cricket, in the face for "having the time of his life," instead of hunting. She shared this sad tale in her autobiography, accurately believing that it would win fans and raise her stature within the Grand Old Party.

It is possible that Mr. McMahan hopes to make a name for himself through his outlandish statements as well. By the reaction of his constituents on July 24, he might have thought it was "Mud." It is obvious that the vast majority of community members want Lapeer to be a leader in the humane treatment of animals. We must also insist that the United States continue to set global standards on issues of human rights, rather than prey on the most vulnerable.
