No data to sense check valuations, what a good term sheet looks like, etc.





The Community

Everyone gets access to our community with our programmes.

You'll have a community of just founders, as well as a fully integrated community where you can interact with community members from ecosystem type companies (we'll vet them so you don't get spammed to death).

This means you'll have a peer network wherever you are or whenever you're online to share your successes, challenges and frustrations with.

You'll also be able to talk to real investors and get insights (but don't bug them to invest)....we have a programme for that.



How do I get investment?

Startups that have been through our Founderversity programme will be able to submit their deck to investors within our database of 7500 based on a success fee of 5% of the amount raised.

Some will be specially selected for our Super Accelerator after graduation.

You'll be invited onto the programme where you'll be offered up front investment on fair terms, with a short, intensive programme focused on giving you the connections and templates you need to scale and own your market.

Please note that the accelerator will only be open to companies with a huge market potential, opportunity, great product and team.
