## General Conditions of Probation

The defendant, having been granted the privilege of serving all or part of his/her sentence on probation, defendant is hereby sentenced to the following general conditions of probation:

- ☒ 1. Do not violate the criminal laws of any governmental unit.
- ☒ 2. Avoid injurious and vicious habits – especially the presence or consumption of alcohol, narcotics and other dangerous drugs unless prescribed lawfully.
- ☒ 3. Avoid persons or places of disreputable or harmful character.
- ☒ 4. Report to the Probation Supervisor as directed and permit such supervisor to visit him/her at home or elsewhere.
- ☒ 5. Work faithfully at suitable employment insofar as may be possible.
- ☒ 6. Do not change his/her present place of abode, move outside the jurisdiction of the Court, or leave the State for any period of time without prior permission of the Probation Supervisor.
- ☒ 7. Support his/her legal dependents to the best of his/her ability.
- ☒ 8. Be subject to random alcohol and drug screening.
- ☒ 9. Fourth Amendment rights waived. Probationer shall submit to search of his/her person, residence, papers, and/or effects at any time without a search warrant whenever requested to do so by a Probation Supervisor or any other law enforcement officer and specifically consents to the use of anything seized as evidence in any judicial proceeding or trial.
- ☒ 10. Pay court ordered fines and fees as directed. *Pay online via your direct text pay link (surcharges apply) or Money Order (made out to "NJC Probation" & print your name).*

## Special Conditions That May Be Ordered

- ☐ 11. Probation may terminate upon successful completion of all conditions and the recommendation of the Probation Supervisor.
- ☐ 12. Probationer will attend, complete, participate in, and pay for the following:
