§ 10.01 SHORT TITLES.

(A) All ordinances of a permanent and general nature of the municipality as revised, codified, rearranged, renumbered, and consolidated into component codes, titles, chapters, and sections shall be known and designated as the Whitmire Town Code, for which designation "codified ordinances" or "code" may be substituted.

(B) All references to codes, titles, chapters, and sections are to such components of the code unless otherwise specified. Any component code may be referred to and cited by its name, such as the "traffic code". Sections may be referred to and cited by the designation "§" followed by the number, such as "§ 10.01".

§ 10.02 INTERPRETATION.

Unless otherwise provided herein, or by law or implication required, the same rules of construction, definition, and application shall govern the interpretation of this code as those governing the interpretation of state law.

§ 10.03 APPLICATION TO FUTURE ORDINANCES.

All provisions of Title I compatible with future legislation shall apply to ordinances hereafter adopted amending or supplementing this code unless otherwise specifically provided.

§ 10.04 CAPTIONS.

Headings and captions used in this code other than the title, chapter, and section numbers are employed for reference purposes only and shall not be deemed a part of the text of any section.

§ 10.05 DEFINITIONS.

For the purpose of this code of ordinances, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

COUNCIL or TOWN COUNCIL. The Council of the Town of Whitmire, South Carolina.

COUNTY, THE COUNTY, or THIS COUNTY. The County of Newberry, South Carolina.

GENDER. A word importing the masculine gender only shall extend and be applied to females and to firms, partnerships, and corporations as well as to males.

GOVERNOR. The Governor of South Carolina.

IN THE TOWN. Includes any territory, jurisdiction of which, for the exercise of its regulatory power, has been conferred on the town by public or private law.

MAY. The act referred to is permissive.

MAYOR. The Mayor of the Town of Whitmire, South Carolina.

MONTH. A calendar month.

NUMBER. Words used in the singular include the plural, and the plural includes the singular.

OATH, *SWEAR*, or *SWORN*. Includes an affirmation in all cases in which, by law, an affirmation may be substituted for an oath, and in such cases the words *SWEAR* and *SWORN* shall be equivalent to the words *AFFIRM* and *AFFIRMED*.

OFFICERS AND OFFICIALS OF TOWN. Whenever reference is made to officials, boards, commissions, departments, and the like by title only (e.g., Town Clerk/Treasurer, Chief of the Fire Department, and the like), they shall be deemed to refer to the officials, boards, commissions, and departments of the Town of Whitmire.

OWNER. Applied to any property, shall include any part owner, joint owner, tenant in common, joint tenant, or tenant by the entirety, of the whole or a part of such property.

PERSON. Extends and applies to firms, partnerships, associations, organizations, and bodies politic and corporate, or any combination thereof, as well as to individuals.

PERSONAL PROPERTY. Includes money, goods, chattels, things in action, and evidences of debt.

PRECEDING; **FOLLOWING**. Next before and next after, respectively.

PROPERTY. Includes both real and personal property.

REAL PROPERTY; REAL ESTATE. Coextensive with lands, tenements, and hereditaments.

SHALL. The act referred to is mandatory.

SIDEWALK. A strip of land in front or on the side of a lot of land lying between the property line and the street.

SIGNATURE; SUBSCRIPTION. Include a mark when the person cannot write.

STATE, THE STATE, or THIS STATE. The State of South Carolina.

- *STATE REFERENCES.* Whenever reference is made to a title or section of the S.C. Code, it shall be construed to refer to the Code of Laws of South Carolina, 1976, as the same may have been amended, or whatever section is to be cited.
- **STREET.** Embraces streets, avenues, boulevards, roads, alleys, lanes, viaducts, and all other public highways in the town.
- **TENANT**; **OCCUPANT**. Applied to a building or land, shall include any person who occupies the whole or a part of such building or land, whether alone or with others.
 - **TENSE.** Words used in the present tense include the future as well as the present.

TOWN, THE TOWN, or THIS TOWN. The Town of Whitmire, South Carolina.

WRITTEN; IN WRITING. Include any representation of words, letters, or figures, whether by printing or otherwise.

YEAR. A calendar year. (1974 Code, § 1-2)

§ 10.06 RULES OF CONSTRUCTION.

- (A) *Generally*. Words and phrases shall be read in context and construed according to the rules of grammar and common usage. Words and phrases that have acquired a technical or particular meaning, whether by legislative definition or otherwise, shall be construed accordingly.
 - (B) *Number*; gender; time. As used in the code, unless the context otherwise requires:
 - (1) The singular includes the plural, and the plural includes the singular;
 - (2) Words of one gender include the other genders; and
 - (3) Words in the present tense include the future.
 - (C) Calendar; computation of time.
- (1) The time within which an act is to be done shall be computed by excluding the first day and including the last. If the last day be Sunday, it shall be excluded.
- (2) In all cases where the law requires any act to be done in a reasonable time or reasonable notice to be given, such *REASONABLE TIME OR NOTICE* shall mean the time as only may be necessary for the prompt performance of such duty or compliance with such notice.

- (D) *Authority*. When the law requires an act to be done, which may by law as well be done by an agent as by the principal, such requirement shall be construed to include such acts when done by an authorized agent.
- (E) *Joint authority*. All words purporting to give joint authority to three or more municipal officers, or to other persons, shall be construed as giving such authority to a majority of the officers or other persons, unless it is otherwise expressly declared in the law giving the authority or inconsistent with state statute or other provisions.
- (F) *Exceptions*. The rules of construction shall not apply to any law which contains any express provision excluding such construction, or when the subject matter or context of such law may be repugnant thereto.

§ 10.07 CONSTRUCTION OF REVISED ORDINANCES.

The provisions of this code, so far as they are consistent with any prior ordinances, shall be construed as continuations of the prior provisions and not as new enactments.

§ 10.08 CONFLICTING PROVISIONS.

If the provisions of different codes, chapters, or sections of the codified ordinances conflict with or contravene each other, the provisions bearing the latest passage date shall prevail. If the conflicting provisions bear the same passage date, the conflict shall be construed so as to be consistent with the meaning or legal effect of the subject matter taken as a whole.

§ 10.09 SEVERABILITY.

If any provision of a section of these codified ordinances or the application thereof to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of the section or related sections which can be given effect without the invalid provision or application, and to this end the provisions are severable.

§ 10.10 REFERENCE TO OTHER SECTIONS.

(A) Wherever in a penalty section reference is made to a violation of a section or an inclusive group of sections, such reference shall be construed to mean a violation of any provision of the section or sections included in such reference.

- (B) References in the code to action taken or authorized under designated sections of the code include, in every case, action taken or authorized under the applicable legislative provision which is superseded by this code.
- (C) Whenever in one section reference is made to another section hereof, such reference shall extend and apply to the section referred to as subsequently amended, revised, recodified, or renumbered, unless the subject matter be changed or materially altered by the amendment or revision.

§ 10.11 REFERENCE TO OFFICES.

Reference to a public office or officer shall be deemed to apply to any office, officer, or employee of the town exercising the powers, duties, or functions contemplated in the provision, irrespective of any transfer of functions or change in the official title of the functionary.

§ 10.12 ERRORS AND OMISSIONS.

If a manifest error is discovered, consisting of the misspelling of any words; the omission of any word or words necessary to express the intention of the provisions affected; the use of a word or words to which no meaning can be attached; or the use of a word or words when another word or words was clearly intended to express such intent, such spelling shall be corrected and such word or words supplied, omitted, or substituted as will conform with the manifest intention, and the provisions shall have the same effect as though the correct words were contained in the text as originally published. No alteration shall be made or permitted if any question exists regarding the nature or extent of such error.

§ 10.13 OFFICIAL TIME.

The official time, as established by applicable state/federal laws, shall be the official time within this municipality for the transaction of all municipal business.

§ 10.14 ORDINANCES REPEALED.

This code, from and after its effective date, shall contain all of the provisions of a general nature pertaining to the subjects herein enumerated and embraced. All prior ordinances pertaining to the subjects treated by this code shall be deemed repealed, from and after the effective date of this code.

§ 10.15 ORDINANCES UNAFFECTED.

All ordinances of a temporary or special nature, and all other existing ordinances pertaining to subjects not enumerated and embraced in this code, shall remain in full force and effect unless herein repealed expressly or by necessary implication.

§ 10.16 ORDINANCES SAVED.

Whenever an ordinance by its nature either authorizes or enables the legislative body, or a certain municipal officer or employee, to make additional ordinances or regulations for the purpose of carrying out the intent of the ordinance, all ordinances and regulations of a similar nature serving such purpose effected prior to the codification, and not inconsistent thereto, shall remain in effect and are saved.

§ 10.17 EFFECTIVE DATE OF ORDINANCES.

All ordinances passed by the legislative body requiring publication shall take effect from and after the due publication thereof, unless otherwise expressly provided. Ordinances not requiring publication shall take effect from their passage, unless otherwise expressly provided.

§ 10.18 REPEAL OR MODIFICATION OF ORDINANCES.

- (A) The repeal of an ordinance, or its expiration by virtue of any provision contained therein, shall not affect any right accrued, any offense committed, any penalty or punishment incurred, or any proceeding commenced before the repeal took effect or the ordinance expired.
- (B) When an ordinance which repealed another shall itself be repealed, the previous ordinance shall not be revived without express words to that effect.

§ 10.19 AMENDMENTS TO CODE; EFFECT OF NEW ORDINANCES; AMENDATORY LANGUAGE.

- (A) All ordinances passed subsequent to this code which amend, repeal, or in any way affect this code may be numbered in accordance with the numbering system of this code and printed or typed for inclusion herein. In the case of repealed chapters, sections, or divisions or any part thereof by a subsequent ordinance, such repealed portions may be excluded from the code by omission from reprinted or retyped pages affected thereby. The subsequent ordinances, as numbered and printed or typed, or omitted, in the case of repeal, shall be prima facie evidence of such subsequent ordinances until such time that this code and subsequent ordinances numbered or omitted are re-adopted as a new code by the Town Council.
- (B) Amendments to any of the provisions of this code shall be made by amending such provisions by specific reference to the section number of this code in the following language:

"That section _____ of the Code of the Town of Whitmire, South Carolina, is hereby amended to read as follows:" (The new provisions shall then be set out in full.)

(C) In the event a new section not heretofore existing in the code is to be added, the following language shall be used:

"That the Code of the Town of Whitmire, South Carolina, is hereby amended by adding a section (or chapter or division) to be numbered _____, which section (or chapter or division) reads as follows:" (The new provisions shall then be set out in full.)

(D) All chapters, sections, divisions, or provisions desired to be repealed shall be specifically repealed by chapter, section, or division number, as the case may be. (1974 Code, § 1-6)

§ 10.20 SECTION HISTORIES; STATUTORY REFERENCES.

- (A) As histories for the code sections, the specific number and passage date of the original ordinance, and amending ordinances, if any, are listed following the text of the code section. Example: (Ord. 10, passed 5-13-1960; Ord. 15, passed 1-1-1970; Ord. 20, passed 1-1-1980; Ord. 25, passed 1-1-1985)
- (B) (1) If a statutory cite is included in the history, this indicates that the text of the section reads substantially the same as the statute.

Example: (S.C. Code § 16-11-700) (Ord. 10, passed 1-17-1980; Ord. 20, passed 1-1-1985)

(2) If a statutory cite is set forth as a "statutory reference" following the text of the section, this indicates that the reader should refer to that statute for further information. Example:

§ 39.01 PUBLIC RECORDS AVAILABLE.

This municipality shall make available to any person for inspection or copying all public records, unless otherwise exempted by state law.

§ 10.21 VIOLATIONS OF RULES, REGULATIONS, AND ORDERS.

Except as otherwise provided in this code, the violation of any rules, regulations, or orders promulgated by any officer or agency of the municipality under authority vested in him, her, or it by law, by the provisions of this code, or by any ordinance or resolution shall be unlawful.

§ 10.22 LIABILITY OF CORPORATIONS AND AGENTS FOR VIOLATIONS.

- (A) Any violation of this code by any officer, agent, or other person acting for, or employed by, any corporation or unincorporated association or organization while acting within the scope of his or her office or employment, shall in every case also be deemed to be a violation by such corporation, association, or organization.
- (B) Any officer, agent, or other person acting for, or employed by, any corporation or unincorporated association or organization shall be subject and liable to punishment as well as such corporation or unincorporated association or organization for the violation by it of any provision of this code, where such violation was the act or omission, or the result of the act, omission, or order, of any such person.

§ 10.99 PENALTY.

- (A) Whenever in this code or in any ordinance or resolution of the Town Council; or in any rule, regulation, or order promulgated by any officer or agency of the town under authority duly vested in him or her; or if any act is prohibited or is made or declared to be unlawful for an offense or misdemeanor, or the doing of any act is required, or the failure to do any act is declared to be unlawful or an offense or a misdemeanor, where no specific penalty is provided therefore, the violation of any such provision of this code or any such ordinance, resolution, rule, regulation, or order shall be punished by a fine of not more than \$500 or imprisonment for 30 days, or both.
- (B) In addition, a municipal judge may order restitution in an amount not to exceed \$7,500. In determining the amount of restitution, the judge shall determine and itemize the actual amount of damage or loss in the order. In addition, the judge may set an appropriate payment schedule. Additionally, a municipal judge may hold a party in contempt for failure to pay the restitution ordered if the judge finds the party has the ability to pay.
- (C) Each day any violation of any provision of this code or any such ordinance, resolution, rule, regulation, or order shall continue shall constitute a separate offense. In addition to the penalties hereinabove provided, any condition caused or permitted to exist in violation of any of the provisions of this code or any such ordinance, resolution, rule, regulation, or order shall be deemed a public nuisance and may be abated by the town as provided by law, and each day that such condition continues shall be regarded as a new and separate offense.
- (D) The penalties and punishments referred to above are the penalties and punishments for violation of all provisions contained in this code and for the violation of all amended ordinances or any new ordinances which may be legally enacted by the Town Council, unless otherwise specifically provided.

§ 11.02 TOWN SEAL.

The seal of the town shall be as follows: within the first or outer circle is engraved "Town Council, Town of Whitmire, South Carolina". In the inner or center circle, a Palmetto tree. Such seal shall be the common seal of the town. The Town Clerk/Treasurer shall have the custody of the seal of the town, and the same shall be kept by him or her in his or her office. No alteration shall be made or permitted if any question exists regarding the nature or extent of such error.

§ 10.13 OFFICIAL TIME.

The official time, as established by applicable state/federal laws, shall be the official time within this municipality for the transaction of all municipal business.

§ 10.14 ORDINANCES REPEALED.

This code, from and after its effective date, shall contain all of the provisions of a general nature pertaining to the subjects herein enumerated and embraced. All prior ordinances pertaining to the subjects treated by this code shall be deemed repealed, from and after the effective date of this code.

§ 10.15 ORDINANCES UNAFFECTED.

All ordinances of a temporary or special nature, and all other existing ordinances pertaining to subjects not enumerated and embraced in this code, shall remain in full force and effect unless herein repealed expressly or by necessary implication.

§ 10.16 ORDINANCES SAVED.

Whenever an ordinance by its nature either authorizes or enables the legislative body, or a certain municipal officer or employee, to make additional ordinances or regulations for the purpose of carrying out the intent of the ordinance, all ordinances and regulations of a similar nature serving such purpose effected prior to the codification, and not inconsistent thereto, shall remain in effect and are saved.

§ 10.17 EFFECTIVE DATE OF ORDINANCES.

All ordinances passed by the legislative body requiring publication shall take effect from and after the due publication thereof, unless otherwise expressly provided. Ordinances not requiring publication shall take effect from their passage, unless otherwise expressly provided.

(C) In the event a new section not heretofore existing in the code is to be added, the following language shall be used:

"That the Code of the Town of Whitmire, South Carolina, is hereby amended by adding a section (or chapter or division) to be numbered _____, which section (or chapter or division) reads as follows:" (The new provisions shall then be set out in full.)

GENDER. A word importing the masculine gender only shall extend and be applied to females and to firms, partnerships, and corporations as well as to males.

GOVERNOR. The Governor of South Carolina.

IN THE TOWN. Includes any territory, jurisdiction of which, for the exercise of its regulatory power, has been conferred on the town by public or private law.

MAY. The act referred to is permissive.

MAYOR. The Mayor of the Town of Whitmire, South Carolina.

MONTH. A calendar month.

NUMBER. Words used in the singular include the plural, and the plural includes the singular.

OATH, *SWEAR*, or *SWORN*. Includes an affirmation in all cases in which, by law, an affirmation may be substituted for an oath, and in such cases the words *SWEAR* and *SWORN* shall be equivalent to the words *AFFIRM* and *AFFIRMED*.

OFFICERS AND OFFICIALS OF TOWN. Whenever reference is made to officials, boards, commissions, departments, and the like by title only (e.g., Town Clerk/Treasurer, Chief of the Fire Department, and the like), they shall be deemed to refer to the officials, boards, commissions, and departments of the Town of Whitmire.

OWNER. Applied to any property, shall include any part owner, joint owner, tenant in common, joint tenant, or tenant by the entirety, of the whole or a part of such property.

PERSON. Extends and applies to firms, partnerships, associations, organizations, and bodies politic and corporate, or any combination thereof, as well as to individuals.

PERSONAL PROPERTY. Includes money, goods, chattels, things in action, and evidences of debt.

PRECEDING; **FOLLOWING**. Next before and next after, respectively.

PROPERTY. Includes both real and personal property.

REAL PROPERTY; REAL ESTATE. Coextensive with lands, tenements, and hereditaments.

SHALL. The act referred to is mandatory.

SIDEWALK. A strip of land in front or on the side of a lot of land lying between the property line and the street.

SIGNATURE; SUBSCRIPTION. Include a mark when the person cannot write.

STATE, THE STATE, or THIS STATE. The State of South Carolina.

- *STATE REFERENCES.* Whenever reference is made to a title or section of the S.C. Code, it shall be construed to refer to the Code of Laws of South Carolina, 1976, as the same may have been amended, or whatever section is to be cited.

§ 11.02 TOWN SEAL.

The seal of the town shall be as follows: within the first or outer circle is engraved "Town Council, Town of Whitmire, South Carolina". In the inner or center circle, a Palmetto tree. Such seal shall be the common seal of the town. The Town Clerk/Treasurer shall have the custody of the seal of the town, and the same shall be kept by him or her in his or her office. § 70.01 REMOVAL OR SCREENING OF UNUSED VEHICLES.

- (A) It shall be unlawful for any person in the town to cause or allow any vehicle, or part thereof, which is not in regular use to be parked, stored, junked, or left in sight of any public street or alley.
- (B) Anyone having such a vehicle, or part thereof, shall cause the same to be moved out of sight of such public street or alley or erect, at the property owner's expense, a properly constructed and designed solid fence, whereby such vehicle, or part thereof, cannot be seen from any public street or alley. Such fence must meet the approval of the Mayor and Town Council.
- (C) Vehicles being held for repairs on the premises of a licensed garage or body shop shall not be deemed a violation of this section.

§ 70.02 ADOPTION OF STATE LAWS.

(A) All the provisions and requirements of the general laws of the state in regard to vehicles, traffic, and pedestrians as contained in the South Carolina Code of 1962 and acts amendatory thereof, insofar as such provisions can be applied within the town, are hereby adopted and made a part of this chapter as fully as though set out herein.

- (B) All provisions and requirements of the Uniform Act Regarding Traffic on the Highways, as amended, insofar as such provisions can have application within the town, are hereby adopted and made a part of this chapter as though fully set out herein.
- (C) It shall be unlawful for any person to fail to comply with the provisions of the acts and code referred to above, and this section shall be cited for violation of any of the provisions applicable to the town.

§ 70.03 TOWN COUNCIL TO REGULATE TRAFFIC.

- (A) The Town Council shall regulate the operation and parking of vehicles within the town by the erection or placing of proper signs or markers indicating prohibited or limited parking, restricted speed areas, one-way streets, play streets, through or arterial streets, parking meter spaces and parking meter zones, u-turns, school zones, hospital zones, loading or unloading zones, quiet zones, and other signs, markers, and official traffic control devices indicating the place or manner of operating or parking vehicles within the town.
- (B) The Council shall designate bus stops and taxicab stands and erect signs prohibiting the parking of vehicles other than buses and taxicabs at their respective stops and stands.
- (C) The Council shall designate truck routes and regulate the parking of vehicles of various sizes and weights.
- (D) The Council shall mark off traffic lanes on streets and parts of streets indicating and directing the flow of traffic when, in the judgment of the Council, such action is necessary.
- (E) The Council shall secure all necessary signs, markers, or official traffic control devices to be erected or placed on any street, or part of a street, when such action is deemed necessary.
- (F) The existence of such signs, markers, or of official traffic control devices at any place within the town shall be prima facie evidence that such signs, markers, or official traffic control devices were erected or placed by, and at the direction of, the Council and in accordance with the provisions of this chapter.

§ 70.04 USE OF ENGINE BRAKE, COMPRESSION BRAKE, OR MECHANICAL EXHAUST DEVICE.

- (A) Except in an emergency situation, it shall be unlawful for the driver of any vehicle to use or operate, or cause to be used or operated, within the corporate limits of the town, any engine brake, compression brake, or mechanical exhaust device designed to aid in the braking or deceleration of any vehicle that results in excessive, loud, unusual, or explosive noise from such vehicle.
- (B) The term *EMERGENCY SITUATION*, for the purpose of this section, shall mean one in which there is imminent danger of collision with property, person, or animals. (Ord. 2010-28, passed 12-13-2010) Penalty, see § 70.99

§ 70.99 PENALTY.

- (A) Any person violating any provision of this chapter for which no specific penalty is prescribed shall be subject to § 10.99 of this code of ordinances.

GENERAL PROVISIONS

§ 110.01 LICENSE REQUIRED.

Every person engaged or intending to engage in any calling, business, occupation, or profession listed in the rate classification index in § 110.47, in whole or in part, within the limits of the town is required to pay an annual license fee for the privilege of doing business and obtain a business license as herein provided.

(Ord. 2009-, passed 6-8-2009)

§ 110.02 DEFINITIONS.

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

BUSINESS. A calling, occupation, profession, or activity engaged in with the object of gain, benefit, or advantage, either directly or indirectly.

CHARITABLE PURPOSE. Benevolent, philanthropic, patriotic, or eleemosynary purpose which does not result in personal gain to a sponsor, organizer, officer, director, trustee, or person with ultimate control of the organization. A charitable organization shall be deemed a business subject to a license tax unless the entire net proceeds of its operation, after necessary expenses, are devoted to CHARITABLE PURPOSES. Compensation in any form to a sponsor, organizer, officer, director, trustee, or person with ultimate control of the organization shall not be deemed a necessary expense of operation.

CLASSIFICATION. The division of businesses by major groups subject to the same license rate as determined by a calculated index of ability to pay based on national averages, benefits, equalization of tax burden, relationships of services, or other basis deemed appropriate by Town Council.

GROSS INCOME. The total income of a business, received or accrued, for one calendar year collected or to be collected from business done within the town, excepting therefrom income from business done wholly outside of the town on which a license tax is paid to some other city or a county and fully reported to the town. GROSS INCOME for brokers or agents means gross commissions received or retained, unless otherwise specified. GROSS INCOME for insurance companies means gross premiums collected. GROSS INCOME for business license tax purposes shall not include taxes collected for a governmental entity, escrow funds, or funds which are the property of a third party. The value of bartered goods or trade-in merchandise shall be included in gross income. The GROSS INCOME for business license purposes may be verified by inspection of returns and reports filed with the Internal Revenue Service, the South Carolina Department of Revenue, the South Carolina Insurance Commission, or other government agency.

LICENSE OFFICIAL. A person designated to administer this chapter.

MUNICIPALITY. The Town of Whitmire, South Carolina.

PERSON. Any individual, firm, partnership, LLP, LLC, cooperative non-profit membership, corporation, joint venture, association, estate, trust, business trust, receiver, syndicate, holding company, or other group or combination acting as a unit, in the singular or plural, and the agent or employee having charge or control of a business in the absence of the principals. (Ord. 2009-, passed 6-8-2009)

§ 110.03 PURPOSE.

The business license levied by this chapter is for the purpose of providing such regulation as may be required for the business subject thereto and for the purpose of raising revenue for the General Fund through a privilege tax. Each license shall be issued for one year and shall expire on December 31. The provisions of this chapter and the rates herein shall remain in effect from year to year as amended by Council.

APPLICATION AND ADMINISTRATION

§ 110.15 LICENSE FEE.

- (A) The required license fee shall be paid for each business subject hereto according to the applicable rate classification on or before April 15 in each year, except for those businesses in Rate Class 8 for which a different due date is specified.
- (B) A separate license shall be required for each place of business and for each classification or business conducted at one place. If gross income cannot be separated for classifications at one location, the license fee shall be computed on the combined gross income for the classification requiring the highest rate. A license fee based on gross income shall be computed on the gross income for the preceding calendar or fiscal year, and on a 12-month projected income based on the monthly average for a business in operation for less than one year. The fee for a new business shall be computed on the estimated probable gross income stated in the license application for the balance of the license year. The initial fee for an annexed business shall be prorated for the number of months remaining in the license year. No refund shall be made for a business that is discontinued. (Ord. 2009-, passed 6-8-2009)

§ 110.16 REGISTRATION REQUIRED.

(A) The owner, agent, or legal representative of every business subject to this chapter, whether listed in the classification index or not, shall register the business and make application for a business

license on or before the due date of each year; provided, a new business shall be required to have a business license prior to operation within the municipality.

- (B) Application shall be on a form provided by the License Official which shall contain the Social Security Number and/or the Federal Employer's Identification Number, the business name as reported on the state income tax return, and all information about the applicant and the business deemed appropriate to carry out the purpose of this chapter by the License Official. Applicants may be required to submit copies of portions of state and federal income tax returns reflecting gross income figures.
- (C) The applicant shall certify under oath that the information given in the application is true, that the gross income is accurately reported, or estimated for a new business, without any unauthorized deductions, and that all assessments and personal property taxes on business property due and payable to the municipality have been paid.
- (D) Insurance agents and brokers shall report the name of each insurance company for which a policy was issued and the total premiums collected for each company for each type of insurance coverage on a form approved by the License Official. An insurance agent not employed by a company shall be licensed as a broker.

§ 110.17 DEDUCTIONS, EXEMPTIONS, AND CHARITABLE ORGANIZATIONS.

- (A) No deductions from gross income shall be made except income from business done wholly outside of the municipality on which a license tax is paid to some other municipality or a county, taxes collected for a governmental entity, or income which cannot be included for computation of the tax pursuant to state or federal law. The applicant shall have the burden to establish the right to exempt income by satisfactory records and proof.
- (B) No person shall be exempt from the requirements of the chapter by reason of the lack of an established place of business within the municipality, unless exempted by state or federal law. The License Official shall determine the appropriate classification for each business in accordance with the latest issue of the North American Industry Classification System (NAICS) for the United States published by the Office of Management and Budget. No person shall be exempt from this chapter by reason of the payment of any other tax, unless exempted by state law, and no person shall be relieved of liability for payment of any other tax by reason of application of this chapter.
- (C) Charitable organizations which have exemptions from state and federal income taxes shall be exempt from a business license tax only in cases where the sponsors, organizers, directors, trustees, or persons who exercise ultimate control of the organization receive no part of the proceeds of operation and all proceeds are devoted to charitable purposes as defined by this chapter. Payment of necessary costs of operation and wages to non-management employees will not disqualify a charitable organization from exemption.

§ 110.18 FALSE APPLICATION.

It shall be unlawful for any person subject to the provisions of this chapter to make a false application for a business license or to give or file, or direct the giving or filing of, any false information with respect to the license or fee required by this chapter. (Ord. 2009-, passed 6-8-2009) Penalty, see § 110.99

§ 110.19 DISPLAY AND TRANSFER.

- (A) All persons shall display the license issued to them on the original form provided by the License Official in a conspicuous place in the business establishment at the address shown on the license. A transient or non-resident shall carry the license upon his or her person or in a vehicle used in the business readily available for inspection by any authorized agent of the municipality.
- (B) A change of address must be reported to the License Official within ten days after removal of the business to a new location and the license will be valid at the new address upon written notification by the License Official and compliance with zoning and building codes. Failure to obtain the approval of the License Official for a change of address shall invalidate the license and subject the licensee to prosecution for doing business without a license. A business license shall not be transferable and a transfer of controlling interest shall be considered a termination of the old business and the establishment of a new business requiring a new business license, based on old business income. (Ord. 2009-, passed 6-8-2009)

§ 110.20 ADMINISTRATION.

The License Official shall administer the provisions of this chapter, collect license fees, issue licenses, make or initiate investigations and audits to ensure compliance, initiate denial or revocation procedures, report violations to the Town Attorney, assist in prosecution of violators, produce forms, make reasonable regulations relating to the administration of this chapter, and perform such other duties as may be duly assigned. (Ord. 2009-, passed 6-8-2009)

§ 110.21 INSPECTION AND AUDITS.

(A) For the purpose of enforcing the provisions of this chapter, the License Official or other authorized agent of the municipality is empowered to enter upon the premises of any person subject to this chapter to make inspections, examine and audit books and records. It shall be unlawful for any such person to fail or refuse to make available the necessary books and records. In the event an audit or inspection reveals that the licensee has filed false information, the costs of the audit shall be added to the correct license fee and late penalties in addition to other penalties provided herein. Each day of failure to pay the proper amount of license fee shall constitute a separate offense.

(B) The License Official shall make systematic inspections and random audits of all businesses within the municipality to ensure compliance with the chapter. Financial information obtained by inspections and audits shall not be deemed public records, and the License Official shall not release the amount of license taxes paid or the reported gross income of any person by name without written permission of the licensee. Statistics compiled by classifications are public records. (Ord. 2009-, passed 6-8-2009) Penalty, see § 110.99

§ 110.22 ASSESSMENTS, PAYMENT UNDER PROTEST, APPEAL.

- (A) If a person fails to obtain a business license or to furnish the information required by this chapter or the License Official, the License Official shall examine such records of the business or any other available records as may be appropriate and conduct such investigations and statistical surveys as the License Official may deem appropriate to assess a license tax and penalties as provided herein.
- (B) A notice of assessment shall be served by certified mail. An application for adjustment of the assessment may be made to the License Official within five days after the notice is mailed or the assessment will become final. The License Official shall establish by regulation the procedure for hearing an application for adjustment of assessment and issuing a notice of final assessment.
- (C) A final assessment may be appealed to the Town Council only by payment in full of the assessment under protest within five days and the filing of written notice of appeal within ten days after payment pursuant to the provisions of this chapter relating to appeals to Council. (Ord. 2009-, passed 6-8-2009)

§ 110.23 DELINQUENT LICENSE FEES, PARTIAL PAYMENT.

- (A) For non-payment of all or any part of the correct license fee, the License Official shall levy and collect a late penalty of 5% of the unpaid fee for each month, or portion thereof, after the due date until paid. Penalties shall not be waived. If any license fee remains unpaid for 60 days after its due date, the License Official shall report it to the Town Attorney for appropriate legal action.
- (B) Partial payment may be accepted by the License Official to toll imposition of penalties on the portion paid; provided, however, no business license shall be issued or renewed until the full amount of the tax due, with penalties, has been paid. (Ord. 2009-, passed 6-8-2009)

§ 110.24 NOTICES.

The License Official may, but shall not be required to, mail written notices that license fees are due. If notices are not mailed, there shall be published a notice of the due date in a newspaper of general

circulation within the municipality three times prior to the due date in each year. Failure to receive notice shall not constitute a defense to prosecution for failure to pay the tax due or grounds for waiver of penalties.

§ 110.25 DENIAL OF LICENSE.

The License Official shall deny a license to an applicant when the application is incomplete; contains a misrepresentation, false, or misleading statement; evasion or suppression of a material fact; or when the activity for which a license is sought is unlawful or constitutes a public nuisance per se. A decision of the License Official shall be subject to appeal to Council as herein provided. Denial shall be written with reasons stated.

(Ord. 2009-, passed 6-8-2009)

§ 110.26 SUSPENSION OR REVOCATION.

- (A) The License Official shall give written notice to the licensee, or the person in control of the business within the municipality, by personal service or certified mail that the license is suspended pending a hearing before Council for the purpose of determining whether the license should be revoked when the License Official determines:
 - (1) A license has been mistakenly or improperly issued or issued contrary to law;
- (2) A licensee has breached any condition upon which the license was issued or has failed to comply with the provisions of this chapter;
- (3) A licensee has obtained a license through a fraud, misrepresentation, a false or misleading statement, or evasion or suppression of a material fact in the license application;
- (4) A licensee has been convicted of an offense under a law or ordinance regulating business, a crime involving moral turpitude, or an unlawful sale of merchandise or prohibited goods; or
 - (5) A licensee has engaged in an unlawful activity or nuisance related to the business.
- (B) The notice shall state the time and place at which the hearing is to be held, which shall be at a regular or special Council meeting within 30 days from the date of service of the notice, unless continued by agreement. The notice shall contain a brief statement of the reasons for suspension and proposed revocation and a copy of the applicable provisions of this chapter. (Ord. 2009-, passed 6-8-2009)

§ 110.27 APPEALS.

- (A) Any person aggrieved by a decision, final assessment, revocation, suspension, or a denial of a business license by the License Official may appeal the decision to the Town Council by written request stating the reasons therefor, filed with the License Official within ten days after the payment of the assessment under protest or notice of denial is received. Payment under protest shall be a condition precedent to appeal.
- (B) An appeal or a hearing on revocation shall be held by the Town Council within 30 days after receipt of a request for appeal or service of notice of suspension at a regular or special meeting, of which the applicant or licensee has been given written notice, unless continued by agreement. At the hearing, all parties shall have the right to be represented by counsel, to present testimony and evidence, and to cross-examine witnesses. The proceedings shall be recorded and transcribed at the expense of the party so requesting. The rules of evidence and procedure prescribed by Council shall govern the hearing. Council shall, by majority vote of members present, render a written decision based on findings of fact and application of the standards herein which shall be served upon all parties or their representatives, and shall be final unless appealed to a court of competent jurisdiction within ten days after service.
- (C) No person shall be subject to prosecution for doing business without a license until the expiration of ten days after notice of denial or revocation which is not appealed, or until after final judgment of a circuit court upholding denial or revocation. (Ord. 2009-, passed 6-8-2009)

§ 110.28 PERMISSION TO USE STREETS.

It shall be unlawful for any person to construct, install, maintain, or operate in, on, above, or under any street or public place under control of the municipality, any line, pipe, cable, pole, structure, or facility for utilities, communications, cablevision, or other purposes without a consent agreement or franchise agreement issued by the Town Council by ordinance which prescribes the term, fees, and conditions for use.

(Ord. 2009-, passed 6-8-2009) Penalty, see § 110.99

§ 110.29 FEE FOR USE OF PUBLIC PLACES.

The annual fee for use of streets or public places authorized by a consent agreement or franchise agreement shall be set by the ordinance approving the agreement and shall be consistent with limits set by state law. Existing franchise agreements shall continue in effect until expiration dates in the agreements. Franchise and consent fees shall not be in lieu of, or be credited against, business license fees unless specifically provided by the franchise or consent agreement. (Ord. 2009-, passed 6-8-2009)

§ 110.30 CONFIDENTIALITY.

Except in accordance with proper judicial order or as otherwise provided by law, it shall be unlawful for any official or employee to divulge or make known in any manner the amount of income or any particulars set forth or disclosed in any report or return required under this chapter. Nothing in this section shall be construed to prohibit the publication of statistics so classified as to prevent the identification of particular reports or returns. Any license data may be shared with other public officials or employees in the performance of their duties, whether or not those duties relate to enforcement of this chapter.

CLASSIFICATION

§ 110.45 CLASSIFICATION AND RATES.

- (A) The sectors of businesses included in each Rate Class are listed with the United States North American Industry Classification System (NAICS) codes. The alphabetical index in § 110.49 is a tool for classification, not a limitation on businesses subject to a license tax. The License Official shall determine the proper class for a business according to the applicable NAICS manual, whether or not the business is listed in the alphabetical index. A business class which is not listed in the rate class or numerical indexes is not subject to a license tax.
- (B) The license fee for each class of businesses subject to this chapter shall be computed in accordance with the following rates.

§ 110.46 CLASS EIGHT RATES.

Each NAICS number designates a separate subclassification. The businesses in this section are treated as separate and individual subclasses due to provisions of state law, regulatory requirements, service burdens, tax equalization considerations, and the like, which are deemed to be sufficient to require individually determined rates. Non-resident rates do not apply except where indicated.

- (A) NAICS 23-Contractors, construction, all types.
 - (1) Having permanent place of business within the municipality:
 - (a) Minimum on first \$2,000: \$60; and
 - (b) Plus per \$1,000, or fraction, over \$2,000 from all work: \$1.35.
 - (2) Non-resident (no permanent place of business in the municipality):
 - (a) Minimum on first \$2,000: \$120; and

- (b) Plus per \$1,000, or fraction, over \$2,000: \$2.70. (Non-resident double rates do not apply.)
- (3) A trailer at the construction site or structure in which the contractor temporarily resides is not a permanent place of business under this chapter.
- (4) The total fee for the full amount of the contract shall be paid prior to commencement of work and shall entitle a contractor to complete the job without regard to the normal license expiration date. An amended report shall be filed for each new job and the appropriate additional license fee per \$1,000 of the contract amount shall be paid prior to commencement of new work. Only one base fee shall be paid in a calendar year.
- (5) No contractor shall be issued a business license until all state and municipal qualification examination and trade license requirements have been met. Each contractor shall post a sign in plain view on each job identifying the contractor with the job.
- (6) Sub-contractors shall be licensed on the same basis as general or prime contractors for the same job. No deductions shall be made by a general or prime contractor for value of work performed by a sub-contractor.
- (7) No contractor shall be issued a business license until all performance and indemnity bonds required by the Building Code have been filed and approved. Zoning permits must be obtained when required by the Zoning Ordinance.
- (8) Each prime contractor shall file with the License Official a list of sub-contractors furnishing labor or materials for each project.
 - (B) NAICS 482-Railroad companies. (See S.C. Code § 12-23-210): \$50.
 - (C) NAICS 5171 and 5172-Telephone companies.
- (1) Notwithstanding any other provisions of this chapter, business license taxes for retail telecommunications service, as defined in S.C. Code § 58-9-2200, including, but not limited to, those services described in North American Industry Classification System (NAICS) 5171 and 5172 shall pay an annual business license fee based on gross income.
- (2) Pursuant to S.C. Code § 58-9-2220, the following business license tax schedule shall apply to the gross income from retail telecommunications services for the preceding calendar or fiscal year which either originate or terminate in the municipality, and which are charged to a service address within the municipality regardless of where these amounts are billed or paid and on which a business license tax has not been paid to another municipality. The measurement of the amounts derived from the retail of mobile telecommunications services shall include only revenues from the fixed monthly recurring charge of customers whose service address is within the boundaries of the municipality.

Whitmire - Business Regulations

- (a) Rate for license taxes due in the years 1999 through 2003: 0.3% of gross income for the preceding year;
- (b) Rate for license taxes due in the year 2004 and each year thereafter: [See state statute] 1% of gross income for the preceding year; and
- (c) For a business in operation for less than one year, the amount of business license tax authorized by this section shall be computed on a 12-month projected income.

- (5) Nothing in this chapter shall be interpreted to interfere with a franchise agreement or contractual agreement entered into with a telecommunications provider prior to December 31, 1997.
- (6) Fees imposed by a franchise or contractual agreement with a telecommunications provider entered into prior to December 31, 1997, which expires prior to December 31, 2003, shall continue in effect until December 31, 2003.
- (7) All fees collected under such franchise agreement or contractual agreement shall be in lieu of fees or taxes which might otherwise be authorized by this chapter.
- (8) A business license tax ordinance, adopted prior to December 31, 1997, which levied a business license tax paid by a telecommunications company higher than that levied under this chapter shall remain in effect through December 31, 2003.
- (9) As authorized by S.C. Code § 5-7-300, the agreement with the Municipal Association of the state for collection of current and delinquent license taxes from telecommunications companies, pursuant to S.C. Code § 58-9-2200, in the form attached to Ord. 2009- is approved and the Mayor is authorized to execute it.
 - (D) NAICS 5175-Television.

 - (a) Minimum on first \$2,000: \$NA;

Whitmire - Business Regulations

 - (O) NAICS 524127-Title insurance. Two percent of gross premiums.
 - (P) NAICS 524210-Brokers for fire and casualty insurers non-admitted.
- (1) On gross premiums collected on policies of companies not licensed in the state, the agent or broker shall pay annually, with copy of the report showing location of the risks insured, 2% of gross premiums. (Premiums for non-admitted business are not included in gross commissions for license under Rate Class 7 for other business.)
- (2) Notwithstanding any other provision of this chapter, license taxes for insurance companies and brokers for non-admitted insurers shall be payable on or before May 31 in each year without penalty. Pursuant to S.C. § 111.01 DISTRIBUTION TO MINORS.

It shall be unlawful for any person to sell, purchase for, or transfer any alcoholic beverage to a minor under the age of 21 years. (1974 Code, § 2A-1) (Ord. passed 4-11-1994) Penalty, see § 111.99

§ 111.02 PROHIBITED ACTS.

111.99 Penalty

No holder of a permit authorizing the sale of beer or wine or any servant, agent, or employee of the permittee shall knowingly do any of the following acts upon the licensed premises covered by such holder's permit:

- (A) Sell beer or wine to a minor;
- (B) Sell beer or wine to any person while such person is in an intoxicated condition;
- (C) Permit gambling or games of chance;
- (D) Permit any lewd, immoral, or improper entertainment, conduct, or practices;
- (E) Permit any act, the commission of which tends to create a public nuisance or which constitutes a crime under the provisions of this code or other ordinances of the city or the laws of the state; or
- (F) Sell, offer for sale, or possess any beverage or alcoholic liquor, the sale or possession of which is prohibited on the licensed premises under the law of the state. (1974 Code, § 2A-2) Penalty, see § 111.99

§ 111.03 MINORS TRANSPORTING ALCOHOL PROHIBITED.

GENERAL PROVISIONS

§ 112.01 DEFINITION.

For the purpose of this chapter, the following definition shall apply unless the context clearly indicates or requires a different meaning.

SOLICITOR. A person who goes from door to door visiting multi-family or single-family dwellings for the following purposes:

- (1) To sell any goods, wares, or merchandise or accept subscriptions or orders therefor; or
- (2) To accept or request donations for any charitable purpose. (1974 Code, § 14-1)

§ 112.02 REGISTRATION REQUIRED.

All persons, before entering into or upon a private residence within the town for the purpose of soliciting, are hereby required to register with the Chief of Police and furnish the following information:

- (A) The name, local and permanent address, age, weight, height, color of hair and eyes, and any other distinguishing physical characteristics of the applicant;
- (B) The nature or purpose for which solicitations will be made and the nature of the goods, wares, and merchandise offered for sale;
 - (C) The name and address of the employer or organization represented; and
- (D) A statement as to whether the applicant has been convicted of any felony or misdemeanor, and if so, the nature of the offense, when and where convicted, and the penalty or punishment assessed therefor.

§ 112.03 FINGERPRINTING AND PHOTOGRAPHING REQUIRED.

Persons required by § 112.02 to be registered shall, at the time of registration, also be fingerprinted and photographed by the Police Department. (1974 Code, § 14-3)

§ 112.04 LICENSE.

Upon furnishing the information required under § 112.02 and complying with the provisions of § 112.03, the applicant shall be issued a license, unless the information furnished in compliance with this chapter shows that the applicant has been convicted of a crime involving moral turpitude. A license issued under this section shall be good for one year from the date of issuance, unless earlier revoked as provided in this chapter. Every solicitor shall carry with him or her, his or her license at all times while engaged in soliciting and shall display the same to any person who shall demand to see the same while he or she is so engaged.

§ 112.05 REVOCATION.

The Chief of Police or his or her designated agent shall revoke any license issued under this chapter if he or she finds that the licensee has given false information or has knowingly withheld information in obtaining the same, or for any violation of any provision of this chapter. § 112.06 PROHIBITED ACTS.

No person shall:

- (A) Enter into or upon a private residence in the town under false pretenses to solicit for the purpose of soliciting orders for the sale of goods, wares, or merchandise, or to solicit for any purpose;
- (B) Remain in a private residence or on the premises thereof after the owner or occupant has requested any such person to leave;
- (C) Enter into or upon the premises of a private residence for soliciting when the owner or occupant has displayed a "No Soliciting" sign on such premises; and/or
- (D) Engage in the practice of soliciting in the town without a license as provided for in this chapter.

§ 112.07 EXEMPTIONS.

The provisions of this chapter shall not apply to the following:

- (A) Any person who visits any residence or apartment at the request or invitation of the owner or occupant thereof;
- (B) Unpaid members of any civic or charitable organization who are registered as such with the Chief of Police, when the names of the solicitors have been listed as such members and the organization has provided each person listed with an approved means of identification with the organization represented;
 - (C) Newsboys soliciting subscriptions to any newspaper published in the state; and
- (D) Route delivery persons who make deliveries at least once a week to regular customers and whose solicitation is only incidental to their regular deliveries. (1974 Code, § 14-8)

§ 112.08 HOURS OF OPERATION.

- (A) No peddlers, solicitors, canvassers, or door-to-door salespersons shall solicit the purchase of goods or services in the town but between the hours of 10:00 a.m. and 6:00 p.m.

SPECIAL PERMITS FOR CHARITIES

§ 112.20 WHEN REQUIRED.

It shall be unlawful for any person, or for any agent or representative thereof, directly or indirectly, to solicit property or financial assistance of any kind, or to sell or offer to sell any article, tag, service emblem, publication, ticket, advertisement, subscription, or anything of value, on the plea or the representation that such sale or solicitation, or the proceeds thereof, is for a charitable, educational, religious, patriotic, or philanthropic purpose, on the streets, in any office or business building, by house to house canvass or in any other public or private place, by telephone, personal solicitation, or in any other way in the town, unless such person shall have first obtained a permit from the Town Clerk/Treasurer; provided, that the provisions of this section shall not apply to any established society, association, or corporation that is organized and operated exclusively for religious, educational, philanthropic, benevolent, fraternal, charitable, or reformatory purposes, not operated for pecuniary profit, no part of the net earnings of which inure to the benefit of any person, private shareholder, or individual and where the solicitation of such organization shall be conducted solely among the members thereof by other members thereof or officers thereof, voluntarily and without remuneration for such solicitation, or where such solicitation may be in the form of collections or contributions at the regular exercises of service of any church, religious society, lodge, benevolent order or fraternity, or similar organization, or of any branch thereof.

§ 112.21 APPLICATION.

- (A) A written application for a permit to solicit for any cause whatsoever, as provided in § 112.20, shall be sworn to and filed with the Town Clerk/Treasurer.
 - (B) The application shall contain the following information:
 - (1) Name of organization applying for a permit to solicit and the address of its headquarters;

- (2) Names and addresses of its principal officers and management;
- (3) The purpose for which any receipts derived from such solicitations are to be used;
- (4) The name of the person by whom the receipts of such solicitation shall be disbursed;
- (5) The name and address of the person who will be in direct charge of conducting the solicitations;
 - (6) An outline of the method to be used in conducting the solicitation;
- (7) The time when such solicitation shall be made, giving the proposed dates for the beginning and ending of such solicitations;
- (8) The amount of any wages, fees, commissions, expenses, or emoluments to be expended or paid to anyone in connection with such solicitation, together with the manner in which such wages, fees, expenses, commissions, or emoluments are to be expended, to whom paid, and the amount thereof;
- (9) A financial statement for the last preceding fiscal year of any funds collected for the purpose set out in § 112.20 by the organization or persons seeking a permit for such solicitations, such statement giving the amount of money so raised, together with the cost of raising it, and the final distribution thereof;
- (10) A full statement of the character and extent of the charitable, religious, educational, or philanthropic work being done by the applicant organization within the town; and
- (11) Such other information as may be required by the Town Clerk/Treasurer in order to fully determine the kind and character and worthiness of the proposed solicitations, and whether or not such solicitation is in the interest of protecting the health, life, and property of the citizens of the town and of preserving and enforcing good government and for the security of the town and its inhabitants. (1974 Code, § 14-10)

§ 112.22 TERM; RENEWAL.

The Town Clerk/Treasurer shall determine, from the application and from such facts as may be developed in connection with such application, the period for which the permit required by § 112.20 shall be approved and granted; provided, that such period shall not exceed three calendar months; provided, further, that upon further application, information, or reports as may be deemed necessary to safeguard the interest of the public and carry out the purposes of this chapter, the Town Clerk/Treasurer may renew and extend such permit for additional periods, not to exceed three calendar months. (1974 Code, § 14-11)

§ 112.23 REPORTS AND INFORMATION FROM PERMITTEE.

The Town Clerk/Treasurer may require from any permittee under this chapter any reports or information at any time and at such intervals, as in the discretion of the Town Clerk/Treasurer shall be necessary, for the successful administration of the provisions of this chapter and the protection of the health, life, and property of the citizens of the town. (1974 Code, § 14-12)

§ 112.24 TRANSFER; POSSESSION OF PERMIT COPIES.

Any permit approved and issued under the provisions of this chapter shall be nontransferable; provided, that this shall not prevent any permittee from using any number of solicitors and representatives as shall be reported to the Town Clerk/Treasurer; provided, further, that the permittee shall furnish to each of its agents, employees, or representatives making any solicitations a facsimile copy of the permit, which shall be carried by all such agents, employees, or representatives making solicitations at the time when solicitations are being made. (1974 Code, § 14-13)

§ 112.25 REVOCATION.

If, upon receipt of written information or upon his or her own investigation, the Town Clerk/Treasurer shall find that any agent or representative of a permittee under the provisions of this chapter is misrepresenting or making untrue statements in the application, or that in any other way the solicitation has been conducted or is being conducted in a manner inimical to the protection of the health, life, and property of the citizens of the town and not in conformity with the intent and purpose of this chapter, it shall be the duty of the Town Clerk/Treasurer to immediately revoke such permit. (1974 Code, § 14-14)

§ 112.26 ISSUANCE NOT DEEMED ENDORSEMENT.

It shall be unlawful for any permittee under the provisions of this chapter or for any agent, employee, or representative thereof to advertise, represent, or hold out in any manner that the permit required by § 112.20 is an endorsement of the holder thereof by the Town Council or any employee thereof, or by the town; provided, that it shall be lawful for a permittee to use, advertise, or hold out the fact of his or her permit in the following words and no others: "Charities Solicitations Permit No.

"including in the blank space the serial number of the permit.

§ 113.01 RETAIL TELECOMMUNICATION SERVICES.

- (A) (1) Notwithstanding any other provisions of Chapter 110, the business license tax for retail telecommunications services, as defined in S.C. Code § 58-9-2200, shall be at the maximum rate authorized by S.C. Code § 58-9-2220, as it now provides or as provided by its amendment. The business license tax year shall begin on January 1 of each year. The rate for the 2005 business license tax year shall be the maximum rate allowed by state law as in effect on February 1, 2005. Declining rates shall not apply.
- (2) In conformity with S.C. Code § 58-9-2220, the business license tax for retail telecommunications services shall apply to the gross income derived from the sale of retail telecommunications services for the preceding calendar or fiscal year which either originate or terminate in the municipality and which are charged to a service address within the municipality, regardless of where these amounts are billed or paid and on which a business license tax has not been paid to another municipality. The measurement of the amounts derived from the retail sale of mobile telecommunications services shall include only revenues from the fixed monthly recurring charge of customers whose service address is within the boundaries of the municipality. For a business operation for less than one year, the amount of business license tax shall be computed on a 12-month projected income.
- (B) (1) For the year 2005, the business license tax for retail telecommunications services shall be due on February 1, 2005, and payable by February 28, 2005, without penalty. For years after 2005, the business license tax for retail telecommunications services shall be due on January 1 of each year and payable by January 31 of that year, without penalty.
- (2) The delinquent penalty shall be 5% of the tax due for each month, or portion thereof, after the due date until paid.

- (C) Exemptions in Chapter 110 for income from business in interstate commerce are hereby repealed. Properly apportioned gross income from interstate commerce shall be included in the gross income for every business subject to a business license tax.
- (D) (1) Nothing in this section shall be interpreted to interfere with continuing obligations of any franchise agreement or contractual agreement in the event that the franchise or contractual agreement should expire after December 31, 2003.
- (2) All fees collected under such a franchise or contractual agreement expiring after December 31, 2003, shall be in lieu of fees or taxes which might otherwise be authorized by this section.
- (E) As authorized by S.C. Code § 5-7-300, the agreement with the Municipal Association of the state for collection of current and delinquent license taxes from telecommunications companies pursuant to S.C. Code § 58-9-2200 shall continue in effect. Notwithstanding the provisions of the agreement, for the year 2005, the Municipal Association of the state is authorized to collect current and delinquent license taxes in conformity with the due date and delinquent date for 2005 as set out in this section, and is further authorized, for the year 2005, to disburse business license taxes collected, less the service charge agreed to, to this municipality on or before April 1, 2005, and thereafter as remaining collections permit.

§ 113.02 PLACING LINES IN STREETS.

- (A) It shall be unlawful for any person to construct, install, maintain, or operate in, on, above, or under any street or public place under control of the municipality any line, pipe, cable, pole, structure, or facility for utilities, communications, cablevision, or other purposes without a consent agreement or franchise agreement issued by the Town Council by ordinance which prescribes the term, fees, and conditions for use.
- (B) The annual fee for use of streets or public places authorized by a consent agreement or franchise agreement shall be set by the ordinance approving the agreement and shall be based on gross revenues derived from activities in the municipality, the length of lines installed in streets and public places, or other formula deemed appropriate by Council. No consent fee or franchise fee shall be construed to be in lieu of a business license tax based on gross revenue unless specifically provided by ordinance. Credits for business license taxes paid may be applied to fees set by ordinance granting consent or a franchise when specifically authorized by the ordinance.
- (C) Establishments providing local or long distance telephone communications, as described in Standard Industrial Classification (SIC) group 481, including voice and data communications; radiotelephone services; cellular telephone services; paging and beeper services; leasing lines, fiber optic cables, microwave, or satellite facilities; selling access and reselling use of facilities or methods to others shall pay an annual business license tax of 3% of gross receipts from all communications activities

conducted in the municipality and for communications services billed to customers located in the municipality on which a business license tax has not been paid to another municipality. (Ord. passed 1-12-1998) Penalty, see § 113.99

§ 113.03 PUBLIC SERVICE DRIVERS.

- (A) It shall be unlawful for any public service driver, either of a hack or automobile, plying the street and transporting passengers for hire, to engage in such service without first obtaining from the Town License Inspector a license to drive such hack, automobile, or other vehicle transporting passengers for hire.
- (B) It shall be unlawful for any such driver to drink or be under the influence of intoxicating liquors or beverages while so engaged. (1974 Code, § 10-10) Penalty, see § 113.99

§ 113.04 EXTERMINATORS.

- (A) It shall be unlawful for any person, firm, or corporation to engage in the business of pest control or extermination of any household pests including, but not limited to, rodents, roaches, and termites (or any other wood-infesting pest) without having first secured a license therefor.
- (B) (1) Applications for such licenses shall be made to the Town Clerk/Treasurer and shall state thereon the description of all vehicles used in such business, the name and owner of such business, along with the address of the principal place of business, as well as the agent thereof.
- (2) Applications for said licenses shall be turned over to the License Committee for the Town Council and the License Committee shall, after such deliberation and investigation as it shall deem wise, either pass or reject any application for said license which shall come before it, and there shall be a waiting period of not less than ten days nor more than 30 days before any such licenses shall be issued.
 - (C) The fee for such licenses shall be determined by class and gross receipts.
- (D) Any licensed pest control or exterminating company, corporation, or individual who shall be guilty of any fraud, cheating, or misrepresentation, whether through himself, herself, or through an employee, shall be deemed in violation of this section and fined accordingly. (Ord. passed 4-21-1981) Penalty, see § 113.99

§ 113.99 PENALTY.

(A) Any person violating any provision of this chapter for which no specific penalty is prescribed shall be subject to § 10.99 of this code of ordinances.

§ 131.02 DESTRUCTION OF SIGNS.

It shall be unlawful for any person to willfully demolish, throw down, alter, or deface any sign, guide board, or placard erected within the town, either by the town or the state's Highway Department. (1974 Code, § 10-6) Penalty, see § 10.99

§ 131.03 INJURY TO PROPERTY OR ANIMALS.

It shall be unlawful for any person to injure any animal which is the property of another or injure any goods, wares, or merchandise or other personal property of another person within the town. (1974 Code, § 10-17) Penalty, see § 10.99

§ 131.04 INJURY TO PUBLIC PROPERTY.

It shall be unlawful for any person to cut, mutilate, injure, hurt, mar, disfigure, efface, or destroy, in any manner whatsoever, any school building, church building, or other public building within the town or any furniture, furnishings, fixtures, ornaments, decorations, or other property located in any

such building; or fence, tree, or other property on the grounds of any park, church or school building, or other public property.

It shall be unlawful for any person to enter or trespass upon the premises of any other person, after notice from the owner or tenant prohibiting such trespass; provided, that due notice forbidding trespasses upon such premises shall have first been given, either orally or by written notice conspicuously posted on the premises by the owner or tenant of such premises, and the proof of a notice in writing being conspicuously posted upon the premises at the time of the alleged trespass or entry shall be deemed and taken as notice conclusive against the person making entry as aforesaid; provided, that this section shall not apply to invitees or licensees.

§ 131.07 HOUSE NUMBER DISPLAY.

CLEARLY VISIBLE. Readable by a person with normal or corrective 20/20 vision from the center of the street, road or avenue to which the number relates.

HOUSE NUMBER. The official number assigned a premises by the Town of Whitmire or Newberry County 911 Service.

PREMISES. Any lot or parcel of land owned by any person, firm or corporation, public or private, improved with buildings, whether occupied or not.

- (B) Assignment and placement of house numbers.
- (1) When a premises has been assigned a number by the Town of Whitmire or the County of Newberry 911 Service, that property number shall be placed on the premises by the property owner or tenant in the manner specified in this section. That number shall be clearly visible from the street to which the house number is related.
- (2) Such numbers shall be placed on existing buildings ami sew buildings upon completion of construction. Said numbers shall not be less than three inches in height and shall be conspicuously placed.
- (3) Once notified by town staff of a number assignment, number change or number problem or violation, the property owner or tenant shall place the number on the property as the notification requires as quickly as possible, but within the time limits established by division (B)(3)(a) below. It shall be unlawful to fail to perform to the numbering provisions of this section. It shall be the duty of all town staff members and citizens to report numbering inconsistencies, problems and violations to town staff for investigation and appropriate enforcement. A violation of such provision shall make the offender liable to the following penalties:
- (a) First offense: written warning. Comply with requirements within 15 days after being properly served upon the owner or tenant by the town. The notice shall be properly served upon such owner or tenant when such notice has been sent by certified mail to such person's last known address or when such person has been served with such notice by any other method authorized by the laws of this state.
- (b) Second offense. A misdemeanor punishable upon conviction by fine of \$50 or by imprisonment for a period not to exceed 30 days, or both.
- (c) *Third or any subsequent offense*. Upon conviction shall be punishable by fine of up to \$500 or by imprisonment for a period not to exceed 30 days, or both. (Ord. 2014-01, passed 3-10-2014)

- (A) Any person who shall act in a violent or tumultuous manner toward another, whereby any person is placed in danger of safety for his or her life, limb, or health;
- (B) Any person who shall act in a violent or tumultuous manner toward another, whereby public property or property of any other person is placed in danger of being destroyed or damaged;
- (C) Any person who shall endanger lawful pursuits of another by acts of violence or threats of bodily harm;
- (D) Any person who shall cause, provoke, or engage in any fight, brawl, or riotous conduct so as to endanger the life, limb, health, or property of another or public property;
- (E) Any person who shall assemble or congregate with another or others and cause, provoke, or engage in any fight or brawl;
 - (F) Any persons who shall collect in bodies or in crowds and engage in unlawful activities;

- (G) Any person who shall assemble or congregate with another or others and cause, provoke, or engage in any fight or brawl;
- (H) Any person who shall frequent any public place and obtain money from another by an illegal and fraudulent scheme, trick, artifice, or device, or attempt to do so; and/or
- (I) Any person who assembles with another or others and engages in any fraudulent scheme, device, or trick to obtain any valuable thing in any place or from any person, or attempts to do so.(1974 Code, § 10-7) (Ord. 10-7, passed 4-14-2003) Penalty, see § 132.99

§ 132.02 FAILURE TO DISPERSE.

It shall be the duty of the police officers and peace officers of the town, upon observing the grouping or congregating of any number of persons in any public street or in any public place within the town for the purpose of conducting themselves in a disorderly manner, to command and direct the persons so grouped or congregated to disband and remove themselves from such place. Any person who shall fail to observe the directions or commands of such police officer or peace officer shall be guilty of a misdemeanor.

It shall be unlawful for any person to interrupt or disturb any religious service in the town. (1974 Code, § 10-9) Penalty, see § 132.99

It shall be unlawful for any person to turn in a false fire alarm. (1974 Code, § 10-12) Penalty, see § 132.99

§ 132.06 INTERRUPTING COURT OR COUNCIL MEETINGS.

It shall be unlawful for any person to interrupt the proceedings of the court; of the Mayor, Mayor pro tem, or Town Council; or any meeting of Town Council, or be guilty of disorderly conduct therein, or to commit any contempt of either of such courts. (1974 Code, § 10-19) Penalty, see § 132.99

§ 132.07 OBSCENITY.

(A) For the purpose of this section, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

AVAILABLE TO THE PUBLIC. Capable of being purchased or attended on a subscription basis, on a membership fee arrangement, or for a separate fee for each item or performance.

DISSEMINATE. To transfer possession of, with or without consideration.

KNOWINGLY. Aware of the character and the content of the material.

MATERIAL. Any book, magazine, newspaper, or other printed or written material; or any picture, drawing, photograph, motion picture, or other pictorial representation; or any statue or other figure; or any recording, transcription or mechanical, chemical, or electrical reproduction; or any other articles, equipment, or machines.

NUDITY. The showing of the human male or female genitals or pubic area with less than a fully opaque covering, or the depiction of covered male genitals in a discernibly turgid state.

OBSCENE. That to the average person applying contemporary community standards:

- (a) The predominant appeal of the matter, taken as a whole, is to prurient interest (i.e., a shameful or morbid interest in sexual conduct, nudity, or excretion);
- (b) The matter depicts or describes in a patently offensive manner sexual conduct regulated by state law; and
- (c) The work, taken as a whole, lacks serious literary, artistic, political, or scientific value.

PERFORMANCE. Any preview, play, show, skit, film, dance, or other exhibition performed before an audience.

PROMOTE. To cause, permit, procure, counsel, or assist.

SERVICE TO PATRONS. The provision of services to paying guests in establishments providing food and beverages including, but not limited to, hostessing, hat checking, cooking, bar tending, serving, table setting and clearing, waiter and waitressing, and entertaining. (1974 Code, § 10-21)

- (B) It shall be unlawful for any person to:
 - (1) Knowingly disseminate, distribute, or make available to the public any obscene material;
- (2) Knowingly engage or participate in any obscene performance made available to the public;
- (3) Knowingly engage in commerce for commercial gain with materials depicting and describing explicit sexual conduct, nudity, or excretion, utilizing displays, circulars, advertisements, and other public sales efforts that promote such commerce primarily on the basis of their prurient appeal;
 - (4) Provide service to patrons in such a manner as to expose to public view:
 - (a) His or her genitals, pubic hair, buttocks, perineum, anal region, or pubic hair region;
- (b) Any device, costume, or covering which gives the appearance of or simulates the genitals, pubic hair, buttocks, perineum, anal region, or pubic hair region; or
 - (c) Any portion of the female breast at or below the areola thereof.
- (5) Knowingly promote the commission of any of the above listed unlawful acts. (1974 Code, § 10-22)
- (C) (1) Actual notice of the obscene nature of any material, performance, or activity prohibited by division (B) above may be given to a person involved in or responsible for such by the Town Attorney on the basis of information lawfully gathered and supplied to him or her by the police or citizens. Such notice shall be in writing and delivered by mail or in person to the alleged offender.
 - (2) Such notice shall state that:
- (a) In the opinion of the Town Attorney, the activity engaged in falls within the prohibitions of division (B) above;
- (b) If such activity has not ceased within seven judicial days, the town will take appropriate legal action; and
- (c) A declaratory judgment proceeding is available if a person engaged in the challenged activity wishes to initiate the legal determination of whether the activity is in fact obscene.

- (3) A person who promotes any obscene activity as prohibited in division (B) above in the course of his or her business is presumed to do so with knowledge of its content and character. (1974 Code, § 10.23)
- (D) (1) Expert affirmative evidence that the materials or activities are obscene is not required when the materials or activities themselves are presented as evidence.
- (2) It shall be an affirmative defense in any prosecution under the preceding divisions that allegedly obscene material was disseminated or presented for a bona fide scientific, medical, educational, governmental, or judicial purpose by a physician, psychologist, teacher, clergyman, prosecutor, or judge.

§ 132.08 PERJURY BEFORE MAYOR/COUNCIL.

It shall be unlawful for any person to swear falsely in any case, trial, or proceeding had before the Mayor, Mayor pro tem, or Town Council. (1974 Code, § 10-25) Penalty, see § 132.99

§ 132.09 LOITERING.

- (A) A person commits a violation if he or she loiters or prowls in a place, at a time, or in a manner not usual for law-abiding individuals under circumstances that warrant alarm for the safety of persons or property in the vicinity. Among the circumstances which may be considered in determining whether alarm is warranted is the fact that the person takes flight upon appearance of a police officer, refuses to identify himself or herself, or manifestly endeavors to conceal himself or herself or any object. Unless flight by the person or other circumstances makes it impractical, a police officer shall, prior to any arrest for an offense under this section, afford the person an opportunity to dispel any alarm which would otherwise be warranted, by requesting the person to identify himself or herself and to explain his or her presence or conduct. No person shall be convicted of an offense under this section if the police officer did not comply with the preceding sentence, or if it appears at trial that the explanation given by the person was true and, if it had been believed by the police officer at the time, would have dispelled the alarm. Any police officer may arrest any person suspected of being a loiterer or prowler without a warrant if it reasonably appears that the delay in arresting the suspect caused by obtaining a warrant would result in the suspect's escape.
- (B) It shall be unlawful for any person, after first being warned by a police officer, or where a "no loitering" sign or signs have been posted, to loiter, stand, sit, or lie in or upon any public or quasipublic sidewalk, street, curb, cross-walk, walkway area, mall or that portion of private property utilized for public use, so as to hinder or obstruct unreasonably the free passage of pedestrians or vehicles thereon.

Whitmire - General Offenses

It shall be unlawful for any person to block, obstruct, or prevent free access to the entrance to any building open to the public.

(C) For the purpose of this section, *PUBLIC PLACE* has the following definition unless the context clearly indicates or requires a different meaning: an area generally visible to public view, including streets, sidewalks, bridges, alleys, plazas, parks, driveways, parking lots, automobiles (whether moving or not), and buildings open to the general public, including those which serve food or drink or provide entertainment, and the doorways and entrances to buildings or dwellings and the grounds enclosing them.

§ 132.99 PENALTY.

- (A) Any person violating any provision of this chapter for which no specific penalty is prescribed shall be subject to § 10.99 of this code of ordinances.
- (B) A person violating § 132.01 shall be guilty of a misdemeanor and upon conviction shall be fined not more than \$500 or imprisoned for not more than 30 days. (1974 Code, § 10-7)

GENERAL PROVISIONS

§ 150.01 LITTER AND DEBRIS ON CONSTRUCTION SITES.

Any contractor operating within the town with a valid license shall be responsible for the removal of all litter and debris from the construction site. (1974 Code, § 4-1) (Ord. passed 2-19-1973) Penalty, see § 150.99

§ 150.02 FIRE LIMITS ESTABLISHED.

The fire limits of the town shall be as follows: beginning at a point on the main line of the Seaboard Air Line Railway directly in front of the garage of P.B. Odell & Son, thence in a southwesterly direction to the Aragon-Baldwin Cotton Mill's spur tract of the Seaboard Air Line Railway, thence in a southerly direction following such spur track to Gillian Street, thence in an easterly direction following Gillian Street to Bridge Street, thence north following Bridge Street to the main line of the Seaboard Air Line Railway, thence in a southerly direction to the point of beginning. (1974 Code, § 4-2)

§ 150.03 CONSTRUCTION WITHIN FIRE LIMITS.

- (A) It shall be unlawful to build, erect, or construct any wood or frame building or structure of any description within the established fire limits of the town, or to alter or repair any building or structure within the fire limits, except with such fireproof material as the Town Council may permit to be used. Any building erected within the fire limits contrary to the provisions of this section shall be declared a nuisance and shall be abated and removed.
- (B) It shall be unlawful for any building or structure of any kind to be erected within the fire limits, or for any building or structure so erected to be repaired, until plans and specifications for such building or repairs shall have been first submitted to, and approved by, the Town Council. (1974 Code, § 4-3) Penalty, see § 150.99

REGULATION AND ENFORCEMENT

§ 150.15 NATIONAL CODES ADOPTED.

- (A) The town does adopt and incorporate by reference, as if fully set forth in this section, the latest editions of the national codes hereinafter specified, for use and enforcement of the jurisdiction of the town. These national codes shall be known and referred to collectively as "The Building Codes":
 - (1) 2003 International Building Code with South Carolina modifications;
 - (2) 2003 International Fire Code with South Carolina modifications;
 - (3) 2003 International Plumbing Code;
 - (4) 2003 International Mechanical Code;
 - (5) 2003 International Energy Conservation Code;
 - (6) 2003 International Residential Code with South Carolina modifications;
 - (7) 2003 International Fuel Gas Code with South Carolina modifications; and
 - (8) 2002 National Electrical Code.

(B) The town has no Building Department or Building Official for enforcement of the Building Codes. Enforcement shall be had by the county by agreement entered by the town through its Mayor and the county. (See May 7, 2008 agreement.) (1974 Code, § 4-5) (Ord. passed 2-11-2008)

§ 150.16 DEMOLITION PERMIT.

- (A) It shall be unlawful for any person to demolish, remove, or tear down any structure which, at the beginning of demolition, exceeds 5,000 square feet without first having a permit issued by the Mayor and Town Council. A fee in accordance with requirements necessary shall be charged.
- (B) Requirements may include, but are not limited to, bond or insurance securing the total demolition costs; fencing, curtains, or barricades around construction area; monitoring and reporting of any hazardous material; a time frame for completion with monetary penalties for over-run; mutual agreement as to finish and final landscape; and anything else Council deems necessary to ensure and maintain the integrity of the neighborhood and community.
- (C) Permits will be issued for 12 months. If the work described in the permit has not begun within six months from date of issue, the permit shall expire and be void.
- (D) It shall be unlawful for any person to demolish any structure without a permit or permits required by this section.
- (E) The Mayor is authorized to issue a stop work order, pursuant to S.C. Code § 6-29-950(A), requiring work to cease until specific violations of the permit are corrected. Failure to comply with a stop work order of the Mayor is a misdemeanor punishable under the general provisions of the town code.
- (F) The Mayor, with the concurrence of the Town Attorney, may request the issuance of an arrest warrant and/or institute a civil action when appropriate. (1974 Code, § 4-7) (Ord. passed 10-15-2001) Penalty, see § 150.99

§ 150.99 PENALTY.

(A) Any person violating any provision of this chapter for which no specific penalty is prescribed shall be subject to § 10.99 of this code of ordinances.

- (B) For purposes of this section, a **TRAVEL OR CAMPING VEHICLE** shall be defined as a vehicle which is:
 - (1) Built on a single chassis;
 - (2) Four hundred square feet or less measured at the largest horizontal projection;
 - (3) Designed to be self propelled or permanently towable by a light-duty truck; and
- (4) Designed primarily not for use as a permanent dwelling but as temporary living quarters for recreational, camping, travel, or seasonal use.
- (C) It shall be unlawful for any person to use any such travel or camping vehicle except as herein authorized by this section.
- (D) A written complaint specifying facts showing a violation of this section filed by any person shall be investigated by the town's Police Department. Upon determination of the violation has occurred, the town's Police Department shall take appropriate enforcement action authorized by this section.
- (E) The Town Council may submit a request to the Town Attorney for institution of a civil action seeking an injunction prohibiting violation of this section when appropriate. (1974 Code, § 4-4) (Ord. 2010-10, passed 5-10-2010) Penalty, see § 151.99

§ 151.02 ZONING VARIANCE FOR BUSINESSES.

Any commercial or industrial business seeking to locate and do business in any area not already licensed as a business area must make application to the Town Council before any business license will be issued. Code §§ 6-29-310 et seq., and incorporated by referenced in the code of ordinances of the town.
- (B) *Purposes*. The purposes of the Comprehensive Plan are to guide the town in each of the elements of the plan for development in accordance with existing and future needs, and promoting the public health, safety, morals, convenience, order, appearances, prosperity, and general welfare of the community and for all those purposes set forth in the S.C. Code §§ 6-29-310 et seq.
 - (C) Title. This section may be cited as "Whitmire Comprehensive Plan, 1998".
- (D) *Jurisdiction*. The provisions of this section shall apply to all land and improvements within the corporate limits of the town. (Ord. passed 2-8-1999)
