I am disputing traffic ticket #578374775 (Unreasonable Speed) for the following reasons:
 It is nearly impossible to speed on the 1100-1500 blocks of U St. on a Saturday night. I saw other police in their cars that did not pull me over for speeding. The cop Shelby said she had to do 60 mph to catch me which is incorrect since soon as I had pulled off from the light, she put on her siren. Selby said she ran my tag while she was following me. That contradicts her 60 mph statement. Selby only took my licence though she asked for licence, registration, and insurance when she first stopped me. She commented on my youth prior to seeing my license. I have a nice new car, this is either a classic case of racial profiling and/or continuous harassment by Assistant Chief Alfred Durham.
 Obviously, others in the Department know of Assistant Chief Alfred Durham's illicit affair with my wife since she has been questioned by the police and they would not allow my mother or brother serve her divorce papers. One cop tried to intimidate my mother and another illegally frisked my brother. Other dealings with the Metropolitan Police Department have me concerned for my safety and deeply depressed.
 That same week of the ticket, I was granted an absolute divorce (grounds adultery) final order. Assistant Chief Alfred Durham is named as the paramour. He has been brazen throughout this ordeal. I asked Alfred Durham "Did you fuck my wife?" Alfred Durham replied "Yea, I did". Assistant Chief Alfred Durham also appears to have raped my wife based upon a detailed description of events.
 I am willing to testify about this alleged crime that he committed. I want the Metropolitan Police Department in general and Alfred Durham in particular to stop threatening my family and myself. This has been and still is very traumatic for me.
