

BREEDING CONTRACT FOR **HM MY GUY GOT SPARKS**

For \$750 stud fee and the cost of semen collection(See below for fees)

Breeding/Collecting done by Colorado State University in Fort Collins for the 2021 breeding season.

Colorado State University Fees are as follows: \$335 for collect & Ship(FedEx overnight), \$200 for collection and pickup/take home with stallion, and \$125 for collection and A.I. an on-site mare.

Breeder and Mare owner agree to the following conditions:

The stallion fee includes a non-refundable booking fee of \$100 payable with this signed contract. The balance must be paid in full before shipment of semen and/or Mare is released to Mare Owner.

This contract contains a Live Foal Guarantee

A live foal guarantee is described as a newborn foal which stands and nurses without assistance. Should the mare fail to have a live foal, as defined above, the mare owner has the right to return the mare for rebreeding in the succeeding year only. Mare owner must notify breeder within 24 hours and send a veterinarian statement.

Rodeojodie LLC(Jodie Dunhill) MUST be notified 1 week in advance of your intended collection date to insure your shipment. Collection days will be on Monday, Wednesday or Thursday. Mare Owner agrees to pay all associated expenses ie. Board, veterinarian expenses and breeding fees, before the mare and/or semen is released to the Mare Owner.

Mare owner agrees that the Stallion Owner, Rodeojodie LLC(Jodie Dunhill) will not be responsible for any disease, accident, sickness or death to mare or foal. Colorado State University will exercise judgement in supervising and caring for them.

It is further agreed that should the stallion die or become unfit for service prior to settling the mare, or if the mare should die, be sold, or become unfit to breed, this contract shall become null and void. The \$100 non-refundable deposit can apply to a second mare if original mare booked should die or be unable to breed in 2020 or next breeding year.
