COMMITTEE OF 100 MINUTES

Date: October 10, 2019

A motion was made to accept the report and a second was made. Motion was passed.

Community Updated and Announcements:

- <u>The Venue Stephanie Nelson</u>, announced the Habitat Breakfast is on October 22nd, The Chamber of Commerce Gala is October 24th and Fireside For Children is on December 9th. There are a few dates still available for parties through the weekdays. Also, there will be a New Years Eve party at the Venue.
- Loudon County Mayor—Buddy Bradshaw, announced that they are exploring options for the Courthouse Annex and that the Courthouse refurbish will begin the spring of 2020.
- <u>Loudon County Chamber of Commerce Rodney Grugin</u>, announced that the new board members are in place, Chamber Gala is on October 24th at the

Venue, and Ribbon Cuttings on November 12th at Y-12 FCU at Dixie Lee. There will be a Networking Breakfast at the Depot on November 15th.

- <u>Lenoir City Beth Collins</u>, announced that a new hotel is coming to Lenoir City on 321 past Bimbo's, Firestone is building in Town Creek, Little Ceasars is moving into the building next to Gondelier, and Pre-posed buildings in Lenoir City are Lakeway Chiro and Lakeway Dental. ORNL has a new remodel and Spring Place Apartments is re-doing all of their apartments. Ash Trailor park is rezoning and townhomes are going in.
- Run Loco Michelle Lewis, announced that on December 7th is Run Loco with lots of Venders, prizes and Food Trucks, come out and support.

Special Feature:

Rachel Baker, Loudon County Visitors Bureau

Rachel talked about the Economic Impact of Tourism in Loudon County. Loudon County ranks #27 out of 95 counties in Tourism. In 2018 there was \$60.9 Million dollars generated in direct tourism expenditures, 471 jobs generated which produced \$11.8 Million in payroll, \$1.5 Million in local tax revenue and \$3.7 Million in state tax revenue. As a result each household paid \$260.36 less in local county and state taxes. "The Loudon County Visitors Bureau Mission Statement is to attract business and leisure travelers and prospective residents to Loudon County through a research and data driven program of marketing, which will enhance economic vitality for our community through job creation, increased tax revenue and new investments."
