- Neal Denton and John Goddard UT Ag Extension Service:
 - o Hemp production and CDB oil have "a tremendous amount of interest".
 - o A grower cannot get a license if they have a felon.
 - Unlike soy and corn, there is no data about hemp production crops. "We do know It is photosensitive plant and has to be panted at just the right time."
 - One cannot tell the difference between hemp and marijuana which causes a problem with law enforcement. The specimens must be sent off for testing of the THC to tell the difference. Hemp has less than .025 THC whereas marijuana does not.
