**ISO AUDIT:-** Depending on the documents submitted, an ISO audit for the business is conducted wherein the authenticity of the documents are checked. The authority then makes a choice based on the defined procedures.

ISO CERTIFICATION:- Once your audit is successful, a certificate is issued to your company. It is couriered to the business address. ISO 9001 certification renewal has to be done once a year and for the renewal, the authorities conduct a surveillance audit to ensure adherence to all the standards.

Mutually beneficial supplier relationships

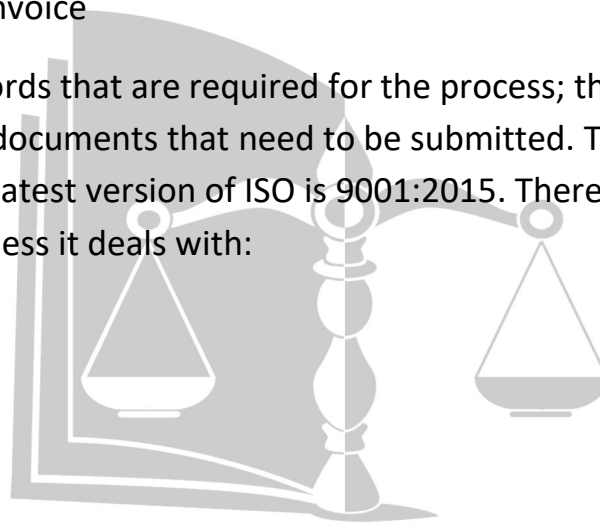
The ISO 14000 certification, on the other hand, deals with the environment such as the one used by waste management firms. A few other ISO certifications are:
