Kaden's Cause

Lisa Bramlage from Kaden's Cause was our speaker today! Lisa has been the executive director for 7 years. Kaden's Cause serves lower income families of children 5 years and younger in all 50 states and since 2019 has assisted with over \$200,000 of funeral expenses for over 300 children. Kaden's Cause provides funeral funding, caskets and urns, headstones, personal memorial gifts and layettes and grief support and additional resources. Lisa is the only person who coordinates everything, but there is a board in Kentucky and Florida. This is an amazing non-profit organization that is continually reaching out to hospitals around the country to provide this specific service. Galisano is one of the hospitals that use this organization. At the fiscal half-year point in 2025, Kaden's Cause will have already helped more families than all of last year. The biggest need they have right now is to get the word out to different people and hospitals about what the organization offers.
