Owner Liability Waiver and Health Certification

The Four Legged Inn General Information and Policies:

The purpose of The Four Legged Inn, Inc. is to provide a safe, fun and stimulating social environment for dogs during the day and a safe, comfortable overnight. To ensure the safety and health of your pet and our other guests we require all guests to comply with the following rules and regulations:

Age: All dogs must be at least 12 weeks of age or older

Sex: All dogs 7 months or older must be spayed or neutered.

Shots: All dogs must have up-to-date vaccinations. Owners must submit written proof of vaccinations. Rabies is required for puppies over 4 months of age.

Health: All dogs must be in good health. Owners will certify their dogs are in good health and have not been ill with communicable condition in the last 30 days. All dogs must be free from any condition which could potentially jeopardize other guests. Dogs that have been ill in the past 30 days will require veterinarian certification of health to be admitted.

Behavior: all dogs must be non-aggressive and not food or toy protective. Owners will certify their dogs have not harmed or shown any aggressive or threatening behavior towards any person or any other dogs.

Application: All dogs must have a complete, up-to-date and approved application on file.

Fees: There is a daily overnight rate and a pass plan. A pass is valid for 12 months from the date of purchase. Admission prices can be found on our website at www.thefourleggedinn.com
