Assumption of Risk & Damage Agreement**

***ACKNOWLEDGMENT OF RISK***

I understand that outdoor recreation activities including kayaking, paddleboarding, canoeing, and Snowshoeing involves inherent risks. These risks include drowning, capsizing, cold water exposure, changing weather conditions, slippery terrain, wildlife encounters, and equipment failure. I voluntarily assume all risks, known and unknown, even those that may result in serious injury or death.

***PARTICIPANT RESPONSIBILITY***

I confirm that I am physically capable of participating and have the skills necessary to safely use the equipment. I agree to wear a life jacket at all times on the water, follow all safety instructions, remain aware of my surroundings, and act responsibly at all times.

***GUIDED VS NON-GUIDED ACTIVITIES***

I understand that unless I am on a guided tour, staff are not acting as guides or instructors. Any suggestions are for general information only, and I am solely responsible for my navigation, decisions, and safety.

***RELEASE OF LIABILITY***

I release and hold harmless Sky Lakes Wilderness Adventures, LLC, its owners, employees, and affiliates from any and all claims for injury, death, or property damage arising from my participation, to the fullest extent allowed by law.

**INDEMNIFICATION (You agree to cover costs if something happens because of you)**

I agree to indemnify and hold harmless Sky Lakes Wilderness Adventures, LLC from any claims, damages, or expenses resulting from my actions, including injury to others or damage to property.

**EQUIPMENT RESPONSIBILITY & DAMAGE POLICY**

I accept full responsibility for all rented equipment. I agree to return equipment in the same condition and understand that I am financially responsible for any lost, stolen, or damaged items.

Lost or sunken equipment may result in additional recovery fees. I understand that conditions may change rapidly and agree to make conservative decisions while on the water.

**CULTURAL & ENVIRONMENTAL RESPONSIBILITY**

I acknowledge that these waterways are culturally significant to the Klamath Tribes and agree to respect all posted areas, avoid restricted zones, and follow Leave No Trace principles.

**GOVERNING LAW**

This agreement shall be governed by the laws of the State of Oregon, and any claims must be filed in Klamath County, Oregon.
