Background

The Dingle Memorial Anthrax Vaccine Justice Act of 2019 (MAVJA) was inspired by the original dutiful diligence and persistence of an Airman of the United States Air Force on behalf of all servicemembers. LtCol Russell E. Dingle passed away in 2005, but his seminal work identifying the illegalities associated with the anthrax vaccine mandate led to the immunization's overdue FDA licensure on Dec 19th, 2005. Record corrections prior to that date are simply the right thing to do, since the earlier order violated 10 USC § 1107.
