7. Adjourn.



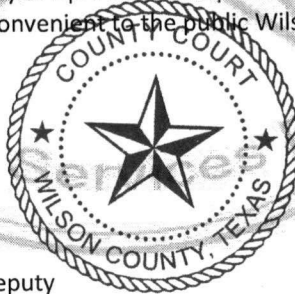
