Monthly Command Report
For July Emergency Response:

- For the month of July, there were a total of **15 fire** calls.
- For the month of July, **Fire** units first responded to Asst. D2 **EMS** on **34** calls
- For the month of July, there were a total of **38 911** EMS calls, **25** transport's and **13** non-transport.
- In addition, there were **5** facility transfers completed.
- For the month of July there were a total of **43** EMS runs.

Average response time, unfortunately there is no real way to track this. There are multiple reporting systems used for Fire and EMS within our department that are separate from each other. I'll be looking into this to get the most accurate number. My thoughts are to contact Dispatch soon for a possible tracking report on this.

Emergency Vehicles:

B-22: Apparatus is being checked daily and is in service. The brake system will soon need to be serviced.

B-21B (New Heavy): Apparatus is being checked daily without major issues to report.

E-22: This unit is not operational due to many issues with it. It has been placed O.O.S.

E-21: Apparatus is being checked daily without any major issues to report. The pull string on the chainsaw located in the Driver 2 compartment failed and needs to be replaced.

T-21: Has been received from Siddon's, in service training was conducted by a training representative from Siddon's with staff members.

M-21 (New Medic Unit): The unit is being checked daily and is in service as the primary 911 MICU at station 1. The unit had four new tires placed. This unit has started to leak oil while parked in the bay. It will need servicing soon. This unit requires an oil change.

M-22: The unit is being checked daily and is in service without any major issues to report, currently positioned at Station 1 as a reserve unit.

M-23: The unit is being checked daily and is in service without any issues to report. The unit is positioned at Station 2 as a 911 MICU. This unit requires an oil change.

Rescue 22: Apparatus is being checked daily and is in service. This unit is still being utilized as a temporary Command. This unit requires an oil change.

MISC:

We are planning to begin ISO survey preparation meetings with our rep starting in September. I highly recommend, due to possible Station condensing and staff reduction we postpone the ISO audit. If the survey is completed while making these changes, it will negatively affect the outcome.

Personnel:

We are currently working on increasing our number of local volunteers.

Administration:

Command staff are in the process of compiling budget items for FY24.
