**Monthly Command Report**  
**For November Emergency Response:**

- For the month of November, there were a total of **29** fire calls.
- For the month of November, **Fire** units first responded to Asst. D2 EMS on **53** calls.
- For the month of November, there were a total of **68 911** EMS calls, **30** transports, **12 refusal** transport, **26** no Pt/DOA/Cancelled calls.

**Emergency Vehicles:**

**B-22:**

Apparatus is currently in service at Station 2 with no reported issues.

**B-21 (New Heavy):**

Apparatus is being checked daily and in service, eventually we're going to have to re-pipe the tank to pump feeder line due to leaks. Currently it is operational.

**( Present time: It's been moved to Station 1 to be under covered parking)**

**E-22-B:**

This unit had the tires replaced with new ones from Billy Bobs per the direction of President Burleson. He advised we have found a buyer. This unit is ready to be sold.

**E-22:**

Apparatus is currently in service. Repairs were made by Siddon's to the foam system and a P.M. was completed. This unit is currently leaking water from the main piston intake. A new Piston intake is needed and was budgeted under Fire equipment. I also believe the tank to pump valve seal/gasket might need to be replaced soon as well.

**T-21:**

This unit is currently in service and fully operational. No issues noted.

**( Present time: It is at Station 2 and kept parked in the bay to protect it, with it being new.)**

**M-21 (New Medic Unit):**

This unit is currently in service at Station 2 with no reported issues. Amaro's Body Shop finalized body work from damaged sustained a few years ago, at no cost to us.

**M-22:**

The unit is O.O.S. service at Station 1, this unit has been leaking coolant and has timing belt issues. Siddons has come by to inspect issues and has ordered parts needed. This unit is the one I believe we will be selling. Equipment and medical supplies have been removed from the unit and is ready to be sold. Siddons still has not contacted me to see if parts are in, to complete repairs.

**M-23:**

The unit is being checked weekly and is our backup Medic unit. Currently it's located at Station 1. **(Present time: I believe it will need new front tires soon.)**

**Rescue 22:**

Apparatus is being checked daily and is in service. This unit is still being utilized as a temporary Command. I believe we should sale this unit. Explanation will be voiced with a contingency plan for replacement.

**MISC:**

We have an abundance of expired medical supplies that's currently being stored upstairs at Station 1.

**Personnel:**

3 full-time personnel submitted their resignation letters in the past month and half. I have been doing my best to fill-in with daily crews, and schedule part-timers for coverage as well. At times I did have to utilize full-time employees for coverage. I have been watching overtime and managing it as best as possible. We have been responding to incidents appropriately and my personal opinion managing the personnel budget well. We have started a new hire process to fill these vacancies. This past Friday myself and the command staff hosted a written and physical test at Station 2. We are going to begin the interview process and background checks within the next two weeks. I believe we will find qualified candidates from the process. About 15 applications were submitted during the initial phase.
