



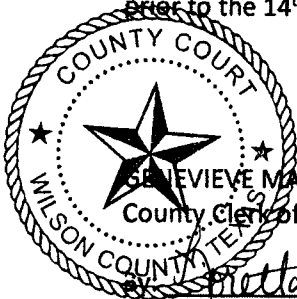

8. Adjourn.


