The following agenda items will be discussed, considered, and action taken as appropriate:

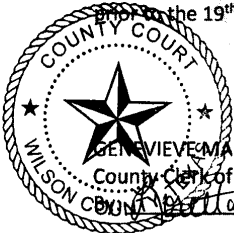
1. Call to Order and Establish Quorum.
