

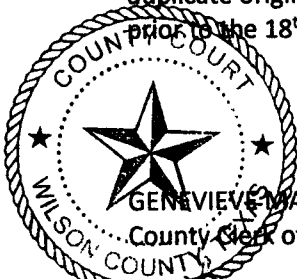
The following agenda items will be reviewed, discussed, and action taken as appropriate:

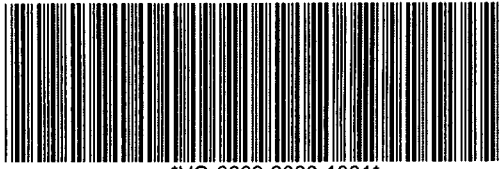

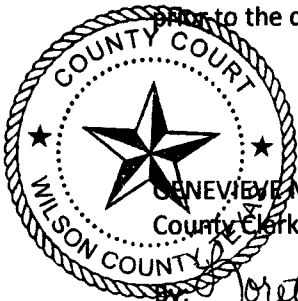

7. Adjourn.




