The owner of dog will pick the puppy at this time or opt for stud fee at this time. If above bitch whelps three (3) or fewer live sellable puppies, the stud fee will be reduced to \$300 for 1 puppy, \$700 for 2 puppies and \$1200 for 3 puppies. If above bitch whelps no live sellable puppies, no breeding fee will be charged. A litter registration application shall be provided to the owner of the bitch by the owner of the dog. The owner of bitch will please provide a copy of the followina: Rabies vaccine • Current eye exam results Brucellosis (STD) test results within 3 weeks of Copy of Registration Papers Pedigree Information Any DNA testing that was completed OFA Hips or PennHip results Dog will be tested for Brucellosis (within 6 months). Additional Brucellosis testing to be paid by owner of female. The owner of the bitch hereby releases from responsibility <u>WIGGLEBUTT LLC</u> and/or <u>Angela & Bill Ogle</u> or its officers from any and all liabilities and/or damage to said bitch while she is in the care of Wigglebutt for breeding. The owner of the Dog hereby releases from responsibility \_\_\_\_\_ Kennels and/ or \_\_\_\_\_ or its officers from any and all liabilities and/or damage to said dog while he is in the care of <u>Wigglebutt</u> for breeding.
