Conditions of Entry

Dogs must have an AKC registration number and be at least one year of age on the day of the trial. Dogs may only run once per test. All entries must be accompanied with a check to be valid. A returned check is not a valid entry. There will be a \$35 fee for a returned check. Entries received by phone, text, or email will not be accepted. Incomplete entries or forms without signature will not be accepted.

WHAT IS FARM DOG?

- This test is a non-competitive pass/fail evaluation of dog's ability to exhibit self-control in a rural farm setting.
 - Open to all dogs at least 9 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL number or dogs enrolled in the AKC Canine Partners Program.
 - Dogs must be on leash at all times unless confined in a crate, kennel, or vehicle.
- Dogs must wear a secure, well fitting, flat collar during the test evaluation.
- Handlers can use verbal cues, hand signals and praise, provided it is not excessive in the opinion of the judges.
 - Dogs may attempt each test element no more than two times.

- Dogs must pass all elements of the test and overall assessment during the same test to qualify.
- Dogs must qualify under two different judges in order to be awarded the FDC suffix title.
- The Judge may discontinue testing if he/she determines the dog is too fearful or under duress to perform the required elements.
- The Judge may request the removal of any dog from the immediate test area at any time, if he/she determines the presence of the dog presents a risk to livestock, other dogs or persons on the farm

Notice To All Exhibitors

- **ALL DOGS RUN AT OWNER'S SOLE RISK**
- All AKC rules regarding sportsmanship and conduct apply.
- This is a rain-or-shine outdoor event. Please plan accordingly. Please bring your own shade, chairs and water.
- Bathrooms are available.
- Dogs must be on lead or crated unless running.
- **A \$25 fine will be assessed for any loose or an exhibitor caught not picking up after their dog.**
- You are responsible for controlling your dog(s) and children.
- Each dog requires an individual entry form for each event in which it is entered.
- Bitches in season and lame dogs will be excused. **Entry fees will be refunded minus a \$5.00 processing fee.**
- Persons exhibiting conduct detrimental to the AKC/any dog(s)/other person(s) will be asked to leave the trial site by the Field Committee, maybe disciplined by the AKC, and **entry fees will not be refunded.**
- **No entry fees will be refunded** if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or
- The event-hosting club, MSWC, or Stoney Run Canine Camp, its agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.
